## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrators and Participants of the Spencer Gifts LLC 401(k) Plan  
Egg Harbor Township, New Jersey

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Spencer Gifts LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)" audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. # SPENCER GIFTS LLC 401(k) PLAN

## NOTES TO FINANCIAL STATEMENTS AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the Spencer Gifts LLC 401(k) Plan (the “Plan”) is for general purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**—The Plan is a defined contribution plan established for the employees of Spencer Gifts LLC (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended, (“ERISA”). Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the “Trustee” or “Principal”) is the current Trustee and record-keeper of the Plan.

**Eligibility**—Full time employees are eligible under the Plan immediately upon hire date. Part-Time/Temporary/Seasonal Employees are excluded from the Plan, unless they reach 1,000 hours of service within a year or 500 hours or more in two consecutive years.

**Contributions**—Each participant’s account is credited with the participant’s contribution. Participants may elect to contribute to their accounts on a pre-tax basis (“pre-tax contributions”) and/or to their Roth accounts on an after-tax basis (“after-tax contributions”) through payroll deductions of 1% to 50% (in the aggregate) of their annual salary (as defined by the Plan), in multiples of 1%, in any combination. Pre-tax contributions and after-tax Roth contributions are subject to limitations imposed by federal laws for qualified retirement plans.

The Plan operates under a safe-harbor provision whereby the Company contributions are provided as follows: 100% contribution on the first 3% of employee deferrals, and 50% contribution on the next 2% resulting in a maximum Company contribution of 4% of compensation. Under the safe-harbor provision, the Plan is not subject to non-discrimination testing.

The Plan will accept participants’ rollover accounts, cash received by participants from a qualified plan within the time prescribed by applicable law.

**Investments**—Upon enrollment in the Plan, a participant may direct employee contributions among available investment funds. A participant may elect to transfer that contribution to any investment fund. Investment elections or contribution rate changes can be changed on any business day and must be made in increments of 1%.

**Participant Accounts**—A separate account is maintained for each participant. Each participant’s account is credited with their contribution, company matching contributions and an allocation of Plan earnings or losses. Earnings or losses are based upon the investment performance of the individual funds in which each participant’s account balance is invested. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Notes Receivable from Participants**—The Plan is subject to the provisions of the ERISA. Participants may borrow up to 50% of their vested account balance up to a maximum of \$50,000. The minimum amount of any loan made to a participant is \$1,000. The loans are secured by the participant’s account and bear interest at rates from 4.25% to 9.5%. Principal and interest are paid ratably through payroll deductions. Maturities range from 2025 to 2039. Generally, loans must be repaid within a five-year period unless used for the purchase of the participant’s principal residence.

**Vesting** — Participants are fully vested in their personal contributions, employer safe harbor contributions, employer discretionary contributions and related account earnings or losses immediately upon enrollment in the Plan.

**Payment of Benefits**— Under the Plan, normal retirement age is 65. On termination of service due to death, disability, retirement or termination of employment, a participant shall have the option to leave the balance in the Plan, receive an annuity payment option as defined by the Plan, or a lump-sum amount equal to the full value of the participant’s account balance. Prior to age 65, in-service withdrawals from the Plan are allowed for unusual hardship and upon attaining the age of 59 1/2.

In accordance with the procedures established by the administrative committee and the terms of the Plan, certain terminated employees may elect to defer their final distribution from the Plan. Upon such election, the amount in such participants’ vested interest in the Plan is entitled to continue to receive investment income and is held by the Trustee until the date of distribution as elected by the participants.

Prior to termination of employment, participants may withdraw amounts from their respective accounts in accordance with the provisions of the Plan.

## 2. SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**Investment Valuation and Income Recognition**—The assets of the Plan are held in trust by Principal as of December 31, 2024 and 2023.

The Plan’s investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 7 and 8 for descriptions of fair value measurements and guaranteed investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest is recorded when earned. Net appreciation includes the Plan’s gains and losses on investments purchased and sold as well as held during the year.

**Use of Estimates**—The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, and liabilities and changes therein; disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Note Receivable from Participants**—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included as administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loss to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan agreement.

**Payment of Benefits**—Benefits are recorded when paid.

**Expenses**— Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

### **3. PLAN TERMINATION**

Although the Company has not expressed any intention to do so, the Company reserves the right to modify, suspend, amend or terminate the Plan in whole or in part at any time subject to the provisions of ERISA. If the Plan is terminated, the amounts credited to the employer contribution accounts of all participants become fully vested.

### **4. TAX STATUS**

The Plan’s administrator adopted a prototype 401(k)/profit sharing non-standardized plan, which received a favorable opinion letter from the Internal Revenue Service on July 20, 2023, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although, the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal or state taxing authorities. The Plan administrator has analyzed the tax positions by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **5. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Principal is the trustee and record-keeper for the Plan. The Plan incurred administrative expenses with Principal for the years ended December 31, 2024 and 2023. Loans to participants are secured by the balances in the respective participant accounts. The Plan also paid asset fees to various mutual fund service providers. The Plan received fees from the mutual fund services providers, which is used to offset administrative and investment advisor expense incurred by the Plan. A portion of the Plan's investments include shares of common collective trusts and a guaranteed investment account that are managed by Principal. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

### **6. INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)**

The Plan management has elected the method of compliance by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan’s management instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Principal, except for comparing such information certified by the trustee with information included in the Plan’s financial statements and supplemental schedule of Form 5500, Schedule H, Part IV, Line 4i-Schedule of Assets (Held at End of Year).

## 7. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 — Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common/Collective Trust:** The Plan invests in the Galliard Stable Return Fund (“SRF”) which is offered through SEI Trust Company, The Plan’s interest in the SRF is valued at the NAV practical expedient of the underlying investments reported by the issuer of the common collective trust at year-end. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from reported NAV. The underlying assets owned by the SRF consist primarily of readily marketable fixed income securities. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that security liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **8. GUARANTEED INVESTMENT CONTRACT**

The Principal Fixed Income Guaranteed Option (“PFIGO”) is a fully benefit-responsive, general-account backed group annuity contract issued by Principal Life Insurance Company (“Principal Life”) to Principal Trust Company as custodian. Contract value reflects contributions plus interest, less withdrawals and administrative expenses. A composite crediting rate, determined semi-annually, is applied uniformly to all contributions within the vintage group of deposit accounts. This rate is based on a weighted average of guaranteed interest rates (“GIR”) across Guaranteed Interest Balances (“GIB”) and is subject to a minimum guaranteed rate, which ranges from 0.15% to 3%, depending on market conditions. For the year ended December 31, 2024, the minimum guaranteed rate was 2.80% and the average rate earned was 4.92%.

Certain events limit the Plan’s ability to transact at contract value with Principal Life. Such events include the following: amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), termination of any record-keeping arrangement, service agreement or other agreement between Principal and the Plan, or termination of the investment contract. No redemption fees, early withdrawal charges, or market value adjustments are charged on participant transfers of assets into or out of the contract. A surrender of the Plan’s interest or initiated transfer in this contract is subject to either a 12-month advance notice or a 5% surrender charge. Notification of the Plan’s intent to terminate its interest may be revoked within 90 days of Principal’s receipt of such notice, after which time, the notice becomes irrevocable. The Plan administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with Plan participants or the issuer are probable of occurring. The balance in the Principal Fixed Income Guaranteed Option contract was \$699,357 at December 31, 2024. There were no amounts held in this contract at 2023.

## **9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment instruments, including mutual funds and common collective trusts. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

The Plan’s exposure to a concentration of credit risk is limited by the opportunity to diversify investments across multiple participant-directed fund elections including active and passively managed funds covering multiple asset classes. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments. The Plan’s investment in Vanguard 500 Index Admiral totaling \$13,372,491 and \$9,530,434 as of December 31, 2024 and 2023, respectively, represented a concentration equal to or greater than 10% of the Plan’s net assets available for benefits.

## **10. SECURE ACT 2.0**

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included the Setting Every Community Up for Retirement Enhancement (“SECURE”) Act 2.0. The SECURE Act 2.0 contains over ninety new retirement provisions, with varying effective dates through 2027. Since the SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Effective January 1, 2024, the Plan administrator adopted several optional provisions, none of which had a material impact on the Plan's 2024 financial statements.

## **11. SUBSEQUENT EVENTS**

In March 2025, all Plan assets invested with SFR were rolled over to the PFIGO. The assets were rolled into PFIGO after the SFR put expired.

The Plan's management evaluated subsequent events through October 9, 2025, the date which the financial statements were available to be issued. Based upon that evaluation, and other than noted above, the Plan's management has determined that no other subsequent events have occurred which would require disclosure in or adjustment to the financial statements.

## **12. RECONCILIATION TO FORM 5500**

No material differences exist between the Form 5500 and the financial statements.
