## **Note 1. Description of the Plan**

### ***General***

The following description of the APLA Health & Wellness 403(b) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by APLA Health & Wellness (Organization) for the benefit of all employees of APLA Health & Wellness, the Global Forum on MSM & HIV, doing business as MPact Global Action for Gay Men's Health and Rights (MPact), and Alliance for Housing and Healing (AHH). Employees who normally work 20 hours or more per week are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the Organization. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Nationwide Trust Company, FSB (Nationwide) serves as the primary custodian of the Plan. Mutual of America Life Insurance Company (MOA) carries an annuity contract held by the Plan and serves as a legacy custodian of the Plan.

### ***Cessation of Participating Employer***

Effective July 1, 2023, the Global Forum on MSM & HIV, doing business as MPact Global Action for Gay Men's Health and Rights (MPact), was removed from the APLA Health & Wellness 403(b) plan as a participating employer and transferred funds out of the Plan.

### ***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Organization make annual pre-tax or Roth contributions of up to the maximum allowed by the Internal Revenue Code. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Organization may make discretionary matching contributions as determined by the Organization's Board of Directors. During the years ended December 31, 2024 and 2023, the Organization made a discretionary matching contribution in an amount equal to each participant's contribution, up to 6 percent of the participant's compensation. Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Investment account options available include various funds. Each participant has the option of directing contributions into any of the investment account options selected by the Organization and may change the allocation daily.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Organization's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Organization's matching contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after 3 years of continuous service. Upon a participant's death or permanent disability while employed by the Organization, or upon retirement or after normal retirement age, the participant becomes 100 percent vested in all account balances plus the earnings thereon.

***Notes Receivable from Participants***

The Plan document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence). Principal and interest is paid ratably through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on prevailing rates as determined by the loan administrator. The Plan allows for participants to have two loans outstanding.

***Payment of Benefits***

Upon termination of service, participants with account balances less than \$1,000 receive an automatic distribution of that balance without consent. Balances greater than \$1,000 but less than or equal to \$5,000 are to be rolled over to an individual retirement account as designated by the administrator, absent an election by the participant for distribution. Participants whose vested benefit exceeds \$5,000 may elect to receive a lump-sum amount equal to the value of his account. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

***Forfeited Accounts***

At December 31, 2024 and 2023, the Plan held no unused forfeited nonvested accounts. During 2024 and 2023, employer contributions were reduced by \$41,537 and \$35,801 from forfeited nonvested accounts, respectively.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Pooled separate accounts are valued at estimated fair value as provided by MOA.

The interest accumulation account, a fully benefit-responsive investment contract, is recorded at contract value, as reported by MOA, which represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. A loan shall be in default if any amount remains unpaid. The balance of any outstanding loan is due within the subsequent calendar quarter after a participant terminates employment. Any default in repayment to the Plan will result in the balance due for the loan being treated as a taxable distribution from the Plan.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Organization or the Plan, at the Organization's discretion.

**Note 3. Certification of Plan Custodians**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide and MOA, qualified institutions, have certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

**Recurring Measurements**

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

## **Note 5. Investment Contract with Insurance Company**

The Plan entered into a fully benefit-responsive investment contract with MOA, who maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The Interest Accumulation Account is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by MOA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

MOA reserves the right to defer the payment of a total withdrawal from the Interest Accumulation Account in connection with the termination of the contract for up to six months following the date of receipt of such request from the plan administrator.

The guaranteed investment contract permits MOA to terminate the agreement under certain circumstances after giving at least 31 days' advance written notification in which to cure any remediable defaults.

## **Note 6. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan paid direct expenses to Nationwide that totaled \$30,468 and \$133,471 in 2024 and 2023, respectively, and direct expenses to MOA that totaled \$47 and \$14 in 2024 and 2023, respectively. Direct expenses paid to IRON for investment management services totaled \$0 and \$17,863 in 2024 and 2023, respectively.

## **Note 7. Plan Termination**

Although it has not expressed an intention to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

## **Note 8. Tax Status**

The Plan operates under a volume submitter agreement in connection with a volume submitter plan and custodial document sponsored by Nationwide Financial Services, Inc. This volume submitter plan document has obtained an advisory letter from the IRS stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
