- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Clifford Chance US LLP Associates Tax-Deferred Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General: The Plan is a participant-directed defined contribution plan established by Clifford Chance US LLP (the “Firm”) to supplement the income of certain employees of the Firm upon retirement. The Plan became effective January 1, 1989. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, (“ERISA”).

The Plan’s trustee and recordkeeper is Fidelity Management Trust Company.

Eligibility: All persons employed by the Firm as associate attorneys, project attorneys and other staff (except for nonresident aliens, staff attorneys and temporary employees) are eligible to participate in the Plan (“Eligible Employees”). Each Eligible Employee becomes eligible to participate in the Plan on the first day of the calendar month following the month in which the Employee commences employment with the Firm, or, if later, attains age twenty-one. Once a participant becomes a partner, his or her account balance is transferred to the Clifford Chance US LLP Tax-Deferred Savings and Profit-Sharing Plan I (the “Profit-Sharing Plan I”) or the Clifford Chance US LLP Tax-Deferred Savings and Profit-Sharing Plan II (the “Profit-Sharing Plan II”).

Contributions: Participants may, at their discretion, contribute a portion of their annual pre-tax or after-tax compensation, each pay period, in 1% increments, subject to limitations (\$23,000 for calendar year 2024, under the Internal Revenue Code of 1986, as amended (the “Code”). Participants age 50 or over may be eligible to make additional contributions of up to \$7,500 for calendar year 2024. Participants may also contribute amounts representing distributions from other qualified plans.

Participant Accounts: Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contribution and Plan earnings and is charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments: Participants direct the investment of their contributions into various investment options offered by the Plan. As of December 31, 2024 and 2023, the Plan offers various mutual funds and a fully benefit-responsive synthetic guaranteed investment contract (the “Synthetic GIC”) issued by Prudential Insurance Company of America (“Prudential”; “Issuer”).

Payment of Benefits: On termination of service, a participant may generally elect to receive either a lump-sum amount equal to the value of the participant’s account or roll the balance over into an individual retirement account or qualified plan of another employer. If the value of a participant’s vested account balance exceeds \$1,000 and the participant does not elect to receive a distribution, his or her account balance will remain in the Plan and the vested balance will be distributed to the participant in a lump-sum distribution at the time of election. Beginning at age 59½ participants may make qualified withdrawals from their accounts. Participants may also make withdrawals in the case of financial hardship.

Death and Disability Benefits: If a participant dies prior to his or her retirement date, his or her account balance shall be paid to the participant's beneficiary in one-lump sum payment in cash no later than the second anniversary of the participant's date of death.

If a participant becomes totally disabled prior to his or her retirement date or termination of employment, the participant's account balance may be distributed as though the participant had retired.

Vesting: Participants are immediately vested in their contribution plus actual earnings thereon.

Notes Receivable from Participants: Subject to the Plan's provisions and the requirements contained in ERISA and the Code, a participant may apply for a loan from the Plan not to exceed the lesser of \$50,000 or 50% of the participant's account balance, at an annual interest rate as determined by the Plan, which approximates the prime rate. The loan repayment is generally made through payroll deductions over the term of the loan (generally not exceeding a period of five years).

Revenue Sharing Agreement: The Plan uses Fidelity Management Trust Company ("Fidelity"), to provide recordkeeping and administrative services for the Plan for the period ending December 31, 2024. All compensation to Fidelity for these services are paid by the participant. The fee is \$87 per participant and is charged quarterly. The amounts remitted by Fidelity are netted against other income on the statement of changes in net assets available for benefits, which were \$9,385 for the year ending December 31, 2024.

These amounts are placed in an unallocated account and are used to pay reasonable and proper Plan expenses per ERISA guidelines or are allocated to Plan participants. If the reverse is true, the Firm will remit the difference to the recordkeeper.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risk and Uncertainties: The Plan holds various investments. Investments are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value, other than the fully benefit-responsive synthetic guaranteed investment contract, which is reported at contract value. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses: The Plan pays for loan processing fees and other miscellaneous expenses. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments. All other expenses relating to the Plan are paid by the Firm.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan document.

NOTE 3 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs.

The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive synthetic guaranteed investment contract with Prudential. Under the synthetic investment contract, the Plan holds units of the Prudential Core Conservative Intermediate Bond Collective Trust ("Collective Trust") issued by Prudential Trust Company and participates in a wrapper contract issued by Prudential. The wrapper contract provides a minimum guaranteed rate of return on the Plan's investment in the Collective Trust and provides that all payments for Plan participant transactions will be executed at contract value. The interest crediting rate is updated quarterly based upon contract provisions, and it may not be less than 0%. Prudential's guarantees under the wrapper contract are backed by the net assets of its general account. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the Issuer or otherwise.

The Plan's investment contract specifies certain conditions under which distributions from the contract could be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Firm, and certain other Firm-initiated events that result in distributions exceeding a set amount. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 6 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. These and any direct expenses paid for by the Plan are considered party-in-interest transactions. Certain Plan investments as of December 31, 2024 were comprised of mutual funds managed by Fidelity Investments, an affiliate of Fidelity Management Trust Company, and therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

Certain administrative functions are performed by employees of the Firm (who may also be participants in the Plan) at no cost to the Plan.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

NOTE 8 - FEDERAL INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Firm by a letter dated November 3, 2015, that the Plan and related trust were designed in accordance with the applicable sections of the Code. Although the Plan has been amended from the original document since receipt of the above letter, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 9 - PLAN TRANSFERS

Along with the Plan, the Firm also sponsors the Profit-Sharing Plan I and the Profit-Sharing Plan II.

Upon becoming a Partner in the Firm, the Associate's account balance may be transferred out of the Plan to the Profit-Sharing Plan I or Profit-Sharing Plan II.

Upon becoming an Associate in the Firm, the Staff's account balance may be transferred into the Plan from the Profit-Sharing Plan I or Profit-Sharing Plan II.

For the year ended December 31, 2024, plan transfers to the Profit-Sharing Plan I were \$48,782 and plan transfers from the Profit-Sharing Plan I were \$744. There were no transfers to or from the Profit-Sharing Plan II during 2024.

NOTE 10 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 9, 2025, which is the date the financial statements were available to be issued.
