## INDEPENDENT AUDITORS' REPORT

**To the Officers and Directors of  
Siskin Hospital for Physical Rehabilitation  
Retirement Savings Plan**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Siskin Hospital for Physical Rehabilitation Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Siskin Hospital for Physical Rehabilitation Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Siskin Hospital for Physical Rehabilitation Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of a Matter - Basis of Accounting**

We draw attention to Note 2 to the financial statements, which describe the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting as described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Siskin Hospital for Physical Rehabilitation Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**(1) DESCRIPTION OF PLAN**

The following description of the Siskin Hospital for Physical Rehabilitation Retirement Savings Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of Siskin Hospital for Physical Rehabilitation (the Hospital). Employees may make elective deferrals upon employment. After one year of service and attainment of age 21 participants may be eligible for employer matching contributions depending on hours worked. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

The Hospital makes discretionary contributions of eligible participant's compensation. For the year ended December 31, 2024, the Hospital matched 50% of employee salary reduction contributions up to 10% of participant's compensation. Contributions are subject to certain limitations. Participants may also contribute amounts from other 403(b) plans, i.e., rollovers, without the benefit of Hospital matching contributions.

**Participant accounts**

Each participant's account is credited with the participant's contribution and allocation of the Hospital's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Hospital contributions. The benefits to which a participant is entitled are the benefits that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their employee contribution account plus actual earnings thereon. Vesting in the employer contribution account is based on years of continuous service. Participants vest in 20% of their employer contribution account beginning in year two and each year thereafter until 100% vested after six years of credited service.

**Payment of benefits**

Upon termination, retirement, disability, or death, a participant may elect to receive a lump sum amount equal to the value of the participant's account if consented to by the plan administrator, or an annuity payout.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the vested value of the account or \$50,000. Loan terms range from 1-5 years, except for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the rate of 4.5% - 9.5% based upon prevailing interest rates. Principal and interest is paid ratably directly by the participants.

**Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,928 and \$49,760, respectively. These accounts will be used to reduce future employer matching contributions. In 2024, employer contributions were not reduced from forfeited nonvested accounts.

**(1) DESCRIPTION OF PLAN (continued)**

**Policy loans**

Participants may borrow amounts directly from the plan custodian. Policy loans may be requested by a participant, using their account balance as collateral for the policy loan. A policy loan is not withdrawn from the participant's balance and is maintained in the loan collateral and loan escrow account. A participant may apply for a policy loan to be made from his or her vested account balance in the Plan not to exceed the lesser of (i) \$50,000 or (ii) 50% of the participant's vested account balance in the Plan. Policy loans may be further limited by the funding vehicles.

When a policy loan goes in default, but cannot be distributed because no distributable event has occurred, the participant receives a 1099R for the outstanding principal and interest at time of default. When this happens, the loan collateral (collateral and escrow accounts) must remain in the participant account as part of the plan assets. See Note 8 for reconciliation of the collateral and escrow accounts to the active policy loans reported on the statements of net assets available for benefits – modified cash basis.

**Administrative expenses**

Personnel of the Plan Sponsor perform various administrative services for the Plan, including maintenance of participant records. The payroll and related overhead costs associated with these services are not included as Plan expenses. Participant transaction fees are charged to the Plan.

**Plan termination**

Although it has not expressed any intention to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of accounting**

The financial statements of the Plan are prepared on the modified cash basis as allowed by the Internal Revenue Service and Department of Labor. This basis differs from accounting principles generally accepted in the United States of America primarily because the Plan has not recognized any receivables or liabilities and their related effects on earnings.

**Use of estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

**Investment valuation and income recognition (continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits**

Benefits are recorded when paid.

**(3) CERTIFIED INVESTMENTS AND INVESTMENT INCOME**

During the plan year ended December 31, 2024, the plan changed third-party administrator and trustee from Corebridge (formerly VALIC) to Empower on December 11, 2024. Certain contract assets and policy loans remained with Corebridge as of December 31, 2024.

The Plan has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower and Corebridge, respectively have certified that the following information, as well as the investment information in the notes to the financial statements and information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024 and 2023, are complete and accurate.

**(5) FAIR VALUE**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits – modified cash basis. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 assets are valued using quoted prices in active markets for identical investments. Level 2 assets are valued using inputs other than quoted prices. Level 2 inputs are observable, either directly or indirectly for the asset or liability through correlation with market data at the measurement date and for the duration of the instrument's anticipated life. Level 3 inputs are unobservable for the investment, indicating that the inputs reflect the entity's own assumption used in pricing an investment based on the best information available. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

The Plan uses the following methods and assumptions in estimating the fair values of the Plan's financial instruments:

**Mutual Funds**

The fair value of mutual funds is based on quoted net asset values (NAV) of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers between levels.

**(6) INVESTMENT CONTRACTS WITH INSURANCE COMPANY**

The Plan has three fully benefit-responsive investment contracts with Corebridge (formerly VALIC). Corebridge maintains the Fixed Account Plus, Fixed Interest Option and Short-Term Fixed Account in its general account. During the year ended December 31, 2024, the Fixed Interest Option was transferred to Empower. All accounts are credited with interest rates set by Corebridge and charged for participant withdrawals and administrative expenses. Corebridge is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Corebridge bears the investment risk for the fixed accounts in the Plan. Funds may be transferred between fixed and variable account options without a charge.

Because the investment contracts are fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. The investment contracts are presented on the face of the statements of net assets available for benefits – modified cash basis at contract value. Contract value, as reported to the Plan by Corebridge, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$7,608,783 and \$8,549,256, respectively. The crediting interest rate is based on a formula outlined by Corebridge in the fund prospectus, but it may not be less than a guaranteed minimum rate dependent upon the date the participant established the account. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Corebridge. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

**(7) PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by Empower and Corebridge (formerly VALIC), the custodians of the Plan for the year ended December 31, 2024. Therefore, these transactions qualify as party-in-interest transactions. Fees of \$107,292 incurred and paid for investment management services are reported on the statement of changes in net assets available for benefits – modified cash basis. The Plan also permits notes receivable from participants. Therefore, transactions pertaining to these investments qualify as party-in-interest transactions. Certain administrative expenses paid by the Plan Sponsor qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**(9) INCOME TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**(10) RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits – modified cash basis.

**(11) SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued.
