Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rule and Regulations for Reporting and Disclosure under ERISA.

NOTE A--DESCRIPTION OF PLAN

The following description of the Payroc WorldAccess, LLC 401(k) Plan (the "Plan") provides only general information. Users of the financial statements should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Payroc Intermediate Holdings, LLC, Payroc, LLC, NXGEN A Transaction Company, Inc. and First Financial Merchant Services, LLC. The Plan was originally established as the Payroc Intermediate Holdings, LLC 401(k) Plan on January 1, 2020. Effective April 1, 2021, the Plan was legally renamed Payroc WorldAccess, LLC 401(k) Plan as the name of the Plan. The Plan was most recently amended in August 2024 (see Note I). The Plan provides for contributions to be made under salary deferral agreements pursuant to Section 401(k) of the Internal Revenue Code (the "Code"). Effective January 1, 2023, a full-time employee will become eligible to participate in the Plan for all contribution types upon satisfaction of three months of employment and having attained the age of 21 (see Note I).

The Plan is subject to the provisions of the Employee Retirement Income and Security Act of 1974 ("ERISA").

The Plan Administrator and Plan Trustees are responsible for oversight of the Plan, determining the appropriateness of investment offerings, and monitoring investment performance.

Contributions

Eligible participants may elect to contribute annual pre-tax or Roth contributions to the Plan by means of a salary deferral agreement. Each year, participants may contribute from 1 percent to 90 percent of pre-tax annual compensation as elective deferrals or Roth elective deferrals. Contributions are subject to limitations as provided in the Code and as described in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover) in accordance with the Plan provisions.

The Plan Sponsor will make a safe harbor matching contribution equal to 100% of salary deferrals that do not exceed 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation.

Salary deferral contributions and safe harbor matching contributions are funded proximate to the withholding date. All contributions invested are directed by the participant in various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, if any, and Company safe harbor matching contributions, if any, as well as allocations of (a) Plan earnings or losses, (b) forfeitures of terminated participants' non-vested accounts, and (c) charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant account balances or compensation, as defined in the Plan agreement.

Participant Accounts-continued

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, participants may elect the way in which contributions are invested in a variety of investment choices within the Plan as more fully described in the Plan's literature. The investment elections will apply to both participant and employer contributions. Participants may change their investment options at any time. During any period in which there is no participant direction on file with the Custodian as to the investment of a participant's account, 100 percent of that participant's account will be invested in the investment option designated from time to time by the Custodian as the default investment. The Plan currently offers various shares of mutual funds and a stable value trust as investment options for participants.

Vesting

Participants are immediately vested in their voluntary contributions and the Company's safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions, if any, plus actual earnings thereon are based on years of credited service as presented below. A participant is 100% vested after four years of credited service. Participants who attain the normal retirement age of 65, or who terminate employment due to death or disability become 100% vested in their account balances.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum of 50 percent of their account balance, not to exceed \$50,000. Participants may only have one outstanding loan at any given time. Loan terms may not exceed five years. However, if the loan is for the purchase of a primary residence, the Plan Administrator may permit a longer repayment term. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined upon initiation of the loan. The interest rates on loans outstanding range from 4.25 percent to 9.50 percent. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of employment due to death, disability, retirement or Plan termination, a participant is entitled to 100 percent of their account balance in a lump-sum cash distribution or as a direct rollover to an individual retirement account ("IRA") or to another employer's tax qualified plan.

Payment of Benefits-continued

For termination of employment for other reasons, a participant is entitled to a distribution of 100 percent of the participant's contributions and the vested portion of the Company's contributions based upon the Plan's vesting provisions.

If a participant's vested account balance is less than \$5,000, the Plan can distribute the entire vested account balance. If the participant fails to make a distribution election and the vested account balance exceeds \$1,000, Roth elective deferrals will be automatically rolled over to a Roth IRA and pre-tax deferrals will be automatically rolled into a traditional IRA. Any amounts less than \$1,000 will be distributed in a lump sum. All distributions less than \$5,000 will be made as soon as administratively feasible.

If a participant's vested account balance is greater than \$5,000, a distribution will be made as soon as administratively feasible following the date the Plan Administrator receives a written request for distribution. Distributions in excess of \$5,000 may be paid in either a lump sum, direct rollover, partial withdrawal or defer receiving payments until age 70 ½.

In-service and hardship withdrawals, subject to certain restrictions, are also permitted.

Forfeited Accounts

Forfeited non-vested accounts may be made available to reinstate previously forfeited account balances of participants, to reduce employer contributions (with the exception to QNEC contributions) or pay any administrative expenses. Forfeited account balances as of December 31, 2024 and 2023 were \$23,411 and \$12,682, respectively. During the years ending December 31, 2024 and 2023, \$ - and \$6,271 of forfeited non-vested accounts were used to offset employer contributions, respectively.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income

The Plan's investments in shares of registered investment companies and stable value collective investment trust are reported at fair value. Fully benefit-responsive investment contracts, when present, are reported at contract value. The Plan does not hold any fully benefit-responsive contracts at December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's stable value collective investment trust is valued at the net asset value used as a practical expedient to estimate fair value. The Plan's Administrator and Trustees determine the Plan's valuation policies utilizing information provided by investment advisers and the Custodian. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends, as applicable, are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid out of Plan assets unless paid by the Company (see Note E). Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments and notes receivable from participants are paid by the individual participant accounts and included in administrative expenses. Investment-related expenses are included in net appreciation of the fair value of investments.

Subsequent Events

The Plan Administrator has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE C--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Should an investment be re-characterized from one level to another level, Plan management would state the basis for the change. Under such circumstances the Plan would report the transfers in and transfers out at the beginning of the Plan quarter when the change occurs.

The following is a description of the valuation methodologies used for Plan assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Registered investment companies are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The stable value collective investment trust, that is composed primarily of fully benefit-responsive investment contracts, is valued at the NAV of units of the collective trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities' liquidations will be carried out in an orderly business manner.

NOTE E--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and a stable value collective investment trust managed by the Custodian and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for these investment management services are included in net appreciation of fair value of investments on the accompanying statement of changes in net assets.

The Custodian provides certain administrative services to the Plan pursuant to a service agreement between the Plan and the Custodian. The Custodian receives revenue from the Plan for performance of these services. This revenue is also used to offset certain amounts owed to the financial advisors, authorized representatives and other third-party administrators for the services they provide the Plan.

Certain employees of the Company provide administrative services for the Plan and the Company is not reimbursed for their services.

NOTE F--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE G--TAX STATUS

On October 6, 2020, the Internal Revenue Service ("IRS") stated that the prototype adopted by the Plan, as then designed, qualifies under the Code section 401(a). The Plan has not received a determination letter specific to the Plan itself and has been amended since receiving the determination letter; however, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability, if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits for any tax periods in progress.

NOTE H--RISKS AND UNCERTAINTIES

The Plan's assets are invested directly and indirectly in various investment securities which are purchased or managed by the Custodian. These investments are exposed to various risks such as interest rate, market, and credit risks. The Plan's assets are subject to the changes in the value of its underlying investments, including the potential for bankruptcy of one or more of the companies in which they are invested.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

The participants who have borrowed from the Plan are all employees of the participating companies and their ability to repay the loans could be affected by economic conditions in the industry in general and economic conditions of the companies and areas they operate from.

NOTE I--PLAN AMENDMENTS

Effective January 1, 2023, the Plan was amended and restated to include required regulatory changes. In addition, the Plan's eligibility requirements were changed from gaining eligibility to participate in the Plan after six months of service to three months of service.

Effective May 8, 2023, the Plan was amended to allow for recognition of service in the Plan for four additional companies. The following companies were included in the amendment: Beanstalk Payment Technologies, FinTech Solution, ACHeck21 and Atlantic Merchant Services.

Effective August 1, 2024, the Plan was amended to allow for recognition of service in the Plan for one additional company. The following company was included in the amendment: i3 Verticals Management Services, Inc.

SUPPLEMENTARY INFORMATION
