Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audit of the financial statements of Fernando L. Sumaza & Co., Inc. and Affiliates' 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements. The financial statements of the Plan for the year ended December 31, 2023, were audited by other auditors whose report, dated January 17, 2025, expressed an unmodified opinion on those statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Fernando L. Sumaza & Co., Inc. and Affiliates 401(k) Retirement Plan in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. 1) Plan description

The following description of Fernando L. Sumaza & Co., Inc. and Affiliates 401(k) Retirement Plan (the "Plan"), provides only general information. Participants should refer to the Plan Document for a complete description of the Plan's provisions.

- A) General – The Plan was established on January 1, 2002. The Plan is a defined contribution Plan with cash or deferred profit sharing, which provides retirement benefits to participating employees of Fernando L. Sumaza & Co., Inc. (the "Employer") and its subsidiaries. The Plan covers all full-time employees who are twenty-one (21) years or older. Participation in the Plan will begin via automatic enrollment for eligible employees.

The Fiduciary Committee (the "Administrator") administers the Plan. The Plan qualifies under section 1081.01 of the Puerto Rico Internal Revenue Code (the "Code") and is subject to the provisions of the Employee Income Security Act of 1974 ("ERISA"). Empower Retirement, LLC ("Empower") is the custodian of the Plan and Oriental Bank & Trust, the trustee.

B) Contributions – The Plan provides for contributions to be made by the Employer and by participants as follows:

i) Employee pre-tax contributions – Pre-tax contributions are limited to \$15,000. In addition, participants who are age 50 or older at the end of a calendar year may make additional pre-tax contributions (catch-up contributions) of up to \$1,500 per calendar year.

ii) Employee after-tax contributions – Participants may make voluntary after-tax contributions to the Plan up to 100% of their compensation.

iii) Rollover contributions – Rollover contributions are permitted and can be made to the Plan from a Puerto Rico qualified Plan by any eligible employee.

iv) Employer's profit-sharing contributions – The Employer may make profit-sharing contributions to the Plan at the Employer's discretion. Employer matching and profit-sharing contributions may not exceed the maximum amount deductible from the Employer's income for that plan year under section 1081.01 of the Code.

v) Employer contributions – The Employer may make matching contributions equal to a discretionary percentage, to be determined by the Employer, of the participant's tax-deferred contributions. For the year ended December 31, 2024, the Employer made no matching contributions. Total annual contributions made by the Employer and participants are limited to the lesser of \$66,000 or the total compensation paid by the Employer to the participant during the Plan year, as provided in the Code, Section 1081.01 (a)(11)(B)(i).

- B) Investment options – The participants' contributions are allocated to the various investment options offered by the Plan as directed by participants.

C)

D) Participant accounts – Individual accounts are maintained for each of the Plan's participants to reflect participant and Employer contributions as well as the participants' share of the Plan's income and any related expenses. Allocations are based on the proportion that each participant's account balance bears to the total of all participant account balances. The benefit to which a participant is entitled is what can be provided from the participant's vested accounts.

1) Plan description - continued

E) Vesting – Participants are vested immediately in their voluntary contributions, plus actual earnings thereon. Vesting in the Employer’s contributions portion plus earnings thereon is based on years of continuous service, as follows:

Years of Service	Vesting Percentage
Less than one (1) year to one (1) year	0%
Two (2) years	20%
Three (3) years	40%
Four (4) years	60%
Five (5) years	80%
Six (6) or more years	100%

F) Payment of benefits – The distribution of benefits to which a participant or beneficiary may become entitled in case of retirement, disability, or termination of employment shall be distributed under whichever of the following methods the participant or beneficiary shall elect:

- i) One lump sum payment;
- ii) Installment payments over a fixed period.

G) Hardship withdrawals – A participant may withdraw all or any portion of the amount allocated to his elective deferral contributions account (including catch-up contributions), excluding earnings, in case of financial hardship.

H) Forfeited accounts – These amounts are used to pay for Plan expenses and any remaining part to reduce Employer matching or profit-sharing contributions. As of December 31, 2024, and 2023, there were \$1,826 and \$1,800 invested in forfeited accounts.

I) Notes receivable from participants – Under the terms of the Plan, participants may borrow up to the lesser of \$50,000 or 50% of the eligible vested account balance, with a minimum loan amount of \$1,000, and treated as a transfer to (from) the investment fund from (to) the participant account. The notes are payable over a period not to exceed 5 years, or 10 years if used for the purchase of a residence. The note is secured by the balance in the participant’s account. Principal and interest are paid ratably through payroll deductions.

2) Summary of significant accounting policies

The most significant accounting policies followed by the Plan are summarized below:

A) Basis of accounting – The accompanying financial statements are prepared on the accrual basis of accounting.

B) Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C) Investment valuation and income recognition – Investment in mutual funds is reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

2) Summary of significant accounting policies - continued

The net appreciation (depreciation) in fair value of investments, including realized gains or losses and net change in unrealized gains or losses, is reflected in the statement of changes in net assets available for benefits. Realized gains or losses on the disposal of investments are determined by specific identification and recognized on a trade date basis. Purchases and sales are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date.

D) Notes receivable from participants – Are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. As of December 31, 2024, the interest rate on outstanding loans ranges from 9.5% to 9.7568%.

E) Contributions – Participant contributions are recorded in the Plan year in which the Employer makes the payroll deductions.

F) Payments of benefits – Benefit payments to participants are recorded when paid.

G) Administrative expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that the Employer pays are excluded from these financial statements. Expenses that are paid by the Plan are recorded when incurred. Fees related to the administration of the notes receivable from participants are charged directly to the participant's account and are included as administrative expenses. Investment-related expenses are included in the net appreciation (depreciation) of investments.

3) Information certified by the custodians

The custodian and recordkeeper of the Plan is Empower Trust Company LLC.

The Plan's asset information as of December 31, 2024, and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, was prepared by, or derived from, information provided by the Custodians to the plan administrator.

The plan administrator has obtained certifications from custodians that the information provided to the plan administrator by the custodians related to the Plan's assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and supplemental schedules, related to the following assets:

4) Fair value measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to determine fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The valuation techniques are based upon observable or unobservable inputs. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan's market assumptions.

These two types of inputs create the following fair value hierarchy:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of assets or liabilities within the hierarchy is based on the lowest significant input to the measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used as of December 31, 2024, and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended and registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 within the fair value hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, using different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The carrying amounts of investments and notes receivable from participants approximate their fair values because of the relatively short-term maturities of these financial instruments.

The collective trust fund is valued using the NAV, provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, less its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in a market that is not active. Since the collective trust fund is valued using NAV, it is not categorized within the fair value hierarchy.

5) Fixed annuities

The Plan entered a Group Fixed Annuity Contract with Empower through an EI Fixed-Account-Series Class I, a general account product of Empower that meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because it represents the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The fixed annuity contract is a fully benefit-responsive investment contract that is reported at contract value. The contract value, as reported to the Plan by Empower, represents (a) contributions made under the contract plus earnings, less (b) the sum of any amount distributed and administrative fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Based on the Empower excessive trading policy, participant transfers may be restricted for up to 30 days if there is excessive trading. Transactions are processed as soon as practicable after resolution of closed or disrupted financial exchanges or markets.

The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long-term new portfolio, compared to the minimum interest crediting rate stated in the contract and prevailing market conditions. The interest credit rate is reset quarterly. There is no guaranteed interest rate under this contract; however, such a rate will never be less than 0%. The actual average yield earned by the Plan on December 31, 2024, was 1.41%.

The Plan's ability to receive due amounts is dependent on Empower's ability to meet its financial obligations. Empower's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the Plan's ability to transact at contract value with Empower. Such events include (1) a complete or partial Plan termination or merger with another plan, (2) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures) that cause a significant withdrawal from the Plan, or (3) premature termination of the contract, among others. The Administrator believes no events are probable to occur that might limit the Plan's ability to transact at contract value with Empower or the participants.

Either the Plan or Empower may terminate the Group Fixed Annuity Contract (other than Plan termination), with advance written notice to the other party. The contract termination date shall be the seventy-fifth (75th) calendar day, or the next Business Day, after the date written notice is received in Empower's administrative offices, unless, before the contract termination date, the Plan and Empower agree to an alternate contract termination date. The Group Fixed Annuity Contract does not provide for specific events that would allow Empower to terminate the contract with the Plan and settle at an amount different from the contract value.

Upon termination of the group annuity contract, the Plan may choose one of the following options:

- Receive the payout of the fund in a lump sum with a market value adjustment.
- Receive the payout of the fund in a lump sum at book value. If this option is selected, Empower may defer payment to a date either twelve (12) or thirty-six (36) months after the contract termination date, depending on the conditions outlined in the contract.
- Receive the payout of the fund in twenty (20) quarterly installments.
- Mutually agree in writing to any other payout option allowable under applicable law.

7) Tax status

The Plan is intended to be a tax-qualified arrangement that complies with the provisions of ERISA, as amended, and with the Code as amended. The latest determination letter from the Puerto Rico Treasury Department, dated April 12, 2016, has an effective date of January 1, 2011, and covers amendments up to January 1, 2020. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Code.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan Administrator evaluated the tax positions taken by the Plan and concluded that, as of December 31, 2024, and 2023, the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that would require adjustments or disclosures to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements.

8) Risk and uncertainties

The Plan's investments are exposed to various risks, such as interest rates, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments is at least reasonably possible, that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

9) Party-in-interest transactions

Employer and Empower are parties-in-interest as defined by ERISA. There was no prohibited party of interest transactions during the year ended December 31, 2024.
