### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

## Note 1. Description of the Plan

### **General**

The following description of Vutex, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Vutex, Inc. (Company) covering all eligible employees, as defined by the plan document. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Life Insurance Company (Principal) serves as the custodian.

### **Contributions**

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of their eligible compensation not to exceed the limits as determined by the Internal Revenue Code (IRC). Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan Sponsor may contribute a discretionary matching contribution and a discretionary nonelective contribution, as determined on an annual basis. The discretionary matching contribution for the year ended December 31, 2024 is not to exceed 3% of an employee's eligible compensation.

### **Participant Investment Account Options**

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change allocations daily.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and plan earnings and charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

### **Vesting**

Participants are immediately vested in all contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions portion of their accounts, plus earnings thereon, is based on years of continuous service. A participant is 100% vested after five years of credit service based on the following vesting schedule:

1 year	20%
2 years	40%
3 years	60%
4 years	80%
5 years	100%

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at the prime rate, as defined, and must be repaid in level payments through payroll deductions over not more than a five-year period, except for the purchase of a principal residence, which may be repaid over a reasonable period of time that may be longer than five years. Loans current outstanding are accruing interest at annual rates from 3.25% to 8.50%.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive a lump-sum amount equal to the value of their vested account balance or may receive partial withdrawals or installments, but only with respect to the minimum required distributions, over a period of not more than the assumed life expectancy. If a participant terminates their employment for any of the above reasons and their vested account balance is less than \$5,000, it will be automatically distributed to them.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. These amounts will be used to offset future employer contributions or pay administrative expenses. Administrative expenses and employer contributions paid by forfeited nonvested accounts were approximately \$16,000 in the year ended December 31, 2024.

**Note 2. Summary of Accounting Policies**

***Basis of Accounting***

The financial statements are prepared using the accrual method of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan's interests in the common collective trusts and pooled separate accounts are valued at NAV of the units of the funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

### **Note 3. Certification of Plan Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment and notes receivable from participants information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### **Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are shares of mutual funds managed by Principal. Principal is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Company directly pays any other fees related to the Plan's operations.

### **Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full-term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023. The Plan had no liabilities valued on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a recurring basis.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. The Plan's pooled separate accounts and collective trust investments are classified within Level 1 of the fair value hierarchy based on unadjusted quoted unit prices provided by Principal Life Insurance Company. These units prices represent the NAV of units held by the Plan and are based on transactions in an active market for identical units within the fund. Because these prices are readily available and reflect actual market activity without adjustment, the investment is classified as Level 1 in the fair value hierarchy. The valuation technique for these investments relies on observable inputs consisting of published unit prices, which are updated daily and are accessible to plan participants and sponsors. No significant judgment or estimation is required in determining the fair value of these investments, as the quoted prices are directly applied to the quantity of units held.

If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows, and these securities are classified within Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There were no investments classified as Level 2 or Level 3 at December 31, 2024 and 2023.

## **Note 6. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer's contributions.

## **Note 7. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Loren D. Stark Company. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the participant's account balances and the amounts reported in the accompanying statements of net assets available for benefits.

## **Note 9. Subsequent Events**

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.
