We have performed an audit of the financial statements of 403(b) Thrift Plan of Gulfstream Goodwill, Inc. (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

**Note 1. Description of Plan**

**General**

The following description of the 403(b) Thrift Plan of Gulfstream Goodwill, Inc. (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan, which was established on May 1, 1994 and subsequently amended, is classified as a defined-contribution plan covering substantially all employees of Gulfstream Goodwill, Inc. (the "Company" or "Sponsor"), regardless of age or length of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* ("ERISA").

Plan assets are held in the custody of Mutual of America Life Insurance Company (the "Plan Custodian"/"MOA").

**Contributions**

Eligible employees may contribute a percentage of their pre-tax, or after-tax, annual compensation, as defined in the Plan, up to the annual limit, as determined by the Internal Revenue Service ("IRS"). Catch-up contributions are allowed for participants who are at least 50 years of age by the end of the Plan year. Contribution deferral percentages can be changed throughout the year.

The Plan includes a Safe Harbor provision. The Safe Harbor contribution is the lesser of 4% of participant's compensation or the amount contributed to the Plan by the participant. A participant must complete one year of service (at least 1,000 hours) and be at least 21 years of age to be eligible to receive Company contributions.

The Plan provides for eligible participants to be automatically enrolled in the Plan, unless they affirmatively decline to participate.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Sponsor's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their salary deferral contributions, employer matching contributions, and rollovers, plus actual earnings thereon.

**Investment Options**

Participants may direct their account balance among any of the Plan's investment options offered by MOA. Participants may change their investment options at any time.

**Benefits and Forfeitures**

Upon termination of employment, death, or disability of the participant, benefit payments will be made based on Plan provisions and participant elections. As of a participant's termination of employment, the participant is entitled to receive a distribution of their entire vested interest. All non-vested benefits are forfeited by participants should they terminate employment prior to becoming vested. Amounts forfeited are used to reduce future Company contributions.

There were no unallocated forfeitures as of December 31, 2024 and 2023. During the year ended December 31, 2024, approximately \$0 of the forfeited account balances were used to offset Company contributions to the Plan.

***Notes Receivable From Participants***

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50%, of their vested account balance. Loan terms range from 1 to 5 years, or up to 10 years for the purchase of a principal residence. A participant may only have two loans outstanding at a time. The notes are collateralized by the balance in the participant's account and bear interest at a rate of the Wall Street Journal's published prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. Participant notes are recorded at their unpaid principal balance, plus accrued but unpaid interest.

***Investment Risk***

The Plan's investments are not insured by the Plan Custodian, the Company, the Federal Deposit Insurance Corporation, or any other governmental agency; accordingly, the Plan is subject to the normal investment risks associated with money market funds, mutual funds, stocks, bonds, and other similar types of investments that it may elect.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The following is a summary of significant accounting policies followed in the preparation of these financial statements, which have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

As of December 31, 2024 and 2023, the Plan's funds were invested in registered investment companies. The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Registered investment companies are valued at the reported net asset value ("NAV") of shares held by the Plan at year end. The NAV is based on the fair value of the underlying assets owned less any fund liabilities.

Purchases and sales of securities are recorded on a trade-date basis, and interest income is recorded on the accrual basis. The net change in the fair value of the Plan's investments include the Plan's gains and losses on investments bought and sold, as well as the unrealized gains and losses on those investments that are held at the end of the year.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

***Payment of Benefits***

Benefits paid to participants are recorded upon distribution when paid.

***Administrative Expenses***

Administrative expenses of the Plan, including compensation for the Plan Custodian, consultants, and legal counsel, may be paid by the Plan sponsor. Commissions and other investment-related expenses are netted against the change in fair value of investments. Certain administrative expenses are paid directly by the Company at its discretion and are not reimbursed by the Plan. Participant notes receivable administration fees are paid by the participants.

***Subsequent Events***

In preparing the financial statements, the Company has evaluated events and transactions for potential recognition through October 15, 2025 the date the financial statements were available to be issued.

**Note 3. Plan Certification**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mid Atlantic Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

**Note 4. Fair Value Measurement**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

**Note 5. Tax Status**

The original plan is a prototype plan prepared and maintained by a third party. The prototype plan obtained its latest determination letter on March 31, 2017, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax exempt.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 7. Related Party Transactions**

The Plan's investments are managed by the Plan Custodian; therefore, these transactions qualify as party-in-interest transactions.

**Note 8. Change in Custodian**

In January 2025, the Plan adopted a restatement and transferred all assets to a new custodian Voya Retirement Insurance and Annuity Company utilizing Voya's volume submitter plan document.
