NOTE 1 – PLAN DESCRIPTION

The following is a brief description of the Relo Redac, Inc. 401(k) Plan (the “Plan”), which is provided for general purposes only. The Plan document, related adoption agreement and individual statements provided to each Plan participant should be referred to for more complete information.

A. GENERAL

The Plan is a qualified defined contribution pension plan covering all eligible employees who are members of a controlled group which includes Relo Redac, Inc. and affiliated companies (collectively, the “Company”). The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Empower Life & Annuity insurance Company of New York and the Empower Trust Company, LLC (collectively, “Empower”) is the investment custodian of the Plan and record-keeper. The Plan’s investments were administered and held in a trust by the investment custodian. The Plan administrator is responsible for overseeing and ensuring compliance with the Plan document. The investment custodian, record-keeper and the Plan administrator are appointed by the Company.

B. ELIGIBILITY

Employees are eligible to participate in the Plan after six months of service. Any employees of the controlled group members that are not employed by a sponsoring entity are excluded. Residents of Puerto Rico are also excluded.

C. CONTRIBUTIONS

Under the Plan, employees make voluntary contributions to be placed into a trust fund for their benefit on a before-tax or after-tax basis, up to the maximum contributions allowed under the Internal Revenue Service Code (“IRC”). Compensation per the Plan document means wages, tips and other compensation on Form W-2. Compensation is adjusted to exclude fringe benefits, expense reimbursements, deferred compensation, and welfare benefits.

The Company may, at its discretion, make a matching contribution equal to a percentage of the participant’s contributions. For the year ended December 31, 2024, the Company contributed 25% of each qualified employee’s contribution, up to a maximum of 10% of the employee’s compensation. The Company’s matching contributions are only credited to those participants that have completed 1,000 hours of service within the 6-month period following their date of hire.

The Company may make an additional contribution to the Plan termed as a Qualified Nonelective Contributions (“QNEC”) and Qualified Matching Contribution (“QMAC”). The QNEC and QMAC contributions are calculated based upon a uniform percentage applied to compensation. The QNEC and QMAC contribution is only credited to those participants that have completed 1,000 hours of service and are employed at the end of the Plan year. For 2024 a QNEC and QMAC was not declared.

D. PARTICIPANT ACCOUNTS

Each participant account is credited with the participant’s contribution and allocations of employer contributions, plan earnings, and distribution and loan fees (if applicable). Allocations are based on participant earnings or account balances, as defined.

E. NOTES RECEIVABLE FROM PARTICIPANTS

Each participant may borrow up to the lesser of: (1) 50% of the present value of the participant's vested interest in the account or (2) \$50,000. The notes are secured by the vested balance in the participant's account. No note shall be less than \$500 and no more than one note at a time is allowed. The notes bear a reasonable rate of interest as determined by the Plan administrator. Any such borrowings are to be repaid within five years, unless the note is for the purchase of a principal residence for which the repayment period may not extend beyond 30 years. Principal and interest is paid pro rata through payroll deductions. A note becomes immediately due and payable upon a participant's termination of employment, death or disability.

F. PAYMENTS OF BENEFITS

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual instalments over a 10-year period, or partial withdrawals. For termination of services for other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution or installments if balance is fully vested and exceeds \$5,000. Participant account balances less than \$5,000 will be automatically distributed as a lump sum distribution. The Plan also allows hardship withdrawals.

G. VESTING

Participants are vested immediately in their contributions, rollover contributions and earnings thereon. Participants vest in the employer contributions as follows:

<u>Full Years of Service</u>	<u>Vested Percentage</u>
Less than 2	0%
At least 2, but less than 3	20%
At least 3, but less than 4	40%
At least 4, but less than 5	60%
At least 5, but less than 6	80%
6 or more	100%

Participants become fully vested upon attainment of normal retirement age, death, or becoming disabled while still employed.

H. TERMINATION PRIORITIES

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination or partial termination, each participant would become 100% vested in their account balance.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. FINANCIAL REPORTING FRAMEWORK

The accompanying financial statements are prepared according to accounting principles generally accepted in the United States of America ("GAAP"), as promulgated by the Financial Accounting Standards Board ("FASB") in the Accounting Standards Codification ("ASC").

B. BASIS OF ACCOUNTING

The financial statements of the plan are prepared on the accrual basis of accounting.

C. ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

D. INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value (except the group annuity fund contract, which is stated at contract value, see Note 7). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

E. NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

F. ADMINISTRATIVE EXPENSES

The Company pays for the cost of the Plan except for investment administration and record-keeping fees, which are deducted from the fair value of the investments. Administrative expenses that are to be paid from the Plan are paid from the Plan's trust funds and allocated to all participants on a pro rata basis. For the year ended December 31, 2024, the Company incurred certain administrative expenses relating to the Plan without charge to the Plan.

G. PAYMENT OF BENEFITS

Benefits are recorded when paid.

H. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

I. SUBSEQUENT EVENTS

The Plan evaluated subsequent events through October 15, 2025, which is the financial statement issuance date. All items which are required for disclosure have been included in the accompanying financial statements and notes thereto.

NOTE 3 – FORFEITED ACCOUNTS

Upon termination of employment participants forfeit their non-vested balances. These amounts may be used to reduce future Company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$15,794 and \$14,175, respectively. During the year 2024, \$5,456 forfeitures were used to pay administrative expenses.

NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan's investments are held in a trust fund administered by the investment custodian of the Plan. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the trustee:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5 – TAX STATUS

The Plan obtained its latest determination letter dated November 14, 2022, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examinations by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – PARTY-IN-INTEREST

The Plan has fund shares managed by Empower, the custodian and Trustee of the Plan and, therefore, the transactions qualify as party-in-interest transactions. The total amount of these funds was \$7,461 and \$11,958 as of December 31, 2024 and 2023, respectively. Notes receivable from participants also qualify as party-in-interest transactions. The total amount of notes receivable was \$108,459 and \$125,895 as of December 31, 2024 and 2023, respectively.

NOTE 7 – FULLY BENEFIT RESPONSIVE CONTRACT

The Plan has a fully benefit responsive group annuity contract with Empower, whose account balance was \$7,461 and \$11,958 as of December 31, 2024 and 2023, respectively. The contract is a traditional investment contract. The account maintains the contributions in an unallocated fund, which is included in its general account, to which it adds interest.

Since the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the contract including Plan termination and other events as specified in group annuity contract. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The contract may not be terminated at any amount less than the contract value.

The issuer is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent.

NOTE 8 – FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

In accordance with the framework, the Plan groups assets and liabilities measured at fair value into three levels based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value.

These levels are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used between December 31, 2024 and December 31, 2023.

- *Mutual Funds*: valued based on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table classifies the investments measured at fair value on a recurring basis by level within the fair value hierarchy as of December 31, 2024:
