

A. Plan Description:

The following description of the Wenco Industries, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

General:

The Plan is a participant-directed defined contribution plan sponsored by Wenco Industries, Inc. (the Company) covering all employees of the Company who are age 21 or older once they have completed three months of service. It is subject to the provisions of the *Employee Retirement Income Security Act of 1974 (ERISA)*, as amended. As of January 1, 2024, Ascensus, Inc. serves as the Plan's recordkeeper and Ascensus Trust Company serves as the trustee. Prior to January 1, 2024, Reliance Trust Company was the trustee and Automatic Data Processing, Inc. served as the recordkeeper. The plan administrator is responsible for overseeing the plan.

Contributions:

Each year, participants may contribute up to 90 percent of pretax annual compensation, as defined in the Plan. The Plan utilizes an automatic deferral provision where eligible participants will begin deferring 3 percent of eligible compensation on the first of the month following the attainment of the eligibility conditions. Participants may elect out of the automatic enrollment. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Matching and profit sharing company contributions are discretionary as determined by the Company's executives. Participants are eligible for matching and profit sharing contributions after completing one year of service (defined as 1,000 hours during the measurement period) and must be employed on the last day of the plan year. Contributions are subject to certain limitations.

Participant Accounts:

Each participant's account is credited with the participant's contribution, allocation of the Company's contributions and plan earnings and any fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options:

Participants direct the investment of their contributions into the various mutual funds and common collective trust options offered by the Plan. Participants may change their investment allocations at any time.

A. Plan Description (Continued):

Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing contributions portion of their accounts plus earnings is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Forfeited Accounts:

Nonvested participants' accounts that are forfeited upon termination of service or excess employer contributions forfeited are used at the discretion of the plan administrator and can be utilized to pay plan expenses or reduce employer contributions. Forfeitures of \$19,719 and \$0 were used during the years ended December 31, 2024 and 2023, respectively, to reduce plan expenses. The unallocated forfeiture balance was \$45,190, and \$8,965 as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants:

Participants may borrow from their participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the Prime Rate plus one percent (plus two percent through December 31, 2023). A loan will carry the same rate of interest throughout its term. Principal and interest is paid ratably through regular payroll deductions. All loans are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence which may be approved for longer repayment terms).

Payment of Benefits:

Upon termination due to death, disability, retirement, or separation of service, a participant is eligible for a distribution of his or her vested account balance. Participants are eligible for in-service distributions upon attaining age 59.5 and may take distributions from their rollover account at any time. The Plan also allows for hardship withdrawals with certain limitations. Terminated participants with vested balances \$7,000 or less will have their balances distributed upon termination.

B. Summary of Accounting Policies and Investments:

Basis of Accounting:

The accompanying financial statements are prepared on the accrual basis of accounting.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

B. Summary of Accounting Policies and Investments (Continued):

Use of Estimates:

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the trustee. See *Note D* for discussion of fair value measurements. ADP is used for the investment of contributions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Net realized and unrealized appreciation is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments.

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

The Company absorbs administrative and operating costs of the Plan. Certain administrative services are paid by the Plan and recorded as fees in the accompanying statement of changes in net assets available for benefits.

C. Information Certified by the Plan's Trustees:

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, the trustee as of and for the year ended December 31, 2024, and Reliance Trust Company (Reliance), the trustee as of and for the year ended December 31, 2023, (both qualifying institutions), have certified the following information included in the accompanying financial statements and supplemental schedule of assets (held at end of year) is complete and accurate (Reliance - to the best of their knowledge and belief):

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments and notes receivable from participants as shown in the accompanying supplemental schedule of assets held (at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

D. Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

D. Fair Value Measurements (Continued):

The three levels of the fair value hierarchy under FASB ASC 820 are:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for identical or similar assets or liabilities in active or inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability or that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end as they are required to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of the funds as reported to the plan administrator by the custodian of the funds on a daily basis. The common collective trusts seek to meet or exceed the performance of a broad market index benchmark through investment solely in insurance contracts issued by the standard life insurance company and in a diverse portfolio of companies which the investment manager believes to be leaders in innovation, take advantage of new technologies, have superior management, and benefit from new industry conditions in the dynamically changing global economy over an entire secular cycle of growth.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. Related Party Transactions:

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan incurs expenses related to general administration, record keeping and trust administration. As a result, the Plan paid \$44,792 to Ascensus, Inc. and \$28,347 to ADP for recordkeeping services during the years ended December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan. Certain investments consist of mutual funds managed by The Vanguard Group, Inc. through a partnership agreement with Ascensus, Inc., the recordkeeper.

F. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

G. Plan Tax Status:

The Plan operates under a non-standardized pre-approved profit sharing plan provided by Ascensus, LLC. This prototype plan document has been filed with the appropriate agency. The pre-approved plan has obtained a favorable opinion letter, dated June, 30, 2020, from the Internal Revenue Service stating that the pre-approved plan constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax-exempt. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements for the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management performs an annual analysis of the Plan's various tax positions, assessing the likelihood of those positions being upheld upon examination by relevant taxing authorities. Management believes the Plan has conducted its operations in accordance with applicable income tax reporting requirements, and has properly maintained its tax-exempt status, and has taken no material uncertain tax positions that qualify for recognition or disclosure in the financial statements.

H. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

J. Plan Transfer and Restatement:

Effective for the blackout period of December 22, 2023 through February 18, 2024, the Plan's assets of approximately \$1,905,000 were liquidated and transferred from ADP to Ascensus, LLC. K. Nonexempt Party In Interest Transactions:

During 2024, certain participant contributions and loan repayments in the amount of 15,895 were not remitted to the Plan timely and are considered to be delinquent under DOL Regulation 2510.3-102. The plan administrator is working through the corrections for lost earnings and does not believe these late deposits will have a material effect on the financial statements nor affect the qualified tax status of the Plan.

L. Subsequent Events:

The Plan did not have any subsequent events through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued, for events requiring recording or disclosure in the financial statements for the year ended December 31, 2024.
