To the Board of Directors

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of 403(b) Thrift Plan of Side by Side, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of 403(b) Thrift Plan of Side by Side's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of 403(b) Thrift Plan of Side by Side and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of 403(b) Thrift Plan of Side by Side (“the Plan”) provides only general information. Participants should refer to the Plan’s documents for a more complete description of the Plan’s provisions.

General

The Plan is a 403(b) tax-deferred annuity plan covering all eligible employees of Side by Side as defined in the Plan’s provisions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Side by Side is the plan sponsor and serves as the plan administrator.

Contributions

Participants may contribute up to \$23,000 and \$22,500 of pre-tax annual compensation for calendar years 2024 and 2023, respectively, as defined in the Plan in accordance with dollar limits set by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans and Roth deferrals. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. For calendar years 2024 and 2023, \$7,500 is allowed as a catch-up contribution for employees who are 50 and older. The Plan also has “automatic contribution arrangement” of 3% of compensation. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a money market fund and various mutual funds as investment options for participants.

Each year, Side by Side will, or may with respect to any discretionary contribution, contribute to the Plan amounts based on the following:

- a) The total amount of the discretionary contribution is divided among eligible participants for a share on December 31.
- b) Participants will share in this discretionary contribution if the participants are actively employed during the Plan year.

In calculating participant’s share, Side by Side multiplies the discretionary contribution by this fraction:

- c) Eligible participant’s pay divided by the total annual pay of all participants receiving a share.

1. Description of Plan, continued

Participant Accounts

Each participant's account is credited with the participant's contribution, the allocation of Side by Side's discretionary contribution, and the Plan's earnings. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their salary deferral plus actual earnings thereon. Vesting in Side by Side's contributions is based on years of service, as defined. Participants are fully vested in Side by Side's contributions after three years.

Payments of Benefits

In general, on termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the fair value of the participant's account balance or monthly, quarterly, or annual installments over a period of not more than his or her assumed life expectancy (or the participant's beneficiary's assumed life expectancy).

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Presentation

The financial statements of the Plan are reported on the accrual basis of accounting.

Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See below for discussion on fair value measurements.

Payments of Benefits

Benefits are recorded when paid.

Fair Value Measurements

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs – quoted prices in active markets for identical assets

Level 2 inputs – quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs – estimates using the best information available when there is little or no market

The Plan is required to measure certain investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relates to the element.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through October 14, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

3. Notes Receivable from Participants

Notes receivable from participants are repaid semi-monthly at varying interest rates. Interest rates on outstanding notes receivable ranged from 4.60% to 5.85% at December 31, 2024 and 2023. Notes receivable from participants outstanding at December 31, 2024 and 2023, were \$30,592 and \$42,894, respectively.

4. Information Prepared and Certified by the Custodian

No auditing procedures were performed on investments and interest income as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The following summarizes the information certified by Mutual of America Life Insurance Company, the custodian of the Plan, as of December 31, 2024 and 2023, respectively:

The general account (interest accumulation account) is comparable to a cash equivalent and therefore exempt from classification as a Level 1, 2, or 3 asset under ASU-820-10 for the following reasons: 1) there are no front-or-back end charges, so investments in the general account are completely liquid; 2) the interest rate credited to investments in the general account is a current rate, and is not dependent upon the length of time the assets are invested with Mutual of America Life Insurance Company; 3) requests for withdrawal can be made at any time and are processed on the day that they are received; they are not dependent on the company having to liquidate securities in order to generate a payment; and 4) the value shown on the pension fund report is the redeemable value of the fund; there are no deferred sales charges, load assessments or interest rate adjustments that would affect the value as a result of a withdrawal request.

7. Related Party and Party-in-Interest Transactions

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$2,466.

The Plan's investment options include funds managed by Mutual of America Life Insurance Company Corporation or its affiliates. As custodian and recordkeeper, Mutual of America Life Insurance Company Corporation's transactions qualify as exempt parties-in-interest transactions.

8. **Plan Termination**

Although it has not expressed any intent to do so, Side by Side has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA. Upon termination of the plan, participants will become 100% vested in their total accounts.

9. **Tax Status**

The Plan presently does not have a tax determination letter from the Internal Revenue Service ("IRS") and is awaiting IRS' issuance of a revenue procedure for issuing determination letters to individual 403(b) plans. However, the plan administrator and the plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

10. **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market volatility, and credit risks. Market risks include global events which could impact the value of investments securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various asset classes and the utilization of investment managers.
