The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Alabama One Credit Union 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. We are required to be independent of Alabama One Credit Union 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Alabama One Credit Union 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental Schedule of Delinquent Contributions and Schedule of Assets (Held at End of Year) as of and for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional

procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS
FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

Note A - Description of Plan

The following description of Alabama One Credit Union (“Credit Union”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering qualifying employees of Alabama One Credit Union. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Consolidated Appropriations Act of 2023 was signed into law on December 29, 2022, which includes the Setting Every Community Up for Retirement Enhancement Act (“SECURE Act”) 2.0. SECURE Act 2.0 contains over 90 new provisions related to retirement, with varying effective dates through 2027. As these provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions became effective in 2024 and thereafter. There was no material impact on the Plan for these financial statements.

The Plan was amended and restated effective July 15, 2024, to incorporate the plan amendments made since the prior restatement in 2022 into the main Plan Document and to add the titles Branch Concierge and Couriers to the list of employee classifications excluded from participation in the Plan. Management does not believe that the restatement had a significant impact on Plan assets.

Eligibility

An employee who has attained the age of 20 is eligible to defer a portion of their salary after two months of service and receive Credit Union matching and non-elective contributions after one year of service. For all types of contributions, participants may begin to make contributions the first day of the month following the date eligibility requirements are met.

Contributions

The Plan allows eligible employees to make pre-tax and Roth deferral contributions up to the maximum permitted under the Internal Revenue Code. An individual, who has reached age 50, may defer an additional “catch-up” contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Credit Union contributes a fixed matching contribution of 100% of deferrals up to 2.5% of

Note A - Description of Plan - Continued

compensation as well as a fixed non-elective contribution equal to 8.25% of the compensation of all eligible participants.

Participants' Accounts

Participant accounts are credited with the participant's contributions and the allocations of the Credit Union's matching and non-elective contributions, as well as Plan earnings, and charged with an allocation of administrative expenses. Participants may direct the investment of their account balances into various investment options offered by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest of 3.00 – 10.50 percent for the years ended December 31, 2024 and 2023. Principal and interest is paid ratably through monthly payroll deductions. Participants are limited to two loans outstanding at any time.

Vesting

Participants are immediately vested in their deferral contributions. Vesting in the Credit Union contribution is based on years of vesting service, as defined by the Plan. Credit Union contributions to a participant's account vest on a graduated schedule over five years of service, at which time the account is 100% vested.

Payment of Benefits

A participant's account becomes fully vested upon the participant's death, permanent and total disability, or attainment of normal retirement age. Upon termination of service, a participant may receive an amount equal to the vested balance in his or her account in a lump sum payment, partial withdrawal or installment, or an annuity. Further, the Plan administrator may permit a participant who experiences a qualified hardship, as defined, or a participant who has attained age 59 ½ to receive a distribution of a portion of the participant's account balance. Distributions are subject to the applicable provisions of the Plan document.

Note B - Summary of Significant Accounting Policies

Forfeitures

Forfeiture allocations may be used to offset employer contributions and pay administrative expenses. No forfeitures were used for the year ended December 31, 2024. Forfeitures totaling \$39,390 were applied to employer contributions for the year ended December 31, 2023. As of December 31, 2024 and 2023, forfeited non-vested accounts available to reduce employer contributions were \$68,879 and \$4,915, respectively.

Note B - Summary of Significant Accounting Policies - Continued

Basis of Accounting

The financial statements have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

Financial Statement Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. All investments in the Plan are participant directed. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator determines the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions

Employee and employer contributions are reported in the year services are rendered to the Credit Union by Plan participants.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS or based on the provisions of the Plan Document are recorded as a liability with a corresponding deduction recorded for corrective distributions.

Note B - Summary of Significant Accounting Policies - Continued

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Plan sponsor, as provided by the Plan document. Expenses that are paid directly by the Plan sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in the net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Date of Management's Review

Management has evaluated subsequent events through October 13, 2025, which is the date on which the financial statements were available to be issued. See Note I for a discussion of events subsequent to the financial statement date.

Note C - Information Prepared and Certified by Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting Disclosure under ERISA. Accordingly, Newport Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

- Investments at fair value
- Balance of notes receivable from participants and related activity
- Interest and dividends
- Net appreciation (depreciation) in fair value of investments
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to

this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

Note D - Fair Value Measurements

FASB ASC 820 - *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded.

Common Collective Trust (Invesco Stable Value): Valued at the net asset value (NAV) per share, used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the investment. The investment's key objectives are to provide preservation of principal, maintain a stable interest rate, and provide daily liquidity for participant withdrawals and transfers in accordance with the provisions of the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) Certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits. There are no unfunded commitments for these investments, they are valued daily, and there are no redemption restrictions.

Note E - Party-in-interest Transactions

Participant loans are managed by Newport Trust Company, the trustee of the Plan; therefore, these transactions qualify as party-in-interest.

Note F - Plan Termination

Although it has not expressed intent to do so, the Credit Union has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

Note G - Plan Tax Status

The Plan has adopted a defined contribution pre-approved plan document provided by The Standard that is restated to include the latest requirements. The document was approved by the

Note G - Plan Tax Status - Continued

Internal Revenue Service on June 30, 2020, as being designed in accordance with applicable sections of the Internal Revenue Code. The Plan administrator believes the Plan is currently operated in compliance with applicable requirements of the Code; therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan follows accounting standards relating to uncertainty of income tax positions. Tax positions are recognized in the financial statements when it is more likely than not that the position will be sustained by the tax authorities. The Plan administrator assessed whether there were any uncertain tax positions that may give rise to income tax liabilities and determined that there were no such matters requiring recognition in the accompanying financial statements. The Plan files information returns under U.S. federal jurisdiction. With few exceptions, the Plan is no longer subject to U.S. federal tax examinations for years before 2022.

Note H – Reconciliation of Financial Statements to Form 5500

There were no differences between the net assets available for benefits and changes in net assets available for benefits per the financial statements and Form 5500 for 2024 and 2023.

Note I – Subsequent Events

The Plan was amended and restated effective February 15, 2025, to add the Interns and Temporary Employees to the list of employee classifications excluded from participation in the Plan. This restatement also added that full-time Human Resource Assistants are eligible to participate in the Plan. Management does not believe that the restatement will have a significant impact on Plan assets.
