Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the A.Y. McDonald Industries, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities For The Audit Of The Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis For Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities For The Audit Of The Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

1. Description Of The Plan

The following description of the A.Y. McDonald Industries, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering substantially all employees of A.Y. McDonald Industries, Inc. and Subsidiaries (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Merger

Effective December 31, 2024, the Plan was amended to add JCM Industries, Inc. as a participating employer. Also effective December 31, 2024, the JCM Industries, Inc. 401(k) Profit Sharing Savings Plan was merged into the Plan pursuant to a formal agreement approved by the plan sponsors. The merger was conducted in accordance with the applicable provisions of ERISA and the Internal Revenue Code. As of December 31, 2024, the Plan recognized a pending transfer receivable of \$11,744,512, representing the net assets to be received from the JCM Industries, Inc. 401(k) Profit Sharing Savings Plan. The transfer is expected to be completed within 30 days, subject to final reconciliation and approval by the plan fiduciaries and service providers.

The pending transfer receivable is recorded as an asset in the accompanying statement of net assets available for benefits. The amount is based on preliminary financial information provided by the JCM Industries, Inc. 401(k) Profit Sharing Savings Plan and may be adjusted upon final settlement. The merger did not result in any changes to participant account balances or plan provisions. All participant rights and benefits under the JCM Industries, Inc. 401(k) Profit Sharing Savings Plan were preserved and transferred to the Plan without reduction.

Contributions

Employees are eligible to participate on their date of hire and are automatically enrolled in the Plan with a deferral amount of 6% of eligible compensation. The Plan includes an automatic escalation feature in which a participant's deferral percentage increases 1% each year until their election deferral reaches 10%, unless the participant elects otherwise.

Participants may contribute up to 80% of eligible compensation in the form of pre-tax or after-tax (ROTH) contributions not to exceed 20% for highly compensated employees or Internal Revenue Code (IRC) limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Notes To Financial Statements (*Continued*)

Under the provisions of the Plan, the Employer has the option to make discretionary matching contributions equal to a percentage of eligible participants' elective deferral contributions. Participants who are not covered under a collective bargaining agreement are eligible for the discretionary match upon becoming eligible to make elective deferral contributions. The Employer elected to make matching contributions equal to 50% of each participant's deferral contribution limited to 4% of the participant's compensation for the year ended December 31, 2024.

Under the provisions of the Plan, the Employer has the option to make discretionary profit-sharing contributions. Participants who are not covered under a collective bargaining agreement are eligible for the discretionary profit-sharing contributions if they are employed by the Employer on the last day of the plan year. The Employer elected to make a discretionary profit-sharing contribution equal to 3% of the participant's compensation, plus an additional 3% of the participant's compensation in excess of the social security wage base for the year ended December 31, 2024. The employer profit-sharing contribution for the year ended December 31, 2024 was \$2,261,187.

Participant Accounts

Each participant's account is credited with the participant's contributions and discretionary employer matching and profit-sharing contributions as well as allocations of the Plan's earnings and expenses. Allocations are based on the participant's eligible compensation, the value of account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants

The Plan does not allow for notes receivable from participants. During 2021, plan assets of another plan were transferred into the Plan. These transferred assets included notes receivable from participants. These loans are secured by the participant's vested account balance and bear interest of 6%. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their rollover, voluntary and employer matching contributions, plus actual earnings thereon. Vesting of the Employer's discretionary profit-sharing contributions is based on a rate of 20% for each year of credited service beginning in the second year of service. Participants are fully vested after six years of credited service or upon death, disability or attainment of normal retirement age of 65.

Hardship Withdrawals

Participants may elect to withdraw all or a portion of their elective deferral contribution balances if they incur a financial hardship. Hardship withdrawals are subject to the terms of the plan agreement and provisions of the IRC.

Notes To Financial Statements (*Continued*)

Payment Of Benefits

Upon termination of service due to death, disability or retirement, participants with an account balance greater than \$7,000 may elect to receive either a lump-sum amount equal to the value of their account, receive installments over a period of time or leave their balance in the Plan subject to minimum distribution requirements. Under the default automatic rollover provisions, participants with a total vested balance of all contribution types other than rollovers of \$7,000 or less will receive a distribution to an Individual Retirement Account without participant consent if a participant does not make a different distribution election after receiving the required notification.

In-Service Withdrawals

Active participants who reach age 59½ may withdraw all or part of their vested accounts.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited accounts totaled \$890 and \$788, respectively. These accounts may be used to reduce employer discretionary matching and profit-sharing contributions or to pay plan expenses. For the year ended December 31, 2024, employer contributions were reduced by \$217,159 from forfeited accounts.

2. Summary Of Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use Of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's fiduciary committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Notes To Financial Statements (*Continued*)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the plan administrator considers the loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan agreement.

Contributions

Contributions from plan participants and matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. Profit-sharing contributions are recorded in the year in which they are declared by the Employer.

Payment Of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, the trustee of the Plan.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and Money Market Fund: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-ended funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts: Valued at the NAV of units of the trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled Separate Account: Valued at the NAV per unit based on either the observable NAV of the underlying investment or the NAV of the underlying pool of securities. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities and then divided by the number of shares outstanding.

5. Related-Party And Party-In-Interest Transactions

Certain plan investments are shares of a common/collective trust managed by Putnam Fiduciary Trust Company (Putnam), a related party to Empower Trust Company, LLC. Empower Trust Company, LLC is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan receives a revenue credit from Putnam. A revenue credit program is a refund of a portion of the revenue Putnam and other fund managers have received based on the funds participants have chosen. Certain recordkeeping fees and other plan fees are paid through the revenue credit program. For the year ended December 31, 2024, \$239,461 was paid to the Plan under this revenue credit program, of which \$189,337 was used to pay administrative expenses.

Notes receivable from participants given to parties-in-interest totaled \$1,597 and \$5,551 as of December 31, 2024 and 2023, respectively.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

7. Prohibited Transactions

As required by ERISA Section 2510.3-102, the Employer is required to segregate employee contributions to the Plan from its general assets as soon as practicable. The Plan had contributions totaling \$42,486, all of which represented employee salary deferrals and loan repayments, that were not remitted timely during 2023 and 2024. These contributions are considered prohibited transactions.

For lost earnings that have yet to be corrected as of December 31, 2024, the Employer will calculate lost investment earnings and compensate the Plan for such amounts in 2025.

8. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022 stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believes that the plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Department of Labor or IRS. Management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks And Uncertainties

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

10. Subsequent Events

The Securing a Strong Retirement Act (SECURE 2.0) was signed into law on December 29, 2022 and includes mandatory and optional provisions with effective dates in 2025 and later. The plan administrator will determine the optional provisions to elect and amend the plan document accordingly.
