**Basis for opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Responsibilities of management for the financial statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's responsibilities for the audit of the financial statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other matter – supplemental schedules required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 and schedule of reportable transactions for the year ended December 31, 2024 is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such supplementary information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Stepan Company Employee Stock Ownership Plan II (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document, as amended, for more complete information regarding the Plan's provisions.

##### **General**

Effective January 1, 2006, Stepan Company (the "Company") established a qualified, tax exempt, employee stock ownership plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Plan is administered by the Company. Fidelity Management Trust Company ("Fidelity") is the Plan's trustee. The investment assets of the Plan are held in the Stepan Company Employee Stock Ownership Plan II Trust.

##### **Eligibility**

Employees are eligible to participate on their first day of employment. Participants must be employed on the last day of the year in order to be eligible for a Company contribution for that Plan year, except in circumstances of retirement, death or disability.

##### **Company Contributions**

Each year, at its discretion, the Company may make a contribution to the Plan. For the year ended December 31, 2024, the Board of Directors approved discretionary contributions of approximately \$1,514,000. Participants are not permitted to contribute to the Plan.

##### **Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with allocable shares of cash, other assets or Company stock pursuant to the Plan, and the income, losses, appreciation and depreciation attributable thereto.

##### **Vesting**

Employees that became a participant in the Plan effective as of January 1, 2006, are fully vested as of January 1, 2006. Employees that became participants in the Plan after January 1, 2006, but before July 1, 2006, became fully vested as of the date of their participation. Employees that became participants in the Plan effective on and after July 1, 2006 are fully vested following the completion of two years of service.

##### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$26,666 and \$52,349, respectively. These accounts may be used to reduce future employer contributions or administrative expenses. During 2024, \$69,211 of the forfeited non-vested balance was used to offset administrative expenses, and there were no forfeitures used to reduce employer contributions.

##### **Voting Rights**

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account. The trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. Each participant is deemed to have instructed the trustee to vote, in accordance with his or her

vote on shares of Company stock allocated to his or her account, his or her proportionate share of the votes attributable to all shares of non-voted Company stock.

#### ***Payment of Benefits***

Each quarter, participants may elect to receive the current year's earned dividends in the form of a cash distribution or reinvest in Company stock. Full distributions from the Plan will not be made until a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company. Distributions are made in cash or, if a participant elects, in the form of Company stock plus cash for any fractional share.

Effective March 9, 2021, the participant account may be distributed in systematic annual, quarterly, semi-annual, monthly, semi-monthly or biweekly distributions, after retirement, death, disability or severance from employment at a fixed percentage or in amounts determined in accordance with Internal Revenue Service ("IRS").

The Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE Act") changed the age at which participants are required to take Required Minimum Distributions from their accounts. Under the new law, effective January 1, 2020, participant distributions may not be deferred past April 1 following the year in which the participant reached the age of 72. The SECURE 2.0 Act increased the age to 73 in 2023 and established an additional increase that will bring the starting age to 75 by 2033.

#### ***Diversification Transfers***

Diversification is offered to participants close to retirement so that they may have the opportunity to move their investment in Company stock into investments that are more diversified. Participants who are at least age 55 with a vested balance may elect to diversify all, or a portion of their account. Diversification is offered quarterly to each eligible participant. A participant may diversify up to 100% of his or her vested Plan balance in 25% increments. Participants who elect to diversify will have the fair market value of the elected portion of the eligible amount in cash transferred to the trust funding the Stepan Company Savings and Investment Retirement Plan.

## **NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared using the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the record date. Net appreciation (depreciation) includes gains and losses on investments bought and sold as well as held during the year.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

As provided in the Plan document, administrative expenses may be paid either by the Plan or by the Company. The Plan pays for record-keeping, audit and distribution fees.

#### ***Transfers***

Diversification transfers from the Plan to the Stepan Company Savings and Investment Retirement Plan are recorded when transacted.

### **NOTE 3 - FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board ("FASB") has issued guidance that defines fair value, establishes a framework for measuring fair value under current accounting pronouncements that require or permit value measurement and enhances disclosures about fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the FASB guidance are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Stepan Company common stock:* Valued at fair value as determined by quoted market prices on the New York Stock Exchange.

*Fidelity Retirement Money Market Fund and cash reserves:* Valued using the amortized-cost method, which approximates fair value. A money market fund is an investment whose objective is to earn interest for shareholders while maintaining a stable net asset value of \$1 per unit. A money market fund's portfolio is composed of short-term (less than one year) securities representing high-quality, liquid debt and monetary instruments. A money market fund seeks to obtain as high a level of current income as is consistent with the preservation of capital and liquidity.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 5 - TAX STATUS

The Plan was amended and restated as of July 1, 2014, and was submitted for review by the IRS. The Plan received a favorable determination letter, dated April 3, 2015, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable regulations of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress.

#### NOTE 6 - PLAN TERMINATION

Although, it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

#### NOTE 7 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan transacts in shares of Stepan Company common stock and certain plan investments are managed by Fidelity Investments, an affiliate of the trustee of the Plan. These transactions qualify as party-in-interest transactions.

#### NOTE 8 - RISKS AND UNCERTAINTIES

The Plan's investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 9 - SUBSEQUENT EVENTS

Plan management has evaluated the Plan's December 31, 2024, financial statements for subsequent events through October 14, 2025, the date the financial statements were available to be issued. Plan management is not aware of any subsequent events that would require recognition or disclosure in the financial statements except as indicated below.

On February 19, 2025, the Plan established a stock purchase agreement with the Stepan Company Trust for Qualified Plans ("the Master Trust") for purposes of purchasing Stepan Company common stock. Effective February 19, 2025, the Master Trust sold 24,211 shares to the Plan.
