INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants
Redwood Dental Group 401(k) Profit Sharing Plan & Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Redwood Dental Group 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

The Plan is a defined contribution plan that was established on July 3, 2017, by Redwood Dental Group and related entities: Redwood Dental of Georgia, PC, Redwood Dental of Illinois, PLLC, Redwood Management Employment Services, Smart Dental Holdings, LLC and Station Dental Group, PC (collectively the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The following description of the Plan is provided for general information purposes only. Participants should refer to the Summary Plan Description or the Adoption Agreement, including amendments thereto, for a complete description of the Plan’s provisions.

Administration

The Plan Sponsor and named Plan Administrator is Redwood Dental Group. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan’s investment offerings and monitors investment performances and fees. The Plan’s Trustee and Investment Custodian is Reliance Trust Company. The Investment Custodian holds all of the Plan’s assets and executes all of the Plan’s transactions. The Company has also retained ADP Retirement Services to provide participant recordkeeping and administration services. Subsequent to year end, effective January 1, 2025, the Trustee and Investment Custodian was changed to ADP Retirement Trust Services, LLC.

Eligibility

The Plan covers all employees of the Employer, except those who are covered by a collective bargaining agreement that does not provide for participation in the Plan and non-resident aliens with no U.S. income. All eligible employees must be 21 years of age and may begin participating in the Plan after completing three months of service, with the entry date being the day the participation requirements are met.

Contributions to the Plan

Each year, participants may elect to contribute up to 90% of their eligible compensation, as defined in the plan document, through payroll withholdings. The Plan also offers a Roth 401(k) option allowing participants to make deferrals on an after-tax basis. Participants who have attained age 50 before the end of the year are eligible to make additional ‘catch-up’ contributions. Participants may also contribute amounts representing distributions from other defined benefit or other defined contribution plans (rollovers).

The Plan also includes an auto-enrollment provision. Those eligible employees who fail to affirmatively elect to participate or waive their right to participate are enrolled at 3% of their compensation.

The Company may make flexible discretionary matching contributions on behalf of the participants in an amount to be determined solely by the Plan Sponsor; the Company will match any ‘catch-up’ contributions. Eligibility for these matching contributions is the same as the eligibility requirements for entry into the Plan. The Company approved a flexible discretionary matching contribution equaling the lesser of 7.45% of 6% of eligible wages or 7.45% of employee deferrals for the year ended December 31, 2024.

Additional discretionary profit-sharing contributions may be contributed to the Plan at the discretion of the Plan Sponsor. Employees must be employed on the last day of the plan year to receive these contributions. No discretionary profit-sharing contributions were made to the Plan for the year ended December 31, 2024.

Participants direct the investment of both their individual contributions plus their share of any matching and profit-sharing contributions into the various investment options offered by the Plan. The Company's contributions are allocated in the same manner as that of the participant's elective contributions.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and employer contributions as well as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance, subject to certain Department of Labor and IRS requirements. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined in the plan document. Principal and interest is paid ratably through payroll deductions each pay period.

Distribution of Benefits

On termination of service, participants with vested account balances greater than \$7,000 (\$5,000 prior to 2024) may elect to receive a lump sum distribution, a partial distribution, installment payments or rollover their account balance to another qualified account. Those participants whose account balances exceed \$7,000 (\$5,000 prior to 2024) may also elect to defer the distribution of their plan balance. If a participant's vested account is more than \$1,000 but less than \$7,000 (\$5,000 prior to 2024), the Plan Administrator may distribute the account balance into an individual retirement account for the benefit of the participant, absent a participant's affirmative distribution election. Participants with balances less than \$1,000 will receive a cash distribution. Participants who elect to have their benefit payments deferred continue to share in allocations of investment income and losses but do not share in subsequent allocations of employer contributions. Special rules apply to distributions due to death, disability, and retirement. Participants should refer to the full plan document for details.

The Plan allows for in-service distributions upon attainment of age 59 1/2 for all deferral contributions, discretionary employer contributions, and rollover contributions for any reason. The Plan also allows for in-service distributions prior to attainment of the Plan's normal retirement age due to financial hardship, as defined in the plan document, from vested account balances.

Vesting

Participants are immediately vested in their contributions (deferrals and rollovers) and earnings thereon. Vesting in flexible discretionary matching and profit-sharing contributions is based on years of continuous service at a rate of 25% per year after 1 full year of credited service. A participant is 100% vested after 5 years of credited service. Participants also become 100% vested upon death, disability, or attainment of normal retirement age.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts are used to pay plan expenses and to reduce future employer contributions. The balance in the forfeitures account at December 31, 2024 and 2023 was \$64,227 and \$41,712, respectively. During the year ended December 31, 2024, \$34,589 in forfeitures were used to reduce the employer's matching contribution.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared using the accrual basis of accounting. Income from investments is recorded when it is earned. Employee contributions are recorded when withheld from pay. Employer contributions are recorded in the period to which they pertain. Expenses are recorded in the accounting period in which they are incurred.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make repayments on a note receivable and the Plan Administrator deems the note receivable to be uncollectible, the balance on the note receivable from the participant is reclassified to benefits paid to participants.

Payment of Benefits

Benefits are recorded when paid.

Fees and Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation or depreciation in fair value of investments.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including, October 10, 2025, which is the date the financial statements were available to be issued.

Note 3 – Unaudited Investment Information Certified by the Trustee

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by Reliance Trust Company as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

1. All investment balances reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
2. All investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
3. All investment-related information included in the Supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024; and
4. Notes receivable from participants as of December 31, 2024 and 2023 and the related income on notes receivable from participants for the year ended December 31, 2024.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan's investments consist solely of mutual funds and money market funds that are measured on a recurring basis using Level 1 inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and Money Market Funds: Valued at daily closing prices as reported by the funds. Mutual funds and money market funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds and money market funds held by the Plan are deemed to be actively traded.

Note 5 – Party-in-Interest Transactions

Plan investments are managed by Reliance Trust Company, who is the Plan's Trustee and Investment Custodian. Indirect compensation (that is netted against investment income on the statement of changes in net assets available for benefits) is paid to the Custodian from total annual operating expenses charged on the balance of fund investments, depending on the particular fund. In addition, the Plan pays direct compensation to ADP Retirement Services related to recordkeeping and administration services. Transactions involving these investments and services are considered party-in-interest transactions; however, these transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their discretionary employer contributions.

Note 7 – Plan Amendment and Tax Status

The Plan is utilizing a non-standardized prototype plan, which has been filed with the IRS and has received a favorable opinion letter dated October 6, 2020, from the IRS. The Plan Sponsor has not elected to apply for an individual IRS Determination Letter on the adoption of the Plan. However, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code and, therefore, that the Plan is qualified under Section 401(a) and is exempt from Federal income tax as of December 31, 2024.

As of December 31, 2024, the Plan was most recently amended effective January 1, 2024. The amendment provided for recognition of service with another employer for eligibility purposes. Periods of service with any entity the employer acquires will also be counted, but only if the individual was an employee of the acquired entity at the time of the acquisition. Additionally, Smart Dental Holdings, LLC was added as a participating employer.

The Plan permitted provisions of SECURE Act 2.0 during the years ended December 31, 2024 and 2023. Written amendments to the plan document to reflect these operational changes will be adopted at a later date in accordance with the deadlines pursuant to applicable laws and IRS guidance.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024, the Plan Administrator believes that the Plan has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, the Plan is currently not being examined.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
