### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of H. M. Dunn Aerosystems, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

#### 1. Description of Plan

The following description of the H. M. Dunn Aerosystems, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the Plan administrator.

**General** - The Plan is a defined contribution plan established effective January 1, 1995, and restated January 1, 2021. The Plan is sponsored by H.M. Dunn Aerosystems, Inc. (the Company) and covers all employees, excluding nonresident aliens, union and leased employees, who have completed one hour of service within a one month consecutive period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company's Retirement Plan Committee (the Committee) is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Trustees. Reliance Trust Company is the trustee and custodian of the Plan.

**Contributions** - Each year, participants may contribute up to 90 percent of pretax annual compensation, as defined in the Plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Discretionary employer contributions are determined by the Company's Board of Trustees. Additional amounts may be contributed at the option of the Company as additional discretionary matching or discretionary nonelective contributions to the Plan to participants who have completed 1,000 hours of service during the Plan year and are employed on the last day of the Plan year. For the years ended December 31, 2024 and 2023, the Company elected to make a discretionary employer matching contribution of 50% of the first 5% of salary deferred into the Plan by participants. For the years ended December 31, 2024 and 2023, there were no discretionary nonelective contributions made to eligible participants out of forfeited nonvested accounts. Contributions are subject to certain IRC limitations.

### Notes to Financial Statements

#### 1. Description of Plan (continued)

**Participant investment account options** - Participants may direct the investment of their contributions into any of the various investment options offered by the Plan and may change their investment options at any time, subject to the terms of the funding vehicles. The Plan currently offers 32 mutual funds and a common collective trust as investment options for participants.

**Participant accounts** - Each participant's account is credited with the participant's contributions, discretionary employer matching contributions, allocations of the discretionary nonelective contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are vested immediately in their voluntary contributions and amounts rolled over or transferred into the Plan plus actual earnings thereon. Discretionary employer matching and nonelective contributions plus actual earnings vest according to the following schedule:

<u>Years of Service</u>	<u>Vested %</u>
Less than 1	0%
1 or more	100%

A vested year of service is attained when a participant works at least 1,000 hours during a Plan year. Additionally, participants who are employed on or after normal retirement age (as defined by the Plan) are automatically fully vested in all contributions.

Participants transferred into this Plan from Apex Engineering International, L.L.C., Nex-Tech and BG Aerostructures, Inc. were fully vested at the time of transfer.

#### 1. Description of Plan (continued)

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. A participant can have two loans currently outstanding in the Plan. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Terms range up to 5 years or greater for the purchase of a primary residence.

**Payment of benefits** - Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or periodic or ad-hoc distributions to satisfy required minimum distribution requirements. For a participant with an account balance of \$5,000 or less, if the participant has not attained the later age of 62 or normal retirement age (as defined by the Plan) and does not elect to have such distribution paid directly to an eligible retirement plan in a direct rollover or to receive the distribution, then the Plan administrator will rollover and deposit the distribution directly into an Individual Retirement Account (IRA) designated by the Plan administrator. In-service distributions are permitted under the Plan for participants who have reached age 59 ½ or in situations of hardship or disability.

**Forfeited accounts** - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$31 and \$6,896, respectively. These accounts may be used to reduce Plan expenses first and then allocated as an additional discretionary nonelective contribution, additional discretionary employer matching contribution, used to reduce any nonelective contribution or used to reduce any employer matching contribution. Forfeited nonvested accounts may also be used to supplement future nonelective employer contributions. During 2024 and 2023, discretionary employer matching contributions were reduced by \$1,937 and \$2,407, respectively, from forfeited nonvested accounts.

#### 2. Summary of Accounting Policies

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

### Notes to Financial Statements

#### 2. Summary of Accounting Policies (continued)

**Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment manager. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Unit values** - Individual participant accounts for the common collective trust are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds, but do have an interest therein represented by units valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each account are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of benefits** - Benefits are recorded when paid. There were no benefits requested before year end that were not paid.

#### 2. Summary of Accounting Policies (continued)

**Administrative expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Recordkeeping and audit fees are paid directly from the Plan and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent events** - The Plan has evaluated subsequent events through the date of this report, which is the date the financial statements were available to be issued. Effective January 1, 2025, the Plan changed its third party administrator from ADP Retirement Services to Principal Life Insurance Company. The Plan transferred its asset balances from Reliance Trust Company to Principal Life Insurance Company on January 2, 2025. No other significant items were noted during this evaluation that would require disclosure in the financial statement or accompanying footnotes.

#### 3. Information Certified by Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the custodian and trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule, as of and for the years ended December 31, 2024 and 2023, are complete and accurate with respect to investments:

- Investments, at fair value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits. There have been no significant changes in the techniques used during the years ended December 31, 2024 and 2023.

#### 4. Fair Value Measurements (continued)

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

*Common/Collective trust:* Valued at the year-end NAV of units of the bank collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based on the fair value of the underlying investments held by the respective fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. Fair Value Measurements (continued)

(a) The objective of this fund is to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity.

#### 5. Common/Collective Trust

The Invesco Stable Asset Fund Trust (Fund) is a collective trust fund and considered to be a stable value fund. The purpose of this Fund is to invest/reinvest collectively in assets of eligible entities. The Fund does not invest directly in fully benefit-responsive contracts, rather it invests in the underlying assets (investment contracts) and enters into a “wrapper” contract issued by a third party. The Fund is valued at NAV of the units of the individual collective trust. The NAV is calculated daily and net investment income and realized and unrealized gains or losses on investments are not distributed but rather reinvested and reflected in the NAV of the Fund. The Fund is valued at fair value and then adjusted by the issuer to contract value. Contract value represents contributions made to the Fund, plus earnings, less participant withdrawals and is considered to be representative of fair value.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. However, certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

1. Participant withdrawals based on advice or direction;
2. Amendments to the Plan documents (including complete or partial Plan termination or merger with another plan);
3. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
4. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or,
5. Participating Plan makes a withdrawal for any reason other than participant-directed withdrawals

The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring. Units of the Fund are issued and redeemed at current NAV.

#### **6. Related-Party and Party In Interest Transactions**

As described in Note 2, the Plan made direct payments to the third party administrator and the Plan's third party auditor of \$55,282 and \$57,810 for the years ended December 31, 2024 and 2023, respectively, which were not covered by revenue sharing and are considered to be party in interest transactions under ERISA. In addition, investment related expenses are covered by revenue sharing and included in net appreciation of fair value of investments. The Company pays directly any other fees related to the Plan's operations.

#### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

#### **8. Tax Status**

The Company adopted a pre-approved plan offered by its third party administrator, Automatic Data Processing (ADP), Inc. The Plan received an Internal Revenue Service (IRS) Opinion Letter dated October 6, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress (2021 and after).
