### 1. Description of Plan

The following description of Guido Companies, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan that covers all eligible employees of Guido Companies, Inc. (the Company, the Employer, or Plan Sponsor). All classifications of employees of the Company are eligible to participate upon the completion of eligibility requirements except for leased employees; employees covered by a collective-bargaining agreement; independent contractors, as defined; and non-resident aliens. The Plan covers all eligible employees of the Company who have completed at least three months of service and who are age 21 or older may participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC). The Trustee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitor investment performance.

#### *Participant Contributions*

Participants may elect to contribute up to 90% of eligible compensation, subject to the maximum dollar amount allowable under the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with and subject to limitations imposed by the IRC. Participants may also contribute amounts representing distributions (rollovers) from other qualified defined benefit or defined contribution plans.

#### *Employer Contributions*

The Company makes safe harbor matching contributions, as defined in the Plan. The Company's contribution percentage was 100% of the first 3% of compensation, and 50% of the next 2% of compensation during 2024. The Company may also make additional profit-sharing contributions to the Plan, at the option of the Company. For the year ended December 31, 2024, safe harbor matching contributions totaled \$593,084. There were no profit-sharing contributions for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, the Company's contributions, and earnings or losses, and may be charged with certain administrative expenses. Plan earnings or losses are applied to a participant's account balance based on the investment experience of the funds held and the number of shares owned in each fund by the participant.

#### *Vesting*

Participants are vested immediately in their contributions and the Company's safe harbor match, plus actual earnings thereon. Vesting in the Company's profit-sharing contribution portion of their accounts is based on years of continuous service. However, upon a participant's death, disability, or attainment of normal retirement age, all amounts are immediately vested.

### ***Forfeitures***

Participant forfeitures of nonvested balances will be used to reduce future employer contributions and pay the expenses of the Plan. At December 31, 2024 and 2023, unallocated forfeitures totaled \$78 and \$72, respectively. During 2024, \$1,018 of forfeitures were used to offset Plan employer contributions.

### ***Payment of Benefits***

Upon termination of service, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. Any balance that does not exceed \$5,000 is automatically paid out as soon as administratively possible. In the absence of an election by the participant within the time period specified by the Plan administrator, any balance that exceeds \$1,000, but does not exceed \$5,000, is paid as a direct rollover to an individual retirement account designated by the Plan administrator, and any balance that does not exceed \$1,000 is paid directly to the participant in the form of a cash, lump-sum distribution. Hardship withdrawals and in-service distributions are also available subject to certain limitations.

### ***Investment Options***

Upon enrollment in the Plan, a participant may direct all contributions to selected investments, as made available and determined by the Plan administrator, in 1% increments. Participants may change their investment options daily.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest loan balance in the previous 12-month period or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the Prime Rate plus 1%. Principal and interest are paid through payroll deductions. As of December 31, 2024, interest rates ranged from 4.25% to 9.50%, with various maturities through 2043. Loan terms range from one to five years. If the purpose of the loan is to acquire or construct a primary residence of the participant, the repayment period may exceed five years.

### ***Administrative Expenses***

Administrative expenses are generally paid by the Company; however, the Plan may pay transaction fees, which are allocated to the specific participants initiating the transactions.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates. Significant items subject to such estimates and assumptions include the fair value of investments.

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies using information provided by the Trustee. See Note 3 for disclosure of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### *Payment of Benefits*

Benefits paid to participants are recorded as a reduction of net assets available for benefits when paid.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### 3. Fair Value Measurements

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices for the asset or liability that are observable.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, Level 2 inputs must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques that are used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

*Mutual Funds* - The fair value of mutual fund investments is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The method above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 4. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan.

The Plan's independent accountants did not perform any auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

## 5. Related Party and Party-in-Interest Transactions

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Employer, and certain others. As such, transactions conducted by Reliance Trust Company qualify as party-in-interest transactions.

The Plan also pays for third-party administrator fees and investment advisory, which qualify as party-in-interest transactions. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

## 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

### 7. Tax Status

On September 1, 2021, the Plan adopted a prototype plan document sponsored by ADP Retirement Services (ADP). ADP received an opinion letter from the IRS, dated October 6, 2020, which states that the prototype document satisfies the applicable requirements of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
