### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the accompanying financial statements of Swisher International, Inc. Defined Contribution Plan for Salaried Employees (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, including the related notes (collectively referred to as the "financial statements").

#### 1. Description of Plan

The following description of the Swisher International, Inc. Defined Contribution Plan for Salaried Employees (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering all full-time salaried employees of the Swisher International, Inc. Controlled Group ("Company") except those employed by Drew Estates. Island Management, LLC, an unrelated employer, is a participating employer in the Plan. Eligibility in the Plan is limited to those salaried employees originally employed after April 30, 2011, who have attained age 21 and who have completed three full calendar months of employment.

The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is administered by a management committee appointed by the Board of Directors of the Company.

##### **Contributions**

As soon as administratively feasible following the end of each calendar quarter, the Company contributes 8% of compensation earned during the calendar quarter, on behalf of each participant who is employed on the last business day of such calendar quarter or whose Normal Retirement, Disability or death occurred during such calendar quarter. Contributions are subject to certain limitations. A participant can make rollover contributions which are held in a separate account and can be invested based on the participant's election. The Plan currently offers a group of twenty-four mutual funds/money market accounts and a common collective trust as investment options for participants.

##### **Participant Accounts**

Each participant's account is credited with allocations of the Company's contribution and account earnings based on the investment activity in the period. The benefit to which a participant is entitled is that which can be provided from the participant's vested account.

##### **Vesting**

An employee must be credited with three vesting years of service to be fully vested under the Plan. Any participant whose employment is terminated prior to the completion of three years of service is not entitled to any benefits under the Plan. A participant is 100% vested in all rollover contributions.

##### **Payment of Benefits**

On termination of service (including termination due to death, disability, or retirement), a participant may elect to receive the accumulated value of the vested interest in his or her account in accordance with Plan provisions. Minimum required distributions, to certain participants, are distributed in the form of an annuity while the participant continues employment, and then the participant has the ability to elect a lump sum distribution after the participant's termination of service.

##### **Other Deductions**

Other deductions include administrative expenses which are paid by the Plan.

#### **Payment Options**

The normal form of benefit payment is a life annuity. Unless elected otherwise, this is the form in which retirement income will automatically be paid if an employee is not married. If an employee is married at the time retirement payments are scheduled to begin, unless elected otherwise, the employee will receive a monthly retirement income for life with an annuity payable for life, continuing after the participant's death, to his or her spouse. The amount continued to the spouse upon death shall be 50% of the amount payable to the retired participant. In addition, a participant may choose a lump sum distribution.

#### **Forfeited Accounts**

Forfeitures of participant unvested accounts may be used to offset future Company contributions. There were forfeited nonvested accounts of \$156,649 and \$189,932 for the years ended December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$126,000 in accumulated forfeitures were used to offset the Company's contributions.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan have been prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America, ("US GAAP").

#### **Use of Estimates**

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of additions and deductions to net assets available for Plan benefits during the reporting period. The most significant estimates include the Plan's valuation of investments. Due to uncertainties inherent in the estimates and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions could be material to the financial statements.

#### **Fair Value Measurements**

The Plan follows the Financial Accounting Standards Board's ("FASB") authoritative guidance on Fair Value Measurements and Disclosures. Accounting Standards Codification Topic 820 ("ASC 820"), "Fair Value Measurements and Disclosures", establishes a framework for measuring fair value. The guidance defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price methodology).

The framework provides a fair value hierarchy that prioritizes the inputs of valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value, including the general classification of such assets pursuant to the valuation hierarchy:

- *Registered investment companies (mutual funds and money markets)* -Mutual funds and money markets are valued at their respective net asset values ("NAV"). The NAV is typically determined by the fund at the close of regular trading in the active market in which the fund is traded. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. Investments in mutual funds and money markets are classified as Level 1 within the valuation hierarchy.
- *Common collective trusts* -The investments are public investment vehicles using the NAV provided by the fund administrator. Common collective trusts are valued at the NAV representing the value of which shares may be purchased or redeemed. The beneficial interest in the net assets of the trust is represented by units. Issues and redemptions of units are recorded, upon receipt of the unit holder's instruction in good order, based on the next determined net asset value per unit. Net asset value per unit is determined each business day.

#### **Investment Income Recognition**

The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation in fair value of investments which consists of the realized gains and losses and the unrealized appreciation and depreciation on these investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividends are recorded on the ex-dividend date.

#### **Payment of Benefits**

Benefits are recorded when paid.

**Risks and Uncertainties**

The Plan provides for various investment options in any combination of mutual funds and the Vanguard Retirement Savings Trust. Investment securities are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

**5. Related-Party Transactions and Party in Interest Transactions**

Certain Plan investments are managed by an affiliate of Vanguard Fiduciary Trust Company who acts as trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from prohibited transactions rules. The Plan is not charged for administrative services performed on its behalf by the Company. The Company has paid substantially all other administrative expenses for the Plan.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**7. Tax Status**

The Internal Revenue Service ("IRS") has determined and informed the Plan by a letter dated September 27, 2013 that the Plan and related trust are designed in accordance with applicable

sections of the IRC. Accordingly, no provision for income taxes has been made. U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS.

The Plan administrator has analyzed the tax positions by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **8. Subsequent Events**

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available for issuance, and has determined that there are no material events or transactions that would require adjustment of the financial statements or additional disclosure in the financial statements.
