**Note 1 Plan Description**

The following description of the Dnata US Inflight Catering 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution 401(k) plan covering all employees who meet the eligibility requirements of Dnata US Inflight Catering and its affiliated entities: 121 at Oxford LLC, Lastrada Restaurant LLC, and 121 at BNA LLC (collectively, the "Companies" or "Plan Sponsors"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan. The assets of the Plan are maintained, and the transactions therein are executed, by Reliance Trust Company (the "Trustee").

**Eligibility**

The Plan is offered to all employees of the Companies who have attained the age of 21 and who have completed six months of service, as stipulated in the Plan Document. Eligible employees may enter the Plan once eligibility requirements are satisfied.

Participants are required to complete one year of service, as defined in the Plan Document, and attain the age of 21 in order to be eligible for employer safe harbor matching contributions and profit-sharing contributions, if any.

**Contributions**

The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they (a) affirmatively elect not to participate in the Plan or (b) complete a salary deferral agreement to elect an alternative deferral amount. Automatically enrolled participants have their pre-tax deferral rate set at 1% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Each year, participants may contribute an amount up to 90% of their annual eligible compensation as pre-tax and Roth (post-tax) deferral, up to the maximum allowed by the Internal Revenue Code ("IRC"), as defined in the Plan Document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, not to exceed IRC limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

**Note 1 Plan Description (continued)**

The Companies match 100% of the first 3% and 50% of the next 2% of the participants' elective deferrals as a safe-harbor matching contribution. Safe-harbor matching contributions during the year ended December 31, 2024 totaled \$896,707. Although not required, the Companies have the option of making discretionary profit-sharing contributions; no such contributions were made during the year ended December 31, 2024. Contributions are subject to certain IRC limitations.

**Participant Accounts**

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contribution, the Companies' contribution, an allocation of investment earnings or losses, and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their elective contributions, rollover contributions, and employer safe-harbor matching contributions. Vesting in the Plan Sponsors' discretionary profit-sharing contributions is based on the following schedule:

A participant is also fully vested upon reaching normal retirement age, upon death, or upon becoming totally and permanently disabled. Upon termination of employment, non-vested balances are accumulated in the Plan's forfeiture account.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. The maximum term of a note for general purpose may not exceed five years; however, if the loan is used for the purchase of a primary residence, the Plan administrator may permit a longer repayment term. Participants are allowed to have one outstanding note at any given time. Principal and interest are paid ratably through weekly payroll deductions. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1% (ranging from 4.25% to 9.50%), which is commensurate with local prevailing rates as determined by the Plan administrator.

**Excess Contributions Payable**

Excess contributions payable in the amount of \$95,365 was recorded at December 31, 2023 with a corresponding reduction in employer contributions. The amount represents excess contributions paid to the Plan by the Companies during 2023 and subsequently refunded.

**Note 1 Plan Description (continued)**

**Payment of Benefits**

Participants may receive all or a portion of their account balance if they terminate employment, become disabled, or reach the age of 59 1/2, or on account of financial hardship, as defined in the IRC. Benefits of \$5,000 or less are subject to involuntary cash-out as soon as administratively practicable after termination of employment.

**Forfeited Accounts**

Forfeited balances of terminated participants' non-vested accounts, if any, are used to reduce future Plan Sponsors' contributions or are applied to pay administration fees. At December 31, 2024 and 2023 forfeited accounts totaled \$10,050 and \$1,057, respectively. During the year ended December 31, 2024, forfeited non-vested accounts of \$2,931 were used to reduce the Plan Sponsors' contributions to the Plan.

**Note 2 Summary of Significant Accounting Policies**

**Basis of Presentation**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, those fees and operating expense are reflected in the net appreciation in fair value of investments.

**Note 2 Summary of Significant Accounting Policies (continued)**

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

**Note 3 Information Certified by the Plan's Trustee**

The following table summarizes investments and other assets information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by, or derived from, information prepared by Reliance Trust Company, the trustee of the Plan, and furnished to the Plan administrator. #### Note 4 Fair Value Measurement

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1 Inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Unobservable inputs based on the Plan's assessment of the assumptions that market participants would use in pricing the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 4 Fair Value Measurement (continued)**

- *Common collective trust:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets held by the fund less its liabilities, and then divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## Note 5 Party-In-Interest Transactions

Certain Plan investments are managed by Reliance Trust Company, the Trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

The Plan makes loans to participants and therefore, these transactions qualify as a party-in-interest transactions.

## Note 6 Plan Termination

Although they have not expressed any intent to do so, the Plan Sponsors have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances and the net assets of the Plan will be allocated as prescribed by ERISA and regulations pursuant thereto.

## Note 7 Tax Status

The Plan is an adoption of the ADP, LLC Pre-Approved Profit Sharing/Money Purchase/CODA (Cash or Deferred Arrangement) Plan for which the Internal Revenue Service has determined and informed ADP, LLC by an opinion letter dated October 6, 2020 that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## Note 8 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
