NOTE 1. DESCRIPTION OF THE PLAN

The following description of Fractal Analytics, Inc. Retirement Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

General:

The Plan is a defined contribution plan that was established on April 1, 2012 and restated on August 1, 2022 by Fractal Analytics, Inc. (“the Company”) and any participating Affiliates. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The following employers participate in the Plan as of December 31, 2024:

The Company is the Plan sponsor. The Plan administrator is the Committee appointed by the Employer Company. The Plan Committee manages the operation and administration of the Plan. The Company has contracted with Reliance Trust Company (Reliance) to act as the trustee, and a third-party administrator to process and maintain the records of the participant data.

Plan transfers:

For the year ended December 31, 2024, plan transfers reported in the statement of changes in net assets available for benefits to the Qure.AI Technologies Inc. 401(k) plan were \$68,247.

Eligibility:

Employees of the above-mentioned participating employers become eligible to participate in the Plan on the date of hire on the first day of the month coinciding with or next following their hire date. Employees excluded from the Plan are as follows:

- certain nonresident aliens who have no earned income from sources within United States
- employees who are residents of Puerto Rico

Contributions:

Participants may elect to defer up to 90% of pretax and Roth 401(k) of the annual eligible compensation, as defined in the Plan. The Plan allows for automatic enrollment for eligible employees except excluded participants as defined in plan documents, with an initial deferral rate of 3%, unless they affirmatively elect not to participate. Contributions are subject to regulatory limitations. The limit is \$23,000 for 2024. In

addition, participants aged 50 or older before the end of the Plan year, can make catch-up contributions. The catch-up dollar limit for 2024 is \$7500.

The Plan allows for an employer discretionary matching contribution and an employer discretionary nonelective contribution subject to certain eligibility requirements. Effective April 1, 2024, the Plan sponsor began providing an employer matching contribution. Under this provision, the employer matches 33% of participants' elective deferrals, up to 6% of eligible compensation, in accordance with the Plan's terms. In 2024, the Company made a matching contribution in the amount of \$530,768 of which \$2,918 was funded by forfeitures. No discretionary nonelective contribution was made for 2024.

Rollover:

Employees may roll over eligible amounts from other qualified retirement plans or rollover Individual Retirement Account (IRA) to the Plan. Employees can also rollover Roth contributions from another qualified plan to this Plan, but rollovers are not permitted from a Roth IRA.

Participant accounts:

Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution, plan earnings and losses, and plan expenses as applicable to the Plan. Allocations of plan earnings & losses are based on individual participant investment choices. All contributions/investments are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Certain investment and fund fees are charged to the funds and are included in plan investment income and losses and charged to participant accounts. Participants should refer to the funds' prospectuses for further information on these fees.

Vesting:

Participants are 100% vested in their contributions and rollover amounts plus actual earnings thereon. plus actual earnings thereon. . Vesting in the Company's discretionary matching and discretionary nonelective contributions and earnings is based on years of continuous service. Participants vests in the Company's contributions based on the following schedule:

Participants become fully vested in the event of death, disability or plan termination.

Investment:

The Plan provides for investments to be directed by participants into a number of investment options held by the Trustee. Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options and may change their investment options at any time.

Forfeitures:

Forfeitures are non-vested portion of participants' accounts that are lost upon termination of employment. Forfeited accounts can be used to pay plan expenses or reduce future employer contributions. As of December 31, 2024 and December 31, 2023 the forfeiture account balance was \$334 and \$315 respectively.

Payment of benefits:

Upon the satisfaction of certain distributable events, participants or their beneficiaries may elect to receive their vested account balance and are paid in accordance with plan provisions.

Notes receivable from participants:

Participants may borrow from their account a minimum of \$500 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Only two outstanding notes per participant is permitted at any given time. The notes are secured by the vested balance in the participant's account and bear interest at rates which are commensurate with prevailing rates as determined by the Plan Administrator. Notes receivable as of December 31, 2024 and 2023 carry an interest rate which range from 5.25% to 9.50%. Principal and interest are paid per the terms of the note and in accordance with Plan provisions. The notes must be repaid within a period of five years, unless the note is used to purchase a principal residence, in which case, the note must be repaid within a reasonable period of time not to exceed 30 years. The Plan Administrator establishes the specific terms and conditions of such notes.

Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting:

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

Reliance certifies the market value of all investments. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. If available, quoted market prices are used to value investments.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Common Collective Trust – Units held in common/collective trust (CCT) are valued using the NAV practical expedient of the CCT. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The CCT may be redeemed at NAV daily without restrictions.

See Note 5 for discussion of fair value measurements.

Contributions:

Contributions from plan participants and employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at December 31, 2024 or 2023.

Excess contributions payable:

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan is required to return contributions to participants in the event certain non-discrimination tests defined under the IRC are not satisfied. As of December 31, 2024 and 2023, there were no excess contributions payable.

Payment of benefits:

Benefits are recorded when paid.

Plan expenses:

In 2024, some fees related to the administration of the Plan were paid by the Company and these amounts are excluded from the Plan's financial statements. Investment/fund fees and participant transaction fees were charged to participant accounts as applicable.

NOTE 3. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, overall market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 4: CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, interest, dividends, net appreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

NOTE 5. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the standard are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Company / Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust - Investments held in a common/collective trust (CCT) are valued using the NAV practical expedient as reported by the CCT issuers. The NAV is based on the fair value of the underlying assets held by the CCT, less its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a CCT is calculated based on a compilation of primarily observable market inputs. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of its investments in a CCT, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations are carried out in an orderly manner.

NOTE 6: PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Plan investments are held by Reliance Trust Company. Any purchases and sales of these funds are performed in the open market at fair value or contract value. Plan related fees are paid to Reliance Trust Company and ADP, Inc. The Plan has other service providers. All these transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 7: INCOME TAX STATUS

The Plan adopted a non-standardized pre-approved plan which received an opinion letter dated October 6, 2020 from the IRS stating that the form of the plan is qualified under Section 401 of the Code and, therefore, the related trust is tax-exempt. The Plan has been amended since, however the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code (IRC) and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9: NONEXEMPT TRANSACTIONS

During the year 2023 certain participant contributions in the amount of \$10,000, were not deposited with the custodian on a timely basis, in accordance with the Department of Labor's Rules and Regulations, resulting in lost earnings (prohibited transaction amount). The Company estimated the amount of lost earnings to be \$239 as of December 31, 2023. This was shown as employer contribution receivable in the statement of net assets available for benefits as of December 31, 2023. In 2024, the Plan sponsor remitted \$239 to the Plan.

NOTE 10: SUBSEQUENT EVENTS
