### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Cohen, Seglias, Pallas, Greenhall & Furman, P.C. Profit Sharing 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. Description of Plan

The following description of the Cohen, Seglias, Pallas, Greenhall & Furman, P.C. Profit Sharing 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of Cohen, Seglias, Pallas, Greenhall & Furman, P.C. (the "Company") who have completed 90 days of service for deferrals and one year of service for employer match and discretionary contributions, and are age 21 or older. Interns, summer associates, leased employees, and collectively bargained employees are not eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The custodian and recordkeeper of the Plan is Lincoln Financial Group Trust Company, Inc. ("Lincoln").

#### *Contributions*

The Plan provides for the following categories of contributions:

- Salary reduction contributions – An employee may elect a reduction of up to 100% of pre-tax eligible compensation, not to exceed the federal limit set by law.
- Catch-up contributions – Employees aged 50 or older may elect to defer additional amounts to the Plan, subject to the federal limit set by law.
- Employer contributions – The employer may make matching contributions at the discretion of management, safe harbor matching contributions allocated to certain non-highly compensated employees at 3% of eligible compensation, and discretionary matching and profit sharing contributions to be allocated in accordance with group-based comparability allocation provisions. The Company made \$609,534 in profit sharing contributions, \$193,021 in safe harbor contributions, and \$267,859 in matching contributions for the year ended December 31, 2024. The various groups are defined by management pursuant to the Plan document.
- Rollover contributions – A participant may make a rollover contribution to the Plan of all or any portion of the entire amount which is an eligible rollover contribution from other qualified plans and certain Individual Retirement Accounts ("IRAs").
- Roth contributions – Employees electing to do so may contribute a portion of their after-tax earnings to the Plan, subject to the federal limit set by law.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation.

Participants direct the investment of participant and employer contributions into various investment options offered by the Plan.

**1. Description of Plan (continued)**

*Participant accounts*

Each participant's account is credited with the participant's contributions, Company matching contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are vested immediately in their contributions and the safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 3-year cliff of credited service for the discretionary matching contributions.

*Notes receivable from participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined annually, is set at the Prime rate plus 1%, as defined. Principal and interest are paid ratably through payroll deductions. Terms range from one month to five years or up to twenty years for the purchase of a primary residence.

*Payment of benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum payment. In addition, the Plan allows for hardship distributions if certain criteria are met.

Distributions of a terminated participant's vested account balance will occur as soon as administratively practicable after termination of employment.

*Forfeited accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$18,811 and \$9,425, respectively. These accounts may be used to reduce future Company contributions and to pay Plan expenses. During 2024, no amounts were applied to plan activities from forfeited nonvested accounts.

## 2. Summary of Significant Accounting Policies

### *Basis of Accounting*

The financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### *Use of Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized/unrealized appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

### *Payment of Benefits*

Benefits are recorded when paid.

#### *Expenses*

Certain expenses of incurred in the administration of the Plan are paid by the Company, and some are paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net realized/unrealized appreciation in fair value of investments.

### 3. Investment Certification

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Lincoln has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

### 4. Fair Value Measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for investment assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

**4. Fair Value Measurements (continued)**

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Changes in Fair Value Levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

## 5. Guaranteed Investment Contract with Insurance Company

In 2017, the Plan entered into a benefit-responsive guaranteed investment contract with Lincoln. Lincoln maintains the contributions in a general account. The contract is reported at contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. As of December 31, 2024 and 2023, total contract value was \$2,759,385 and \$2,864,450, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date unless 90 days' notice is given by either the Plan or Lincoln.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code;
2. Premature termination of the contracts;
3. Plan termination or merger;
4. Changes to the Plan's prohibition on competing investment options; or
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers that also would limit the ability of the Plan to transact at contract value with the participants.

### **6. Tax Status**

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Lincoln Retirement Services Company LLC. On June 30, 2020, the Internal Revenue Service (“IRS”) stated in an opinion letter that the prototype profit sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”) and, therefore, the related trust was exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **7. Related Party and Party-in-Interest Transactions**

Certain investments are shares of a stable value account managed by Lincoln and, therefore, transactions related to this investment qualify as party-in-interest transactions. Fees paid by the Plan to Lincoln related to contract administration were \$77,875 for the year ended December 31, 2024.

Fees incurred by the Plan for the investment management services are included in net realized/unrealized appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Lincoln receives revenue from investment fund service providers for services Lincoln provides to the funds. This revenue is used to offset certain amounts owed to Lincoln for its administrative services to the Plan. If the revenue received by Lincoln from such investment fund service providers exceeds the amount owed for its services, Lincoln remits the excess to the Plan’s trust on a quarterly basis. The Plan or Plan Sponsor may make a payment to Lincoln for administrative expenses not covered by revenue sharing. During 2024, \$36,002 (inclusive of net appreciation) was received from Lincoln and is reflected in net realized/unrealized appreciation in the statement of changes in net assets available for benefits, and \$22,500 was used to pay Plan investment advisory and management expenses. The account balance as of December 31, 2024 and 2023 was \$56,909 and \$43,407, respectively.

Additionally, the Plan issues loans to participants, which are secured by the participant’s account balances. These transactions qualify as party in interest transactions.

## **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks, as well as the risk related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments as of December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

## **9. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

## **10. Nonexempt Party-in-Interest Transaction**

During the year ended December 31, 2023, the Company failed to timely remit certain elective deferrals and loan repayments withheld from participants during one pay period to the Plan. The total amount of late remittances was \$55,992. Management of the Plan calculated lost earnings based on actual returns for the Plan during the period, which amounted to \$5,401 over the applicable period and a qualified nonelective contribution made to the impacted participants on February 2, 2024.

## **11. Plan Operations**

During the year ended December 31, 2024, it was discovered that certain of the Plan's provisions were not properly applied in the daily operation of the Plan. The definition of compensation for participant and employer contributions as per the Plan document was not properly applied when calculating contribution amounts. The Plan sponsor is in the process of correcting this error, including making any necessary adjustments to participant accounts and related contributions.

## **12. Subsequent Events**

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.
