Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The Ready Pac Foods, Inc. 401(k) Retirement Savings Plan (the “Plan”) is a defined contribution plan that covers all employees of Ready Pac Produce, Inc. (the “Company” and “Plan Sponsor”) and of employees of affiliated companies that are members of the same controlled group, other than non-resident aliens, leased employees and employees covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

THE PLAN DOCUMENT INCLUDES DETAILED RULES FOR EACH SITUATION. PARTICIPANTS AND OTHER INTERESTED PARTIES SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

A. Eligibility

A Company employee is eligible to participate in the Plan on the first day of the month coinciding with or next following date on which he or she has attained age 18 and completed 60 days of employment with the Company. Enrollment in the Plan and 3% deferrals are automatic upon satisfying age and service requirements, unless specifically waived by the employee.

B. Benefits

Benefits under the Plan begin when a participant retires, dies or ceases to be an employee, whichever applies. Normal retirement age is 65. After attaining age 59½ or upon total and permanent disability, a participant may elect to withdraw all or any portion of his or her vested account balance, subject to the rules and procedures established by the plan administrator. The Plan also allows hardship withdrawals under certain circumstances.

C. Vesting

A participant is fully vested immediately as to voluntary contributions, rollover contributions and related earnings. Company contributions are vested as follows:

D. Contributions

Participants may elect to defer from 1% to 70% of compensation, as defined in the Plan, subject to limitations set forth by the Internal Revenue Code (“IRC”). The Company may make matching and/or profit sharing contributions at its sole discretion. Profit sharing contributions, if any, are allocated to eligible participants’ accounts based on compensation. There were no matching contributions for the 2024 Plan year.

E. Notes Receivable from Participants

Loans are available to all participants on a reasonably equivalent basis. The minimum loan amount is \$1,000. The maximum a participant may borrow is the lesser of \$50,000, reduced by the highest outstanding loan balance in the previous 12-month period, or 50% of his or her vested account balance. The loan period is a maximum of 5 years (10 years for principal residence purchase) at the local prevailing commercial interest rate as determined by the plan administrator. Participants may only have one loan outstanding at any time. Loans must be repaid through payroll deductions. Notes receivable at December 31, 2024 carry interest rates ranging from 4.25% to 9.50% with maturities through November 2029.

F. Forfeitures

Forfeitures result from non-vested Company contributions of terminated employees. Forfeitures of \$122,342 and \$152,161 at December 31, 2024 and 2023, respectively, were available to offset Company contributions or pay administrative fees of the Plan. In 2024, forfeitures totaled \$127,604; \$140,000 were used to offset Company contributions and \$17,423 were used to pay administrative fees of the Plan.

G. Administrative Expenses

The Plan pays most administrative expenses, either from forfeitures or from participants' accounts. Investment returns are reported net of investment expenses. Direct expenses paid by the Plan in 2024 were as follows:

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

The participants select how their share of plan assets will be invested among those investment vehicles made available. Participants may change their investment options at any time during the Plan year.

C. Investment Valuation and Income Recognition (Continued)

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability. The following tables set forth Plan investments measured at fair value based on the inputs used to value them at December 31:

Shares may be redeemed at any time at net asset value. There are no restrictions on redemptions and no unfunded commitments to purchase additional shares. D. Risks and Uncertainties

The Plan utilizes various investments, which in general are exposed to various risks, such as interest rate, market, and credit risks. Due to the risk associated with investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

NOTE 3 - INCOME TAX STATUS

The Company adopted a prototype plan that has received an advisory letter from the Internal Revenue Service stating that the form of the Plan qualifies under applicable requirements of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. No provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - PLAN TERMINATION

The Company reserves the right to terminate the Plan. In the event of termination of the Plan, participants' accounts shall become 100% vested. No money shall be returned to the Company. Upon termination, the Company will elect either to maintain the trust created by the Plan to make benefit payments, or liquidate Plan assets to distribute them to participants in accordance with the provisions of ERISA.

NOTE 5 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 6 - RELATED PARTY TRANSACTIONS

Fidelity Management Trust Company or related entities provide investment options offered under the Plan. Transactions in these investments, while considered party in interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party in interest transactions under ERISA.
