### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mainsail Property Management 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investments information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. ### Note 1—Description of the Plan

The following is a summary of major provisions of the Mainsail Property Management 401(k) Plan (the "Plan"). Participants should refer to the Plan document for more complete information.

*Plan Description* – The Plan was established by Mainsail Property Management, LLC (the "Company" or "Plan Sponsor") as a defined contribution plan effective January 1, 2006 and was amended and restated January 1, 2025. There were no changes in Plan provisions as a result of the restatement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

*Participation* – All employees of the Company who have completed at least six months of service and worked 500 hours may participate in the Plan. The Plan provides for entry dates as of the first day of each month, following a participant's eligibility date. Participants are eligible for employer matching contributions upon entry into the Plan.

*Contributions* – The Plan provides for participant salary deferrals up to 90% of the employees' annual compensation, safe harbor matching contributions, and discretionary employer matching contributions. Participants may contribute the maximum allowed under Section 402(g) of the Internal Revenue Code ("IRC"). Participants who have attained the age of 50 are eligible to make pre-tax catch-up contributions, subject to certain limitations. In addition, the Plan accepts rollovers from other tax-qualified plans. The Company has elected to make a safe harbor contribution equal to 100% of the first 3% of participant contributions plus 50% of the next 2% of participant contributions up to 5% of eligible compensation, as defined by the Plan document. Safe harbor matching contributions made to the Plan totaled approximately \$675,000 during the year ended December 31, 2024. There were no additional employer discretionary matching contributions during 2024.

*Participant Accounts* – Each participant's account is adjusted for the participant's contributions, employer safe harbor matching contributions, discretionary employer matching contributions (if any), an allocation of Plan earnings or losses, a portion of the administrative expenses, and any distributions to the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting* – Participants are immediately vested in their participant salary deferrals, employer safe harbor matching contributions, and rollovers, plus actual earnings or losses thereon. Discretionary employer matching contributions (if any) vest based on the schedule below:

1 year	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years or more	100%

On termination of service due to death and total and permanent disability, as defined by the Plan, a participant shall become 100% vested in their entire account balance.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loans are permitted for a term of up to five years or up to 30 years if used to purchase a primary residence. The notes are secured by the balance in the participant's account and bear interest at local prevailing rates as determined at the time the note is made. Interest rates on loans outstanding as of December 31, 2024 ranged from 4.11% to 9.5% and the loans mature at various dates through August 2039. Principal and interest payments are paid ratably through payroll deductions.

### Note 1—Description of the Plan (continued)

*Payment of Benefits* – Upon termination, retirement, death, or disability, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s account, a life annuity, or annual installments paid over a ten-year period. For termination of service for other reasons, the participant may receive the value of his or her account as a lump-sum distribution.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting.

*Investments, Investment Valuation, and Income Recognition* – Investments are reported at fair value, except for its fully benefit-responsive investment contract, which is valued at contract value (see Note 7). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value determinations are made based upon a hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 investments).

Three levels of inputs that may be used to measure fair value:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value.

*Mutual Funds* – These public investment vehicles are valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is classified within Level 1 of the valuation hierarchy based on the underlying assets of the account, which are traded on an active market.

*Common Collective Investment Trusts* – These are investment vehicles valued using NAV provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is classified within Level 2 of the valuation hierarchy because NAV’s unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments, most of which are traded on an active market and the balance of which are valued using their net asset value as a practical expedient.

### **Note 2—Summary of significant accounting policies (continued)**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought, sold, and held during the year.

*Contribution Receivable* – The amounts of participant-related contributions that have been deducted from the participant's payroll as of the end of the year but have not been deposited with the Plan until after the end of the year is reflected as participant contributions receivable in the Plan's financial statements. In addition, any contributions due and payable by the Company are reflected as Company contributions receivable in the Plan's financial statements.

*Benefits Paid to Participants* – Benefits are recorded when processed and paid by the Plan.

*Notes Receivables from Participants* – Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes receivable are reclassified as deemed distributions based upon the terms of the Plan document.

*Accounting Estimates* – The preparation of the financial statements in accordance with generally accepted accounting principles in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements, and the reported amounts of revenue and expenses during the reporting period. Actual results may vary from those estimates.

### **Note 3—Information certified by the qualified institution (unaudited)**

The Plan administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company ("qualified institution"), has certified that the following information is complete and accurate:

- Total investments and notes receivable from participants as reflected in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the certified information, except for comparing such information with the related information in the financial statements and supplemental schedules.

**Note 5—Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Employer contribution portion of their account.

**Note 6—Income tax status**

The Plan had adopted the Automatic Data Processing Defined Contribution Plan Basic Plan Document #1, which received a favorable opinion letter from the IRS on October 6, 2020, which stated the Plan and related trust were designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 7—Full Benefit-Responsive contract**

The Plan has invested in investment contracts through Invesco, Ltd. These investment contracts allow participants to invest in the Invesco Stable Asset Fund. The primary investment objective of the Invesco Stable Asset Fund is to be a long-term investment for participants seeking stability of principal.

The Invesco Stable Asset Fund have been determined to be fully benefit-responsive. As a result of these contracts being fully benefit-responsive, the contract value is the relevant measurement for that portion of the net assets available for benefits attributable to these investment contracts. Contract value, as reported to the Plan by the Trustee, represents contributions made under the contracts, plus or minus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

### **Note 8—Party-in-interest transactions**

Notes receivable from participants are considered to be party-in-interest transactions because they are transacted with Plan participants. While these transactions qualify as party-in-interest activity, they are expressly exempted from the prohibited transaction rules (ERISA, Title I, Section 408(b)). Administrative fees paid by the Plan during the year ended December 31, 2024 for professional services rendered by parties in interest were based on customary and reasonable rates.

### **Note 9—Risks and uncertainties**

The Plan provides for investment options in various investment securities. Investment securities, in general, are exposed to certain risks, such as interest rate, market, and credit. Due to the level of risk associated with investment securities and the level of uncertainty related to the changes in their value, it is at least reasonably possible that changes in fair value of investment securities in the near future could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

As the values of the Plan's individual investments have and will fluctuate in response to changing market conditions, the amount of potential losses that will be recognized in subsequent periods, if any, cannot be determined.

### **Note 10—Administrative expenses**

Administrative expenses are comprised primarily of investment fees and are paid by the Plan. Additionally, certain professional fees incurred on behalf of the Plan are paid by the Plan Sponsor.

### **Note 11—Subsequent events**

Management has evaluated subsequent events through October 13, 2025, in connection with the preparation of these financial statements, which is the date the financial statements were available to be issued.
