We have performed an audit of the financial statements of the Summit 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – SUMMARY OF THE PLAN

Plan Description

The following description of the Summit 401(k) Plan, formerly known as the APT/KCA 401(K) Plan, (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was effective on March 1, 1997 and qualifies as a defined contribution retirement Plan for KCA Electronics, Inc. and APT Electronics, Inc. In April 2016, the KCA Electronics, Inc. merged with Marcel Electronics International and formed Summit Interconnect, Inc. In July 2016, APT Electronics, Inc. ceased participating in the Plan. On December 7, 2018, Summit Interconnect, Inc. acquired Streamline Circuits Inc., a leading manufacturer of high-quality printed circuit boards. On July 31, 2019, Streamline Circuit’s 401(k) plan was terminated and allowed their participants to begin participating in the Plan on August 1, 2019. For the years ended December 31, 2024 and 2023, Summit Interconnect, Inc. (the “Company”) is the Plan sponsor. This Plan was established for the purpose of providing retirement benefits to eligible employees in accordance with the Plan. The Plan is intended to satisfy the provisions of Section 401(a) of the Internal Revenue Code (“IRC”) of 1986, as amended. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration

The Plan is administered by the Company. Fidelity Management Trust Company (“Fidelity”) is the trustee and assets custodian of the Plan.

Participant Eligibility

Each of the Company’s employees is eligible to participate in the 401(k) Plan if they have completed 3 months of service and attained age 21. Once the eligibility requirements have been met, employees may enroll in the Plan on the first day of the next month. Employees are eligible to receive matching contributions if they make 401(k) deferrals. In order to be eligible for the discretionary employer contributions the employee must have completed 1,000 hours of service during the Plan year and be employed on the last day of the Plan year.

Contributions

The Company’s eligible employees may contribute up to the 402(g) limit and/or the Actual Deferral Percentage (ADP) test limit for highly compensated employees. The 402(g) limit for 2024 was \$23,000. In addition, all eligible employees who have attained age 50 before the close of the Plan year are eligible to make catch-up contributions of up to \$7,500 in accordance with, and subject to the limitations of Code Section 414(v).

Contributions (Continued)

The company has elected to make safe Harbor matching contributions starting January 1, 2022 to all eligible Participants in an amount equal to 100% of the first three percent of their eligible compensation, and 50% of the next two percent of their eligible compensation, contributed to the Plan as Deferral Contributions (computed by the company based on the employee's eligible compensation contributed to the Plan each payroll period). For the year ended December 31, 2024, the Company made Safe Harbor contributions amounting to \$1,280,675 to the Plan.

During the plan year ended December 31, 2024, the Plan Sponsor identified a remittance error in which certain eligible participants did not receive timely elective deferral contributions for a specific pay period.

The Plan Sponsor intends to make Qualified Non-Elective Contributions (QNECs) to the affected participants' accounts. The QNECs will compensate participants for missed deferrals and related earnings. A QNEC amount of \$14,740 has been recorded as an employer contribution receivable in the statement of assets for the year ended December 31, 2024.

The Company may make a discretionary matching and/or profit-sharing contributions equal to an amount determined by the Company to eligible employees. There were no discretionary contributions made in fiscal year ended December 31, 2024.

Investment of Plan Funds

A participant may invest his or her respective share of all employee and employer contributions into any of the investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's allocation of (a) the Company's matching contribution, (b) the Company's discretionary profit-sharing contribution, (c) the participant's contribution, (d) the Company's Safe Harbor match contribution and, (e) Plan earnings.

Allocation of Investment Activity

The net increase or decrease in such values resulting from fund income and allocated expenses, if any, are apportioned to each participant's account in proportion to the value of the participant's account as compared to the investment fund as a whole.

Vesting

Participants are one hundred percent (100%) vested in their contributions and 100% vested in their respective safe harbor contributions, and any rollover contributions for employer matching contributions, qualified matching contributions, qualified nonelective contributions and any earnings thereon as follows:

Forfeitures

Amounts forfeited from terminating participants' non-vested portion of their Company matching contribution and discretionary profit-sharing contribution account and earnings on Company contributions are used first to reduce administrative expenses, then to reduce matching and discretionary profit-sharing contributions. There were no forfeitures of non-vested accounts as of December 31, 2024 and 2023 that are included in the cash accounts.

Payment of Benefits

Retired or terminated participants receive the vested portion of their Company contributions and earnings on their Company contributions and one hundred percent (100%) of their pre-tax contribution as soon as administratively possible following retirement, termination or upon becoming disabled.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half of the participant's vested account balance, \$50,000, or the limitations set by the Tax Reform Act of 1986 and Section 408(b) of ERISA. The notes are to be repaid through payroll withholding over a period of five years or longer if the loan is used to acquire a principal residence under hardship circumstances.

Hardship Distributions

A participant may elect a hardship distribution if it is deemed that the participant has an immediate and heavy financial need as described by the Plan. Any hardship withdrawals made prior to the participant attaining age 59½ will be subject to the applicable federal and states taxes and/or penalties.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

SECURE Act 2.0 Provisions

In December 2022, the Securing a Strong Retirement Act of 2022 (“SECURE Act 2.0”) was enacted, introducing a broad array of mandatory and optional provisions. These changes are intended to enhance retirement savings opportunities, simplify plan administration, and improve participant outcomes. Participants are encouraged to review the updated Summary Plan Description and contact the Plan Administrator with any questions regarding how these changes may affect their benefits. Plan management continues to evaluate key SECURE 2.0 provisions and assess implementation of applicable optional and mandatory requirements. No provisions of the Act materially impacted the Plan's financial position, changes in net assets available for benefits, or related disclosures as of or for the year ended December 31, 2024.

Basis of Accounting

The financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America (“GAAP”) and in accordance with the Plan agreement.

Accounting Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Non-Discrimination for Employee and Employer Contributions

The Plan, as required by the IRC, performs annual tests between highly compensated participants versus non-highly compensated participants to ensure that highly compensated participants are not disproportionately favored under the Plan. If the Plan fails the tests, it must refund excess deferral contributions or make a Qualified Non-Election Contribution (“QNEC”) for the non-highly compensated employees. Excess contributions that are refunded within two and a half months of the Plan year end are accrued as a liability on the statement of net assets available for benefits.

Administrative Expenses

Plan administrative expenses are paid by the Plan, unless paid by the Company.

Payment of Benefits

The Plan does not accrue non-distributed benefits related to participants who have withdrawn from the Plan but recognizes such benefits as a deduction from net assets in the period in which such benefits are paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There has been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds are held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded and are classified as level 1 investments.

Investment Valuation and Income Recognition (Continued)

Money Market Funds

These investments have an object to earn interest for shareholders while maintaining a NAV of \$1 per share. The portfolio comprises short-term, or less than one year, securities representing high-quality, liquid debt and monetary instruments.

The money market funds held by the Plan are deemed to be actively traded and are classified as level 1 investments.

The Plan's investments (including investments bought, sold and held during the year) appreciated by \$1,575,961 for the year ended December 31, 2024.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. The current interest rates on existing loans range from 5.25% to 10.50%.

NOTE 3 – INFORMATION CERTIFIED BY THE PLAN CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. All of the information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity, the trustee/custodian of the Plan.

NOTE 4 – INCOME TAX STATUS

The Internal Revenue Service issued a favorable opinion in a letter dated June 30, 2020 that stated that the Volume Submitter Profit Sharing Plan adopted by the Company, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has since been amended and restated. The trustee/custodian, Plan sponsor, and Plan administrator are not aware of any course of action or series of events that have occurred that would adversely affect the qualified status of the Plan. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination participants will become one hundred percent (100%) vested in their accounts.

NOTE 6 – PARTY IN INTEREST TRANSACTIONS

For the plan year ended December 31, 2024, all Plan investments were managed by Fidelity, the trustee of the Plan, and therefore, these transactions qualified as party-in-interest transactions. For the year ended December 31, 2023, fees paid by the Plan to Fidelity for the contract administration services amounted to \$22,124. All party-in-interest transactions qualify for statutory exemptions.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invested in various investment securities in 2024. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
