INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor
Goodwill Industries of Kanawha Valley 401(k) Plan
Charleston, West Virginia

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Goodwill Industries of Kanawha Valley 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

1 – DESCRIPTION OF PLAN AND SIGNIFICANT ACCOUNTING POLICIES

Plan Description

The following description of the Goodwill Industries of Kanawha Valley 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for more complete information.

General

The Plan, established July 1, 2014, is a defined contribution 401(k) plan available to all non-temporary, non-client employees of Goodwill Industries of Kanawha Valley, Inc. (the Plan Sponsor), who complete 1 hour of service within the 6-month period following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Significant accounting policies and estimates

The accounting and reporting policies of the Plan conform to the accrual basis of accounting and to general practices within the employee benefit plan industry.

The financial statements of the Plan are prepared on the accrual basis of accounting.

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Each year, participants may contribute up to the maximum allowable amount as permitted by the Internal Revenue Code. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan also permits participants to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1 percent of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The Plan Sponsor will make a safe harbor employer matching contribution to the Plan equal to 100 percent of the Participant's elective deferrals, including catch-up contributions, that do not exceed 3 percent of the Participant's compensation, and 50 percent of the amount of the Participant's elective deferral that exceeds 3 percent of the Participant's compensation but that do not exceed 5 percent of the Participant's compensation. In no event shall the safe-harbor contribution exceed 4 percent of a Participant's compensation. The Plan Sponsor contributed \$169,695 to the Plan in 2024 and \$132,125 in 2023. Contributions are subject to certain IRS limitations.

Participant investment options

Each participant has the right to direct all contributions and earnings thereon among alternative investment options made available by the Plan Sponsor under the Plan. Participants should refer to the most recent annual report and prospectus of each mutual fund for information on risk factors, asset concentrations, investment objectives and other financial data. Participants may transfer funds between investment options at any time.

Participant accounts

Each participant account is credited with the participant's elective contributions and contributions by the Plan Sponsor. In addition, each participant's account is credited with the specific earnings (losses) of the investments owned in self-directed participant accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

The Plan provides for immediate vesting of salary reduction contributions and earnings thereon and any safe harbor contributions. In connection with any profit sharing contributions, the Plan provides for a six-year vesting schedule, as shown below:

Forfeiture accounts

These accounts will be used to pay for administrative expenses or reduce future employer contributions.

Payment of benefits

Upon retirement (normal retirement age is 59 ½ for this Plan), death, disability or other termination of employment, as defined in the Plan document, participants or their

spouses and/or beneficiaries will receive their account as a lump sum cash payment. Further, upon termination of employment, the participant may elect to transfer his or her vested account balances to another qualified plan or individual retirement account. If the vested account of a participant is greater than \$1,000 but less than \$5,000, and the participant has not provided the Plan with timely instructions as to the distribution of their vested balance, a direct rollover to an Individual Retirement Account or Annuity will be made at the discretion of the Plan Sponsor. If a participants' vested account balance is less than \$5,000 and written instructions are not received by the Plan, participants will automatically receive a check representing their vested balance, less applicable taxes.

The Plan does not allow for hardship withdrawals and benefits are recorded when paid.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2 – RELATED PARTY TRANSACTIONS AND INVESTMENT ADMINISTRATION

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Plan Sponsor, and certain others. During the year ending December 31, 2024, transactions with parties-in-interest primarily included certain administrative functions performed by employees of the Plan Sponsor at no cost to the Plan. The Plan Sponsor pays substantially all administrative fees for the Plan and certain investments of the Plan include accounts invested with the Custodian.

3 – INFORMATION CERTIFIED BY CUSTODIAN

All investment information disclosed in the accompanying financial statements, including investments held at December 31, 2024 and 2023 and investment income (loss), which includes net appreciation (depreciation), were obtained and derived from information supplied to the Plan Sponsor and certified as complete and accurate by the custodian.

4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or

liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has ability to access.

Level 2: Inputs to valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the closing price reported on the active market on which the mutual funds are traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

Collective Investment Trust: Valued at NAV. The NAV, as provided by the Custodian is based on the fair value of the underlying investments held by the fund less its liabilities.

5 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

7 – TAX STATUS

The Internal Revenue Service has determined and informed the Organization by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

8 – SUBSEQUENT EVENTS
