## INDEPENDENT AUDITOR'S REPORT

The Plan Administrator of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Access Clinical Partners, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### NOTES TO THE FINANCIAL STATEMENTS

#### NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Access Clinical Partners, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

**General**—The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Access Clinical Partners, LLC, and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Access Clinical Partners, LLC (the Company) is the Plan’s sponsor and serves as plan administrator.

**Eligibility**—Employees of the Company are eligible to participate in the Plan upon reaching age 21 and after completing one consecutive month of service, and enter on January 1 or July 1 of the Plan year. Participants must complete at least one consecutive month of service during the Plan year to be eligible to receive any employer paid profit sharing contributions.

#### **Contributions**

**Participant Contributions**—Each year, participants may contribute between 1–100% of pre-tax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

**Profit Sharing Contributions**—The Company may elect to make profit sharing contributions to the Plan. Profit sharing contributions are allocated to participants in the same proportion as a participant’s compensation bears to the total of all participants’ compensation. In order to share in the allocation of profit sharing contributions, a participant is required to complete 500 hours of service in the applicable plan year. There were no profit sharing contributions for the year ended December 31, 2024.

**Employer Safe Harbor**—The Company also makes safe harbor matching contributions equal to 100% of employee contributions for the first 3% of employee compensation plus 50% of employee contributions for the next 2% of employee compensation, regardless of the employee’s hours of service or employment on the last day of the Plan year. Safe harbor contributions for the year ended December 31, 2024 were \$3,668,226.

Contributions are subject to regulatory limitations.

**Participant Accounts**—Each participant’s account is credited with the participant’s contributions and Company safe harbor contributions as well as allocations of the Company’s profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**—Participants are vested immediately in their contributions and employer safe harbor contributions plus actual earnings thereon. Vesting in the Company’s profit-sharing contribution portion

of their accounts is based on years of continuous service. Participants vest in the Company's profit sharing contributions based on the following schedule:

**Notes Receivable from Participants**—Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a dwelling unit, in which case, the loan must be repaid within a reasonable period of time not to exceed 30 years. Under the terms of the Plan Agreement, Plan loans will bear a rate of interest of the prime rate as published by the Wall Street Journal plus 1%. Principal and interest is paid ratably through semi-monthly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.5% with various maturities through July 2052.

**Payment of Benefits**—On termination of service from the Company, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Upon termination, vested account balances less than \$5,000 will be automatically distributed in a lump sum.

**Change in Trustee** – Effective October 1, 2024, a new trustee was appointed. Plan assets transferred to the new trustee, Fidelity Management Trust Company were transferred into funds comparable to those offered by the previous trustee, Delaware Charter Guarantee & Trust Company DBA Principal Trust Company (Principal Trust Company). The conversion initiated a blackout period beginning September 19, 2024, and continuing through November 3, 2024. During the blackout period, funds could not be applied to employee-selected funds with the new trustee or withdrawn from the Plan until the trustee had time to accurately complete the conversion. During the period, employee contributions continued to be made through payroll deductions, and the contributions were deposited and held in the income fund until the completion of the blackout period. At the end of the blackout period, these funds were transferred to the investment options requested by each participant.

The financial statements and accompanying notes present information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedules that were prepared by or derived from information prepared by Fidelity Management Trust Company, the trustee of the Plan as of December 31, 2024 and for the period October 1, 2024 to December 31, 2024, and Principal Trust Company, the trustee of the Plan as of December 31, 2023 and for the period January 1, 2024 to September 30, 2024, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustees that such information is complete and accurate.

## **NOTE 2. BASIS OF PRESENTATION AND RECENT ACCOUNTING PRONOUNCEMENTS**

**Basis of Accounting**—The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

**Use of Estimates**—The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation**—The investments are reported at contract value and fair value. The Plan’s trustee, Fidelity Management Trust Company, certifies the contract value of the guaranteed investment contract and the fair value of all other investments. If available, quoted market prices are used to value investments.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

**Income Recognition**—Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Notes Receivable from Participants**—Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement.

**Payment of Benefits**—Benefits are recorded when paid.

**Administrative Expenses**—Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan from participants may include notes receivable and distribution fees charged to participants’ accounts and administrative Plan fees. Investment related expenses are included in net appreciation in fair value of investments.

### NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1**—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

**Level 2**—Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3**—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024, and 2023.

**Registered Investment Companies (Mutual Funds)**—Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

**Pooled Separate Accounts**—Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

**Collective Trusts**—Units held in collective trusts (CT) are valued using the NAV practical expedient of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 4. GUARANTEED INVESTMENT CONTRACT

In 2007, the Plan entered into a fully benefit-responsive investment contract (FBRIC) with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a semi-annual basis for resetting. The FBRIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the FBRIC criteria and, therefore, is reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are

probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

On September 20, 2023, the Plan notified the trustee that it intended to terminate the Plan's interest in the Principle Fixed Income Guaranteed Option group annuity contract as of September 20, 2024 to avoid a surrender charge. Subsequent to this notification, the decision was made to change trustee from Principal Trust Company to Fidelity Management Trust Company as of October 1, 2024. The Principal Fixed Income Guaranteed Option was terminated on October 1, 2024 with the transfer of the recordkeeping to Fidelity Management Trust Company.

#### **NOTE 5. TAX STATUS**

The Plan document is a prototype standardized defined contribution plan that received a favorable opinion letter from the Internal Revenue Service dated on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

#### **NOTE 6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across a variety of participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into a variety of financial instruments. Investment decisions are made, and the resulting risks are borne, exclusively by the Plan participants who made such decisions.

#### **NOTE 7. INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, and Principal Trust Company, the former trustee, have certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments and notes receivables from participants reflected in the Schedule H, Line 4i – Schedule of assets (held at end of year) as of December 31, 2024.
- All investment balances and investment information, excluding the classification and level of investments, as shown in Note 3, Fair Value Measurements as of December 31, 2024, and 2023.

**NOTE 8. PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by Fidelity Investments. Fidelity Management Trust Company is the trustee of the Plan and an affiliate of Fidelity Investments and, therefore, transactions with these entities qualify as exempt party-in-interest transactions. Fees paid for investment management services on such investments were included as a reduction of the return earned on each fund.

The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts.

**NOTE 9. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

**NOTE 10. NONEXEMPT TRANSACTIONS**

In the prior years, the Company remitted certain participant contributions in the aggregate amount of \$443,878 to the trustee later than required by Department of Labor (DOL) Regulation 2510.3 102. The Company has filed Forms 5330 with the IRS for the affected plan years and paid the required excise taxes on the transactions. In addition, participant accounts have been credited with the amount of investment income that would have been earned had the participant contributions been remitted on a timely basis.

**NOTE 11. SUBSEQUENT EVENTS**

Subsequent events were evaluated through October 15, 2025, the date the financial statements were issued.
