INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Majority Strategies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Notes to Financial Statements

1. Summary Plan Description:

The following description of the Majority Strategies 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective January 1, 2024, for the benefit of eligible employees of Majority Strategies, LLC. Prior to the establishment of the Plan, eligible employees participated in a multiple employer plan. As of January 1, 2024, participant account balances and related obligations attributable to the Company were transferred from the multiple employer plan into this newly established single-employer plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

Employees who are age 20 or older are eligible to participate in the Plan, except nonresident aliens, leased employee and members of a specific union. Eligible employees may enroll immediately following the date the employee satisfies the Plan’s eligibility requirements.

Contributions

Participants may elect to defer, subject to IRS limits, up to 90% of their annual eligible compensation. In addition, employees who have attained age 50 by the end of the Plan year may make catch-up contributions up to limits defined by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company makes a safe harbor matching contribution equal to 100% of a participant’s contribution up to 3% of eligible compensation plus 50% of the participant’s contributions over 3% of eligible compensation up to 5%, subject to certain Plan limitations. The Company may also make additional discretionary nonelective contributions to the Plan. These contributions are allocated using a pro rata formula which is based on the ratio of the participant’s qualifying compensation in relation to total compensation of all qualifying participants. No discretionary nonelective contributions were made in 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, allocations of Company contributions, and participant earnings. Participant earnings are based on an allocation of Plan earnings respective to each participant’s account balances and investment selections. Any related administrative expenses based on participant earnings or account balances are deducted from the participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance

Investments

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and common collective trusts as investment options for participants.

1. Summary Plan Description (Continued):

Notes Receivable from Participants

Participants are permitted 2 outstanding loans at a time. Participants may borrow a minimum of \$1,000, up to 50% of their vested contributions and related earnings, not to exceed \$50,000. Loans are secured by the balance in the participant's account and must be repaid in level payments through payroll deductions within a five-year period, except for loans for the purchase of a principal residence which may be repaid over a reasonable period of time not to exceed a maximum of 30 years. Generally, notes receivable from participants include interest at 1% above the prime rate.

Payment of Benefits

The entire vested balance in an individual participant's account, shall be payable to the participant, upon the election of the participant, upon retirement at or after age 65, upon determination of total and permanent disability, or to the participant's beneficiary in the event of death. Additionally, hardship withdrawals and certain other in-service withdrawals are also permitted by the Plan if certain criteria are met. Participants may elect to receive an in-service distribution after attaining the age of 59 ½. Account balances that are under \$5,000 may be automatically distributed upon termination of service as a lump sum without the consent of the participant.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon, as well as Company safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary nonelective contributions is based on the following table:

Administrative Expenses

In accordance with Plan provisions, the Company or the Plan may pay administrative expenses of the Plan. Administrative expenses paid by the Plan for trustee, recordkeeping and investment advisory services are allocated to participants proportionally based on the value of their account balances. Administrative expenses recorded in the Plan pertaining to loan transaction fees are deducted directly from the applicable participant's account.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

1. Summary Plan Description (Continued):

Forfeited Accounts

Forfeitures from non-vested participant accounts are used to reduce future Company contributions and to pay Plan expenses. As of December 31, 2024, forfeited non-vested accounts held to be used in the future totaled \$0. During 2024, no forfeitures were used to reduce Company contributions or pay Plan expenses.

2. Summary of Accounting Policies:

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts reported in the financial statements and the accompanying notes. Actual results could differ from those estimates.

Income Valuation and Income Recognition

Investments of the Plan are presented at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Realized gains and losses on the sales of securities are reported on the average cost method.

Notes Receivable from Participants

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributed based upon the terms of the Plan document. The loans are secured by the balance in the participants’ accounts

Payment of Benefits

Benefits are recorded when paid.

2. Summary of Accounting Policies (Continued):

Risks and Uncertainties

The Plan provides for various investment securities which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

3. Fair Value Measurements:

The Financial Accounting Standards Board, Accounting Standards Codification Topic 820 (ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: Mutual funds are valued at quoted market prices on nationally recognized security exchanges (Level 1 inputs).

Common/Collective Trusts: The investments in the common collective trusts are valued at the net asset value (NAV) of units held by the Plan at year end. The NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund. NAV is used as a practical expedient to estimate fair value. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Income Tax Status:

The Internal Revenue Service has determined and informed the Organization by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Service.

Management evaluated the Plan's tax positions and concluded that as of December 31, 2024, the Plan had taken no uncertain tax positions that require recognition of a liability (or asset) in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for tax years before 2021.

6. Party-In-Interest Transactions:

ADP, LLC (“ADP”) provides recordkeeping services to the Plan and is considered a party in-interest to the Plan. Fees paid by the Plan to ADP for transaction fees charged to participants amounted to \$26,214 for the year ended December 31, 2024.

Reliance Trust Company (“Reliance”) is the trustee and custodian of the Plan, therefore, transactions involving managed investments qualify as party-in-interest transactions. Reliance is considered parties in-interest to the Plan.

Included in the Plan assets are notes receivable from participants. At December 31, 2024, notes receivable from participants amounted to \$78,923, respectively. For the year ended December 31, 2024, interest income related to notes receivable from participants amounted to \$3,482. These transactions qualify as party-in-interest transactions permitted under provisions of ERISA.

7. Plan Termination:

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100 percent vested in their accounts.

8. Subsequent Events:

Effective January 1, 2025, the Plan was amended to implement an automatic enrollment feature whereby eligible employees are automatically enrolled at a deferral rate of 3% of eligible compensation. The amendment also includes an automatic annual escalation of 1%, up to a maximum deferral rate of 10% of eligible compensation. However, effective November 1, 2025, the automatic enrollment feature was discontinued.

Effective January 1, 2025, ADP Retirement Trust Services, LLC was appointed as the Plan’s trustee upon the resignation of Reliance Trust Company.

Management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be filed and has determined that, except as disclosed above, there were no material events requiring recognition or disclosure
