## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Code for America 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Code for America 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1 - Description of plan

#### General

Effective July 13, 2022, Code for America Labs, Inc. (the "Plan Administrator", or "Plan Sponsor", or "Company") adopted a defined contribution 401(k) plan (the "Plan") covering all eligible employees of the Company. The Plan excludes non-resident aliens, residents of Puerto Rico, and part-time, temporary, or seasonal employees whose regularly scheduled service is less than 1,000 hours of service in the relevant eligibility computation period.

The following description of the Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Administration

The Company has appointed an Administrative Committee (the "Committee") to manage the operations and administration of the Plan.

The Company contracted with Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively referred to as "Empower") to act as the Plan custodian and trustee.

The Company has adopted a non-standardized pre-approved plan and appointed Empower as the Plan's third-party administrator for processing transactions, maintaining the records of participant accounts, and monitoring compliance with governmental regulatory requirements.

#### Contributions

Each year, participants may contribute up to 50% of their plan year compensation as defined in the Plan Document. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan Document also permits Roth 401(k) contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers investments in mutual funds and common collective trust funds to its participants. As part of a collective bargaining agreement, effective October 2023, the Company changed its discretionary matching contributions to 100% of employee contributions up to 3% of compensation for all eligible participants, and 50% of employee contributions over 3%, up to 5% of compensation for eligible participants who have attained 3 years of service. Prior to October 2023, the Company matched 100% of employee contributions up to 3% of eligible compensation. The Company's discretionary matching contributions for the years ended December 31, 2024 and December 31, 2023 were \$733,135 and \$693,078, respectively. Contributions are subject to certain IRS limitations.

### Note 1 - Description of plan (continued)

#### Participant accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions and the Company's matching contributions plus actual earnings thereon.

#### Notes receivable from participants

A participant may have a maximum of one loan outstanding at any time. Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The limit of \$50,000 is reduced by the highest outstanding balance of any previous loan. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. The interest rate for loans outstanding at December 31, 2024 ranged from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the Company. Loan terms typically range up to five years or may exceed five years for the purchase of a primary residence. Principal and interest are paid ratably through semi-monthly payroll deductions.

#### Payment of benefits

Upon reaching the age of 65 and at the discretion of the participant or upon termination of service due to death, disability, or retirement, a participant or the designated beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in partial payments.

Upon termination before reaching the normal retirement age, if the participant's or beneficiary's vested account balance is \$7,000 or less, the Plan will distribute the amount to an Individual Retirement Account ("IRA") for the participant's benefit. If the vested account balance exceeds \$7,000, the participant can request to receive the balance in a single lump-sum payment, or in partial payments.

#### Forfeited accounts

Forfeitures of non-vested employer contributions may be used to pay the Plan's expenses or to reduce employer contributions, at the discretion of the Plan Sponsor. Forfeitures of \$901 were used to reduce employer contributions during the year ended December 31, 2024. No forfeitures were used during the year ended December 31, 2023. The forfeiture account balance was \$15 and \$893 as of December 31, 2024 and 2023, respectively.

### Note 2 - Summary of accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

The Plan's investment in the Putnam Stable Value Fund, a common collective trust fund, represents an indirect investment in a fully-benefit responsive investment contract, which is reported at fair value without presenting the adjustment for contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent participant loans are recorded as Plan distributions on the basis of the terms of the Plan Document. No allowance for credit losses was deemed necessary by the Plan Sponsor based on an assessment of the outstanding notes receivable from participants at December 31, 2024 and 2023.

#### Payment of benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees paid to the investment managers and recordkeeper for investment management, advisory services and administration of participants' accounts are reported net of revenue sharing arrangements for the years ended December 31, 2024 and 2023. Asset-based fees, fees related to administration of notes receivable and participant withdrawals are charged directly to the participants' accounts and amounted to \$85,956 and \$60,914 for 2024 and 2023, respectively, prior to revenue sharing. Investment fees are included in the net appreciation in the fair value of investments. Revenue sharing credited to the plan expense account for the years ended December 31, 2024 and 2023 was \$49,904 and \$37,011, respectively.

#### Subsequent events

In preparing its financial statements, the Plan has evaluated subsequent events through October 15, 2025 which is the date the financial statements were available to be issued.

### Note 3 - Certified investments

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, a qualified institution.

The Plan's investments in mutual funds and common collective trust funds (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$1,691,542 in 2024 and \$1,785,640 in 2023.

### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. The Plan's investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

No assets were noted at Level 2 or 3 during the years ended December 31, 2024 and 2023. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

### Note 4 - Fair value measurements (continued)

Depending on the fund, the common collective trust funds seek long-term capital appreciation or growth. In order to achieve these objectives, the underlying funds are invested primarily in equity securities. The fair value of common collective trust funds is based on the investment's net asset value per unit, considering quoted market prices for similar securities, interest rates, foreign exchange rates, prepayment speeds, credit risk, and other inputs.

The Putnam Stable Value Fund is invested in high-quality guaranteed investment contracts and in synthetic wrap contracts, including insurance separate accounts as well as high-quality money market instruments and cash equivalents. The underlying investments may include asset-backed securities, corporate bonds, mortgage-backed securities, and securities issued or backed by U.S. government agencies. The fair value of the Putnam Stable Value Fund is based on the investment's (NAV) per unit, as reported by the manager of the fund. The initial pricing input is the quoted price obtained for the underlying fund, which is then adjusted to apply factors disclosed in the contract. There is no immediate recognition of the investment gains and losses on the fund's securities. Instead, gains or losses are recognized over time by periodically adjusting the interest rate credited to the fund under the synthetic wrap. The synthetic wrap allows a stable value fund to maintain a constant NAV and protects the fund in certain circumstances.

### Note 5 - Rollover contributions

During 2024, the rollover contributions of \$275,710 from other plans were from six active participants. During 2023, the rollover contributions of \$352,655 from other plans were from thirteen active participants.

### Note 6 - Related party transactions and party-in-interest transactions

Plan investments in mutual funds are managed by Empower and other fund managers, and the stable value fund is managed by Putnam Investments. Empower is the Plan custodian, third party administrator and trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Refer to **Note 2 - Expenses** for expenses of the Plan paid by the Plan Sponsor as well as the Plan participants to the party-in-interest. All these transactions are considered party-in-interest transactions under ERISA regulations but are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

### Note 7 - Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### Note 8 - Tax status

The Internal Revenue Service has determined and informed Empower, by letter dated November 14, 2022 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax-exempt as of the financial statement date and through the date of issuance of the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position not likely to be sustained upon examination by taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### Note 9 - Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks related to geopolitical tensions, economic instability, and changes in international trade policies, including the imposition of new tariffs, could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
