Opinion

We have audited the accompanying financial statements of the Phillips Infrastructure Holdings, Inc. Health and Welfare Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and plan benefit obligations and changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and the plan benefit obligations and changes in plan benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 - DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

General - The following description of the Phillips Infrastructure Holdings, Inc. Health and Welfare Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan provides health benefits (hospital, surgical, and major medical), dental, short-term disability, long-term disability, and death benefits to all eligible employees (full time with at least two months of service) and covered dependents of Phillips Infrastructure Holdings, Inc. (the "Sponsor") and subsidiaries, Phillips and Jordan, Inc.; RowCon, LLC; National Fleet Services, LLC; and Phillips and Jordan Environmental Services, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In conjunction with the Plan, the Sponsor has established the Phillips Infrastructure Holdings, Inc. Voluntary Employee Benefits Trust (the "VEBA Trust"). Accordingly, the activities, assets, and liabilities of the VEBA Trust are included in the financial statements of the Plan. The purpose of the VEBA Trust is to set aside assets (from those of the Sponsor) to fund certain current and future health benefit claims as well as certain other expenses. Expenses not paid through the VEBA Trust are paid directly by the Plan or the Sponsor.

Although it has not expressed any intent to do so, the Sponsor has the right, under the Plan, to modify the benefits provided to participants, to discontinue its contributions at any time, and to terminate the Plan subject to provisions of ERISA. Any assets remaining after payment for claims incurred prior to the termination date must be used to fund other employee benefit plans.

Basis of Accounting - The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Contributions - Participants contribute specified amounts as determined annually by the Sponsor. The Sponsor makes weekly contributions to the Plan in amounts equal to participant contributions, plus amounts estimated to cover the remaining expenses and benefits not covered by the participants or the Plan's excess liability insurance.

Benefits - The Plan is self-insured for health insurance benefits up to \$175,000 per claimant per year. Health claims in excess of \$175,000 are subject to reimbursement through a reinsurance contract with certain aggregate policy limits per year. Dental benefits are provided under a non-experience rated group insurance contract with Cigna Healthcare, and short-term disability, long-term disability, and death benefits are provided for under non-experience rated group insurance contracts with Guardian Life Insurance Company of America.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Sponsor to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Benefit Obligations - As noted in the financial statements, at December 31, 2024 and 2023, the Plan has net assets available for benefits of \$827,236 and \$1,364,666, respectively. Amounts of \$931,310 and \$335,617 are reconciling items to the Estimated Claims Incurred but not reported for 2024 and 2023, respectively. Such amounts have been recorded as benefit obligations by the Sponsor, who intends to fund related claims when presented by benefit providers. Benefit obligations are estimated by the Sponsor based upon Plan experience, merits of individual claims, and payments of claims subsequent to year end but prior to the issuance of financial statements. Actual benefit obligations could differ from these estimates.

NOTE 1 - DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - (Continued)

Company funding receivable - Company funding receivable of \$352,943 represent amounts due from the employer for funding not yet paid as of December 31, 2024. These amounts were received subsequent to year-end.

Administrative Expenses - Certain administrative expenses of the Plan are paid directly by the Sponsor. Pharmacy rebates are received by the Sponsor shown net of administrative expenses on the Statements of Changes in Net Assets Available for Benefits. These rebates amount to \$547,785 and \$466,557 as of December 31, 2024 and 2023, respectively.

Date of Management's Review - Management has evaluated events and transactions occurring subsequent to the statements of net assets available for benefits date for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through October 15, 2025, which is the date these financial statements were available to be issued.

NOTE 2 - CONCENTRATION OF CREDIT RISK

The Plan maintains its cash deposits in a financial institution located in the State of Tennessee. From time to time, these deposits may exceed federally insured limits. The Sponsor does not believe a significant credit risk exists as of December 31, 2024.

NOTE 3 - TAX STATUS OF VEBA TRUST

The VEBA Trust was established under the Plan to hold the Plan's assets and is qualified pursuant to §501(c)(9) of the Internal Revenue Code as a tax-exempt organization. The Internal Revenue Service made a favorable determination in a letter dated August 6, 2007 that the VEBA Trust meets the requirements of IRC §501(c)(9) and is therefore exempt from federal income taxes in accordance with IRC §501(a). The Plan Sponsor is not aware of any cause of action that would adversely affect the qualified status of the VEBA Trust.

The Plan recognizes tax loss contingencies when it is probable that a liability had been incurred and the amount of the loss could be reasonably estimated. The amount recognized would be subject to estimates and management's judgment with respect to the likely outcome of each uncertain tax position. Although the tax years ending December 31, 2021 through December 31, 2024 remain open for examination by various taxing authorities, it is management's opinion that no significant uncertain tax positions remain open at December 31, 2024.

NOTE 5 - PARTY-IN-INTEREST

The Sponsor is the administrator of the Plan and, as such, executes the normal duties associated therewith. Costs incurred for audit, legal, and other administrative functions are paid by the Sponsor on behalf of the Plan. There were no financial transactions recorded between the Sponsor and the Plan other than contributions made by the Sponsor to the Plan. The Plan utilizes Cigna Healthcare to provide claims administration and recordkeeping services, reinsurance protection, and pharmacy rebates. Transactions between the Plan and Cigna Healthcare qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.
