### Note 1: Description of Plan

The following description of the Mercy Health Corporation Employees' Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a participant-directed defined contribution plan established for a not-for-profit organization, commonly known as a Code Section 403(b) savings plan. The Plan covers all full-time employees of Mercy Health Corporation (referred to as either the "Plan Sponsor", "Company" or "Employer") not subject to a collective bargaining agreement or eligible to participate in another defined contribution plan of the Company. To be eligible for the purpose of receiving Company contributions, employees must have completed one full year of employment in which at least 1,000 hours of service was attained. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA and, therefore, provides that participants may choose to direct their contributions and/or all or part of their account balances among the Plan's investment alternatives. All investments are participant-directed.

#### Contributions

Each year, participants may contribute between 1% and 100% of compensation, as defined in the Plan, not to exceed the annual maximum allowed by the Internal Revenue Service ("IRS"). The Plan includes automatic participant deferrals unless participants opt out. The automatic deferral rate is 3% for years 1 and 2, 4% for year 3, 5% for year 4, and 6% for years 5 and more.

*Company matching contributions* - The Plan includes a matching contribution of 100% of participant contributions limited to 4% of each participant's eligible compensation. These contributions are made on a per pay period basis.

*Company discretionary contributions* - The Plan includes a Company discretionary contribution not to exceed 2% of a participant's eligible compensation. This contribution is based on the fiscal year goals of the Company. Participants must be employed at December 31 preceding the Company's fiscal year end to receive this contribution. The Company did not approve a discretionary contribution for the fiscal years ended June 30, 2025 and June 30, 2024.

Participants may also contribute amounts representing distributions from other qualified plans ("rollovers") with approval from the custodians. The Plan also allows for Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and allocations of (a) plan earnings (losses), and (b) forfeitures of terminated participants' nonvested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their voluntary contributions and Employer safe harbor matching contributions, plus actual earnings thereon. Participants become 100% vested in Employer discretionary contributions after completing 2 years of service. Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service during the latest 12 consecutive month period ending on December 31. Participants may also become fully vested upon attaining the age of 59 ½, death, termination due to disability or termination of the Plan.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined monthly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

Benefits are paid to the participant or beneficiary upon death, disability, retirement, or termination of employment, up to the amount of the participant's account. Benefits may be paid in a lump-sum distribution, installment distribution, or as an annuity, depending on the vested balance of the participant's account based on Plan terms. Once a participant has reached the age of 59 ½ or met the hardship or disability requirements, distributions may be made, at the participant's election, from their account.

#### Forfeitures

Forfeitures arise as a result of participants who terminate service with the Employer before becoming fully vested in the Employer's contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$212,490 and \$478,852, respectively. These accounts may be used to reduce future Employer contributions or to pay administrative expenses of the Plan in accordance with the plan document. Remaining forfeitures will be allocated to active participants. During the year ended December 31, 2024, \$560,199 of forfeitures were used to reduce employer contributions.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant notes receivable are recorded as deemed distributions on the basis of the terms of the plan document.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value except for fully benefit-responsive investments. Fully benefit-responsive investments are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account against the investment option for which the loan was originally charged. Fees paid by the Plan are allocated proportionately to participants based on their respective account balances. Investment related expenses are included in net appreciation of fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

*Stable value fund:* Fair value is estimated using the NAV per unit provided by the investment issuer. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, which include conventional contracts with insurance companies, synthetic investment contracts, short-term fixed income securities, and debt securities. There are no funding commitments associated with the stable value fund and participants can transact daily, except in circumstances where funds are being transferred to a competing investment options, which may require a 90-day notice period.

### Note 4: Guaranteed Investment Contracts

The Plan has entered into fully benefit-responsive investment contracts with Voya Financial. Voya Financial maintains the contributions in a general account. The accounts are credited with a fixed rate of interest and charged for participant withdrawals. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value, as reported to the Plan by Voya Financial, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

### **Note 4: Guaranteed Investment Contracts** (Continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on an annual basis for resetting. The contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or election of equity wash provisions, (3) bankruptcy of the Employer or other Employer' events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

### **Note 5: Information Prepared and Certified by the Custodians**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held of \$816,152,864 and \$726,407,021 at December 31, 2024 and 2023, respectively, and notes receivable held from participants at December 31, 2024 and 2023, and net investment income of \$103,595,576 for the year ended December 31, 2024, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Voya Institutional Trust Company and Empower Retirement, LLC, the custodians of the Plan.

### **Note 6: Party-in-Interest Transactions**

Certain plan investments are managed by the custodians. Voya Institutional Trust Company and Empower Retirement, LLC are the custodians as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Employer's contributions.

### **Note 8: Tax Status**

The Company adopted a volume submitter 403b plan with an IRS opinion letter, which states the volume submitter plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC, and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
