## Notes to the Financial Statements

### 1. Description of the Plan

The following description of the SearchPros Staffing LLC 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan, effective January 1, 2016, is a defined contribution 401(k) Plan covering all of the employees of SearchPros Staffing LLC and its related entities (the “Plan Sponsor”). Employees are eligible to participate in the Plan once they have attained age 21 and completed six months of service. Union employees, nonresident aliens, and employee as the result of a transaction code section 410(b)(6)(C) that is an asset or stock acquisition, merger, or similar transaction involving a change in the employer of the employees of a trade or business are not eligible to participate in the Plan. Participants may begin making deferrals into the Plan on the first day of each calendar month of the Plan year following eligibility.

The Plan is subject to the provisions of Section 401(a) of the Internal Revenue Code and the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

#### *Contributions to the Plan*

Participants may contribute their eligible annual compensation into the Plan subject to certain anti-discrimination restrictions and to an annual limitation of \$23,000 for 2024 (\$30,500 for those participants who are age 50 or over). Roth contributions are also permitted under the Plan.

The Plan permits the Plan Sponsor to make discretionary matching and profit sharing contributions. Participants must be age 21, complete 1 year of service and be employed on the last day of the Plan year to be eligible for such contributions. For 2024, the Plan Sponsor elected to forego matching and profit sharing contributions.

#### *Participant Accounts*

All of the Plan’s assets are invested, as directed by the participant, as pooled funds. A participant’s account balance is derived through an allocation of these funds. Each participant's account is credited with the participant's contribution and related investment earnings and losses pursuant to the participant's investment allocations. Allocations of income are based strictly on the participant's selection of investments and timing of purchase. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan.

#### *Vesting and Forfeitures*

Participants are immediately 100% vested in their contributions and related earnings at all times. Participants vest in Plan Sponsor matching contributions and profit sharing contributions in ratable installments of 20% after the first year of service. Participants are immediately 100% vested in the event of death or disability. Forfeitures may be used to pay Plan expenses. At December 31, 2024 and 2023, forfeitures available to pay Plan expenses were \$0 and \$15, respectively. During the year ended December 31, 2024, forfeitures in the amount of \$15 were used to pay fees.

#### *Payment of Benefits*

The Plan provides for the payment of benefits to the participant (or, if applicable, the beneficiary) at retirement, death, disability, hardship or termination of employment. In-service distributions are also available for participants who are at least age 59½. In-service withdrawals are also allowed for participant’s rollover contribution account at any time. Participants who qualify for retirement benefits and withdrawals may receive their benefits in the form of installments, partial withdrawals, annuity contracts or a lump sum payment. The benefit to which a participant is entitled is the benefit that can be provided directly from the participant's vested account balance. Participants who separate from service and have vested account balances of \$5,000 or less and do not process their own distribution may receive a lump sum cash payment if the entire vested account balance

is \$1,000 or less. If the value of the vested account balance is greater than \$1,000 but equal to or less than \$5,000 the account will be converted to an individual retirement account. Retired participants must begin receiving a distribution from their account balance no later than April 1 of the year following the year in which the participant attains age 73.

#### ***Plan Amendments***

Effective January 5, 2024, the Plan was restated to:

- Change the trustee from Reliance Trust Company to Counsel Trust DBA Mid Atlantic Trust Company.
- Change the Plan name to SearchPros Staffing LLC 401(k) Profit Sharing Plan and Trust.
- Change the exclusion of certain classes of employees to exclude employees as the result of a code section 410(b)(6)(C) transaction and allow leased employees to participate.
- Remove limits on elective deferrals to limits imposed by code sections 401(k).
- Allow Annuity Contracts as a form of distribution.

## **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting and in accordance with ERISA. Contributions from participants are recorded when withheld from the participant. Plan Sponsor contributions are recorded when approved by the Plan Sponsor. Benefit payments are recorded when paid.

#### ***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value as determined by the Plan custodian (see Note 3). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from the participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

#### ***Subsequent Events***

The Plan has evaluated subsequent events through September 2, 2025, the date the financial statements were available to be issued.

#### 3. Certification of Assets

Reliance Trust Company (“Reliance”) and Counsel Trust DBA Mid Atlantic Trust Company (“MATC”) served as the trustees of the Plan’s assets. In that capacity, Reliance and MATC held the Plan’s investment assets and executed investment transactions. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). As permitted under such election, the Plan administrator has obtained certifications from Reliance and MATC as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that all investment information supplied to the Plan is complete and accurate. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and interest, dividends and net appreciation/depreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from the certified information.

The asset or liability's fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market funds and Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable Value Fund:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued at the net asset value as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidation will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **5. Tax Status**

The Plan sponsor has adopted the Paychex Non-Standardized Pre-Approved Profit Sharing plan. The Pre-Approved plan received a favorable opinion letter from the Internal Revenue Service dated August 31, 2020, stating that the Pre-Approved plan is designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since the opinion letter, the Plan sponsor and administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, the Plan sponsor and administrator believe that the Plan is qualified and its related trust is exempt from tax

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. Management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all non-vested account balances would become 100% vested.

#### 7. Related Party Transactions

Counsel Trust DBA Mid Atlantic Trust Company ("MATC") serves as the trustee of the Plan's assets. All transactions with MATC qualify as party-in-interest transactions.

Fees incurred by the Plan for investment management services are included in net appreciation/depreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments totaling \$61,357 to the recordkeeper, contract administrator, and advisors which were not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan's operations.

#### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these securities and the level of uncertainty related to changes in the value, it is at least reasonably possible that changes in the various risk factors will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.
