Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of CTHP, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Consolidated Tribal Health Project, Inc.'s the (NPO) CTHP, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement and amendments for a more complete description of the Plan's provisions.

A. General

The NPO has established a retirement plan to supplement their employee's retirement income. Contributions are made into a Trust Fund which pays benefits to the employees at retirement. The Plan was originally effective on October 01, 1994, and was restated from November 01, 2023. All employees who have completed three months of service are eligible to participate.

B. Contributions

Contributions to the Plan consist of employee contributions of up to 90% of their compensation and employer contributions equal to 5% of the employee compensation. Participants direct the investment into various investment options offered by the Plan. All contributions are invested through the Reliance Trust Company.

Contributions are subject to certain limitations. The limits include:

C. Participant Accounts

Each participant's account is credited with the participant's contribution, Plan earnings or losses, and an allocation of the NPO's contribution. Allocation of the NPO's contribution is based on eligible employee compensation, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting Schedule

Participants are immediately vested in their entire account, including employer matching and discretionary nonelective contributions.

E. Distribution of Benefits

Benefits under the Plan are distributable upon normal retirement at age 55 or upon termination of employment by reason of retirement, disability, death, or other separation from service. A participant will receive a lump sum, substantially equal installments, or a partial withdrawal with a minimum of \$500, with the withdrawal amount equal to the value of the participant's vested interest in their account.

F. Forfeited Accounts

Forfeitures may first be used for administrative expenses, with the remaining balance used to offset future employer contributions. Total forfeited non-vested accounts as of December 31, 2024, and 2023 were \$2,429 and \$2,439, respectively.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

Basis of accounting refers to when revenues and expenditures or expenses are recognized in the accounts and reported in the financial statements. The financial statements have been prepared under the accrual basis of accounting. Revenues are recognized when they are earned, and expenses are recognized when they are incurred.

B. Use of Estimates

The preparation of the Plan statements in conformity with U.S generally accepted accounting principles ("GAAP") requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period.

C. Receivables

Receivables from participants and employers are determined based on the contributions withheld but not remitted to the Plan. As of December 31, 2024, the Plan had participant's and employer's contributions receivable amounting to \$11,131 and \$7,079 respectively.

D. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the plan valuation policies utilizing information provided by investment advisors, custodians, and insurance company. See note 4 for a discussion of fair value measurements. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the plan at year-end. Investment contracts are valued at fair value, which is determined by the trustee.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis.

Management fees and operating expenses charged to the Plan for investment in mutual funds are reflected as a reduction of net assets in the Statement of Changes in Net Assets Available for Benefits.

E. Contributions

Contributions from employees and the employer are recorded in the period in which the employer transfers the funds to the Plan.

F. Distributions

Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan or receive their total benefits in a lump-sum amount or installments over the years equal to the value of the participant's interest in their account. The Plan allows the automatic distribution of participant account balances that do not exceed \$5,000. In addition, the Plan provides for hardship distributions when specific criteria are met.

G. Administrative Expenses

The Plan may assess specific administrative expenses directly against an individual Participant's Account. These expenses are incurred by, or are attributable to, a particular Participant based on the use of specific Plan services.

H. Refundable Contributions

The Plan completes a non-discrimination test pursuant to IRS regulations on an annual basis. Excess contributions determined as a result of this test, if any, are netted against the participant contributions in the Statement of Changes in Net Assets Available for Benefits. For the years ended December 31, 2024 and 2023, the Plan passed the non-discrimination test.

NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE

Consolidated Tribal Health Project, Inc. has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rule and Regulations for Reposting and Disclosure under ERISA. Accordingly, the Reliance Trust Company, a qualified institution has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments as reported on the Statements of Net Assets Available for Benefits as of December 31, 2024;
- Net investment gain as shown on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024;
- Investment amounts included in the Notes to Financial Statements;
- All investment information included in the Supplemental Schedule of Assets (Held at End of Year) - As of December 31, 2024.

At the request of the Consolidated Tribal Health Project, Inc., the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Internal Revenue Service has determined that the form of the Plan and related trust are designed by applicable section 401 of the Internal Revenue Code (IRC). The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds: Values at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/ Collective Trust: It is valued daily and has a daily redemption period. There are no unfunded commitments for the common/collective trust held by the Plan as of December 31, 2024 and 2023. The total value of the common/collective trust is \$250,077 and \$0 as of December 31, 2024 and 2023, respectively.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the NPO has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants will become 100% vested in their accounts in the event of Plan termination.

NOTE 6 - TAX STATUS

The Plan has yet to receive a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 7 - PARTY-IN-INTEREST TRANSACTION

Certain Plan investments are managed by the Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan, and therefore, these transactions are recognized as exempt party-in-interest transactions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to multiple risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 9 - ERISA FIDELITY BOND

In accordance with ERISA Section 412, the Plan covers a fidelity bond intended to protect the Plan from the risk of loss due to fraud or dishonesty on the part of persons who handle funds or other property on behalf of the Plan.

NOTE 10 - SUBSEQUENT EVENTS

The management evaluated all subsequent events through October 14, 2025, the date on which the financial statements were available to be issued, and have determined that no adjustments are necessary to the amounts reported in the accompanying financial statements, nor have any subsequent events occurred, the nature of which would require disclosure.
