Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sugar Creek Packing Co. 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Emphasis of Matter—Plan Merger

As discussed in Note 9 to the financial statements, the Board of Directors of Sugar Creek Packing Co. approved the merger of the Veroni USA, Inc. 401(k) Plan into the Sugar Creek Sugar Creek Packing Co. 401(k) Plan and Trust effective December 31, 2024. All plan assets of the Veroni USA, Inc. 401(k) Plan were transferred to the control of the Sugar Creek Sugar Creek Packing Co. 401(k) Plan and Trust effective December 31, 2024. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Plan Description

The following description of the Sugar Creek Packing Co. 401(k) Plan and Trust (the Plan) is provided for general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General: The Plan is a defined contribution plan sponsored by Sugar Creek Packing Co. and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). These responsibilities are carried out by the Sugar Creek Packing Co. 401(k) Retirement Committee (the Committee).

Plan participants include substantially all nonunion employees of Sugar Creek Packing Co.; Wingate Packing, Inc., effective January 15, 2012; Cincinnati Beverage Company, effective June 5, 2023; and Veroni USA, Inc., effective June 24, 2024 (collectively, the Company). Participants must have completed 90 days of service and attained 21 years of age. Participants direct the investments of contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds (registered investment companies) and one guaranteed annuity contract as investment options.

Contributions: Each eligible employee (participant), as defined in the Plan, may elect to contribute, through payroll deductions, a percentage of their compensation limited to maximum allowable under the Internal Revenue Code for such plan year. Plan participants may contribute from 1% to 50% of their annual salary on a pretax or after-tax basis. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company contributes 100% of the first 3% of the participant's compensation contributed to the Plan plus 50% of the next 2% of the participant's compensation deferred to the Plan. Contributions are subject to certain limitations. The Company may also make a discretionary contribution to the Plan, which was \$0 for the year ended December 31, 2024.

Participant accounts: Each participant's account is credited with the participant's contribution, the Company's contribution and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and the Company's matching contributions plus earnings thereon. Discretionary contributions are subject to a six-year vesting schedule.

Payment of benefits: A participant may receive the value of his or her account upon retirement, disability, or termination. Upon death of a participant, the beneficiary shall be entitled to the full value of the account. Distributions are made in either a lump sum or equal installments not to exceed the life expectancy of the participant. Hardship withdrawals, as defined in the Plan, are also available to the participants.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes to Financial Statements

Note 2. Summary of Significant Accounting Policies (Continued)

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make certain estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions: Participant contributions and Company matching contributions are recognized when the participant contributions are withheld from the participant's earnings. Employer discretionary contributions are recognized when declared by the employer.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: The Plan is responsible for certain administrative expenses, which are recognized when incurred. A portion of the administrative expenses are paid by the Company, at the Company's discretion.

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 15, 2025, the date on which the financial statements were available to be issued.

Note 3. Tax Status

The Plan has adopted a nonstandardized preapproved plan sponsored by Empower Trust Company, LLC. The nonstandardized preapproved plan provider has received an opinion letter from the Internal Revenue Service as to the nonstandardized preapproved plan's qualified status. The nonstandardized preapproved plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Empower also certified to the completeness and accuracy of \$5,783,826 of net appreciation in the fair value of investments, \$1,906,964 of interest and dividends and \$69,643 of other income related to the aforementioned investments for the year ended December 31, 2024.

Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 5. Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at quoted market prices which represent the net asset value (NAV) of the shares held by the Plan at year-end.

The method described above may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Note 6. Guaranteed Annuity Contract With Insurance Company

The Plan has a guaranteed annuity contract investment contract with Empower Annuity Insurance Company of America. The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the traditional investment contract at December 31, 2024 and 2023, was \$4,983,466 and \$5,632,032, respectively. Fair value approximates contract value at December 31, 2024 and 2023.

The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0% and is reset at least as frequently as annually.

Note 6. Guaranteed Annuity Contract With Insurance Company (Continued)

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuers' ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code
2. The Plan's total investment in the contract falls below an amount specified in the contract
3. Premature termination of the contract
4. Plan termination of merger
5. Changes to Plan's prohibition on competing investment of other Plan provisions that have an adverse effect on the investment
6. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8. Party-in-Interest Transactions

Empower Trust Company, LLC is the trustee, as defined by the Plan. Empower Annuity Insurance Company of America is the custodian of the guaranteed annuity contract described in Note 6. Accordingly, transactions with these service providers and their affiliates qualify as party-in-interest transactions. Total fees paid by the Plan to these service providers and their affiliates were approximately \$57,000 during the year ended December 31, 2024.

In addition, the Plan paid approximately \$96,000 for certain expenses related to Plan operations to other various service providers during the year ended December 31, 2024.

Note 9. Plan Merger

The Board of Directors of Sugar Creek Packing Co. approved the merger of the Veroni USA, Inc. 401(k) Plan into the Suga Creek Packing Co. 401(k) Plan and Trust effective December 31, 2024. As a result, net assets of approximately \$811,000 were transferred to the control of the Sugar Creek Packing Co. 401(k) Plan and Trust effective December 31, 2024. The net assets related to the plan merger were liquidated on December 31, 2024, and received by the Sugar Creek Packing Co. 401(k) Plan and Trust on January 3, 2025; thus, the net assets related to the plan merger are shown in Due from broker on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024.
