Note 1 - Plan Description

The following description of the 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established by Providence Health & Services (the Company) for eligible employees of the Company and other participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is part of the Providence St. Joseph Health Master Trust (the Master Trust), a master trust arrangement, and has a divided interest in the Master Trust. Fidelity management Trust Company (Fidelity) serves as the trustee for the Master Trust which includes assets of the Plan, the St. Joseph and Covenant Health Systems 401(k) Plan, and the Providence Health & Services 401(a) Service Plan.

Eligible employees can begin participating in the elective deferral and match portion of the Plan on the first day of the payroll period following their date of hire. Employees covered by a collective bargaining agreement that does not provide for participation in the Plan are not eligible to participate in the Plan.

Transfers - Effective January 1, 2020, the Plan was amended to make certain employees in the Providence Health & Services 401(a) Service Plan eligible to contribute to the Plan. As a result, \$2,098,330 of assets related to those participants were transferred into the Plan during the year ended December 31, 2024.

Contributions - Participants may elect to defer up to 75% of their eligible compensation as pre-tax or Roth contributions. Swedish Edmonds (SE) employees may elect to defer up to 90% of their eligible compensation. In addition, participants can make regular after-tax contributions which may be limited to ensure the Plan passes the ACP test. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover). The Plan includes a provision whereby participants are automatically enrolled approximately 45 days after their hire or rehire date at a 6% deferral rate unless they elect a different deferral rate or decline enrollment in the Plan. Participants that are automatically enrolled will have their deferral rate increase by 1% each year, up to a maximum of 10%, unless otherwise elected.

Participants receive employer match on pre-tax and Roth contributions equal to 50% of each participant's contributions, up to a maximum range of 3% to 6% of eligible compensation based on years of match level service. Regular after-tax contributions are not eligible for employer match. Participants are credited with a year of match level service for each calendar year in which they are credited with at least 1,000 eligible hours.

Swedish Health Services (SHS) participants that are not active participants in the SHS Pension Plan and SE participants receive matching contributions equal to 100% of each participant's contributions, up to a maximum of 2% of eligible compensation. Additionally, SHS participants that are not active participants in the SHS Pension Plan and SE participants receive an employer Basic contribution, which is equal to 5% of eligible compensation, after the completion of 500 hours of service during each plan year.

Participants (other than SHS and SE participants) will be entitled to an allocation of employer discretionary contributions if they complete 1,000 hours of service during the plan year and are employed on the last day of the plan year. For the year ended December 31, 2024, eligible participants received employer discretionary contribution according to the following schedule:

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions, employer contributions (if eligible), and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting - Participants are immediately vested in their contributions and employer match plus actual earnings thereon. Matching contributions for certain participating employers or under a legacy plan that was merged into the Plan may be subject to different vesting rules.

Vesting in the employer discretionary contribution portion of a participant's account is based on vesting years of service, defined as any plan year during which the participant is credited with at least 1,000 hours of service, according to the following schedule:

Employer discretionary contributions for certain participating employers or under a legacy plan that was merged into the Plan may be subject to a different vesting schedule.

For SHS and SE participants, vesting in the employer Basic contributions portion of their account is based on vesting years of service, defined as any plan year during which the participant is credited with at least 500 hours of service, according to the following schedule:

Forfeited Accounts - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,473,303 and \$712,113, respectively. During 2024, \$19,244,413 in forfeited accounts were used in accordance with the provisions specified in the Plan document.

Payment of Benefits - Upon termination of service, death, or disability, a participant or beneficiary may generally elect to receive a lump-sum distribution equal to the value of the participant's vested interest in their account or installments paid at least annually in the amount specified by the participant. Participants who have attained age 59½ may also elect to receive a distribution from the eligible portion of their vested account balance prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the Plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan and from the regular after-tax portion of their account.

Notes Receivable From Participants - Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account. Interest rates are set at 1% above the prime rate, as defined. Principal and interest are paid directly by participants to the Plan's recordkeeper (outside of payroll).

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Certain expenses specifically related to the activity of a particular participant are allocated directly to the participant's account. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through August 22, 2025, the date the financial statements were available to be issued.

Note 3 - Interest in Master Trust

The Master Trust records are maintained by each investment fund option. Funds are allocated to the participating plans in accordance with plan provisions and participant allocation elections. The allocation of net assets is based on the respective number of shares or units held by the plans' participants as of year end. The allocation of investment income is calculated daily based on the shares or units held by the plans' participants as of that day's end.

Note 4 - Fair Value Measurements

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4 - Continued

The following is a description of the valuation methodologies used for the Master Trust's assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Self-Directed Brokerage Accounts - Accounts primarily consist of mutual funds, exchange traded funds, and common stocks that are valued on the basis of readily determinable market prices.

Registered Investment Company Funds - Valued at the daily closing price as reported by the fund. Registered investment company funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Collective Trust Funds - Valued at the NAV provided by the funds' trustee. These funds trade on a regular basis, have a published price that the Plan can obtain at any time and are valued based on this published price.

Note 5 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and investment income or loss and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 6 - Party-in-Interest Transactions

Certain Plan investments are managed by Fidelity or its affiliates. Transactions with such investments qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants would become 100% vested in their employer contributions.

Note 8 - Tax Status

The Plan obtained its latest determination letter dated September 4, 2013, in which the IRS states that the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan's management and the Plan's legal counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Delinquent Contributions

The Company determined there were instances in which participant deferral contributions, for a subset of the total population, were not deposited by the Company as plan assets within the time limitation stipulated under the Department of Labor's (DOL) regulations. In total, \$1,794,289 of deferral contributions were identified as delinquent in periods before 2022 and lost earnings have been restored to the Plan. For the 2022 plan year, \$25,182 of deferral contributions were identified as delinquent. During 2023, the Company restored lost earnings associated with the 2022 delinquent deposits. For the 2023 plan year, \$303,211 of deferral contributions were identified as delinquent. During 2025, the Company restored lost earnings associated with the 2023 delinquent deposits. For the 2024 plan year, \$132,033 of deferral contributions were identified as delinquent. During 2025, the Company restored lost earnings associated with the 2024 delinquent deposits. Management intends to file a Voluntary Fiduciary Correction Program application related to the 2023 and 2024 delinquent deposits.

Note 11 - Contingencies

On October 31, 2024, a class action complaint was filed against the Company in U.S. District Court for the Western District of Washington alleging that the Company misused forfeited funds to offset employer contributions rather than to defray plan expenses for participants. The Company believes that it has been managing forfeited funds consistent with legal authority, denies all allegations of wrongdoing, and has filed a motion for judgement on the pleading. The case has been stayed pending mandatory mediation and resolution of a similar case pending before the Ninth Circuit Court of Appeals.
