INDEPENDENT AUDITORS' REPORT

The Trustees

Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of America's Family Health and Welfare Fund (the Fund), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and benefit obligations for the years then ended, and the related notes to financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of America's Family Health and Welfare Fund as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

The supplemental schedule of benefit costs and operating expenses and schedule of assets (held at end of year), together referred to as "supplemental information," are presented for purposes of additional analysis and are not a required part of the financial statements. The schedule of assets (held at end of year) is presented for the purposes of additional analysis and is required by the

Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA and is not a required part of the basic financial statements. The schedule of benefit costs and operating expenses is presented for purposes of additional analysis and is not a required part of the basic financial statements or the required supplemental schedules under the Department of Labor's Rules and Regulations under ERISA. Such information is the responsibility of the Fund's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
