Independent Auditor's Report

To the Board of Trustees
Lufthansa German Airlines Employee Health and Disability Benefits Plan Trust

Opinion

We have audited the financial statements of Lufthansa German Airlines Employee Health and Disability Benefits Plan Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits - modified cash basis and plan benefit obligations - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis and changes in plan benefit obligations - modified cash basis for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits - modified cash basis and plan benefit obligations - modified cash basis of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits - modified cash basis and changes in its plan benefit obligations - modified cash basis for the years then ended, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter

As discussed in Note 5 to the financial statements, the plan has negative net assets available for benefits and additional support for funding needs. The Lufthansa German Airlines' (the Sponsor) evaluation of the events and conditions and the Sponsor's plans to mitigate these matters are also described in Note 5. Our opinion is not modified with respect to this matter.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.


Auditor's Responsibilities for the Audit of the Financial Statements

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Lufthansa German Airlines Employee Health and Disability Benefits Plan Trust's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Lufthansa German Airlines Employee Health and Disability Benefits Plan Trust's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF PLAN

The following brief description of the Lufthansa German Airlines Employee Health and Disability Benefits Plan Trust (the Plan) provides only general information. Participants should refer to the plan agreements for a more complete description of the Plan's provisions.

General - On July 14, 1982, Lufthansa German Airlines (the Sponsor) established a long-term disability plan for its employees known as Lufthansa German Airlines Employee Health and Disability Benefits Plan Trust (the Prior Plan). Effective December 15, 1989, the Sponsor amended, restated and renamed the Prior Plan, creating the Plan. As part of the Plan, the Sponsor established a dental and medical benefits plan effective January 1, 2002. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions - The Sponsor's policy is to contribute approximately 80 percent of the cost of coverage for benefits paid on behalf of current employees participating in the Plan, with such employees contributing the remaining cost through pre-tax salary withholdings.

Beginning in 2015, the Sponsor will reimburse retirees and spouses up to \$117 per participant per month for enrollment in prescription drug coverage purchased elsewhere. This reimbursement is only available to those retirees and spouses who were enrolled in the prescription-only plan at the end of 2014. No other company subsidy is being offered for Medicare-eligible participants.

Benefits and eligibility - The Plan provides medical, hospital, surgical, dental, disability, vision care and prescription drug benefits to full-time employees of the Sponsor who have at least 1,000 hours of service each year and to their eligible dependents. These employees become eligible to participate in the Plan after three months of continuous employment. Retired employees can continue participation through Consolidated Omnibus Budget Reconciliation Act (COBRA) continuation of health benefits coverage.

Self-insured benefits - The Plan's medical, hospital, surgical, dental, disability, vision care and prescription coverage are self-insured. The claims for self-insured benefits are processed by third-party claims processors under Administrative Services Only (ASO) arrangements. The claims processors pay claims directly to or on behalf of the participants and are then reimbursed by the Plan. Despite the Plan's utilization of third-party claims processors, the ultimate responsibility for payments to providers and participants is retained by the Plan.

Stop-loss coverage - The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount as well as its aggregate exposure for all claims).

Other - Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, plan assets shall be first used to satisfy all benefits payable as of the date of termination; then used to pay plan administration expenses; and lastly for the exclusive benefit of participants enrolled as of the date of termination.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting - The financial statements have been prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP). That basis differs from U.S. GAAP principally because employer contributions are recognized when received rather than when earned. Accordingly, receivables from employer contributions and stop-loss refunds and their related effects on earnings have not been recognized in these financial statements. Additionally, expenses for operating costs are recorded when paid. Accordingly, there are no payables for operating costs included in these financial statements.

Use of estimates - The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, disclosures of contingent assets and liabilities, and actuarial present value of accumulated benefit obligations at the date of the financial statements and changes therein. Actual results could differ from these estimates.

Payment of benefits - Claim payments to administrators and premium payments to insurance companies are recorded when paid by the Plan.

Stop-loss - Premiums for stop-loss insurance are included in administrative expenses in the accompanying Statements of Changes in Net Assets Available for Benefits. Stop-loss refunds are netted with benefits paid in the accompanying Statements of Changes in Net Assets Available for Benefits and are recorded when received. Accordingly, receivables for stop-loss refunds are not recognized in the financial statements. Total stop-loss refunds were \$1,010,990 and \$717,059 for the years ended December 31, 2024 and 2023, respectively.

Income taxes - The trust established under the Plan (the Trust) to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code, and accordingly, the Trust's net investment income is exempt from income taxes except where such income is in excess of amounts needed to pay benefits. When such income is in excess, the Trust may be subject to tax on its investment income. As of December 31, 2024 and 2023, investment income did not exceed amounts needed to pay benefits and, accordingly, no provision for taxes was recorded.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent events - The Plan has evaluated events and transactions that occurred through October 15, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

3. PLAN BENEFIT OBLIGATIONS

Claims payable and claims incurred but not reported - Claims payable and claims incurred but not reported are presented in the Statements of Plan Benefit Obligations and is the amount of claims paid subsequent to the date of the financial statements for claims incurred (both reported and not reported) prior to the financial statement date. The amount is based on actual claims experience after the balance sheet date. Historical claims experience shows that claims are generally reported and paid within four months of the incurrence. Accordingly, actual claims payment data through the date of management's review is used to develop this liability, and there are no estimated amounts included therein.

Postretirement benefit obligations - The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan's participating employer and from existing plan assets.

Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes, an annual rate of increase in the per capita cost of covered health care benefits was assumed for 2024; the rate was assumed to remain at 4.75 percent through 2029 and thereafter. The weighted-average discount rate was 4.90 percent in 2024 and 5.30 percent in 2023 and the average retirement age was assumed to be 65 for both years. The health care cost trend rate decreased from 7.00 percent in 2023 to 6.50 percent in 2024. A one percent increase in the health care cost trend rate would increase the postretirement benefit obligation by \$10,000 at December 31, 2024.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

4. SPONSOR LOAN PAYABLE

During the year ended December 31, 2024, the Plan repaid the Sponsor's loan of \$600,000. The Plan received an additional operational non-interest-bearing loan from the Sponsor in the amount of \$2,900,000 to cover cash flow deficits. As of December 31, 2024, the remaining balance of the loan is \$2,300,000.

5. RISKS AND UNCERTAINTIES

Cash accounts at the banks are insured by the Federal Deposit Insurance Corporation, subject to certain limits. At times, such cash balances may be in excess of the insured limits. There was no cash in excess of insured limits as of December 31, 2024 and 2023, respectively. The Plan has not experienced any losses on their accounts.

As of December 31, 2024, the Plan has negative net assets available for benefits due to the timing of claims payments versus funding by the Sponsor and participants that was collected during the first week of 2025. During 2025, the Sponsor has increased the amount that participants are required to contribute to the Plan for coverage and has also increased Sponsor funding to meet cash flow needs. Furthermore, obligations for future benefit payments will be met by additional Sponsor contributions, as needed.

6. PARTY IN INTEREST TRANSACTIONS

The Plan has several service providers. Such providers are parties in interest under ERISA. However, all transactions with such providers are exempt party in interest transactions under ERISA.
