Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of Margaret Mary Health Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a prototype defined contribution plan and trust custodial account adopted by Margaret Mary Health (Plan sponsor). The Plan is a defined contribution plan providing for retirement benefits, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. All employees are eligible for all Plan purposes.

Contributions

Employees can participate in the Plan, for the purposes of elective deferrals and employer-matching contributions, on their date of hire. The Plan permits participants, through a salary deferral election, to have deductions of any set dollar amount per payroll period or a percentage of their eligible compensation, up to the maximum allowed by law, contributed to their account. Rollover and catch-up contributions are also permitted. The Plan sponsor matches participant deferrals up to the lesser of 1.5% of a participant's eligible compensation or \$1,500. These matching contributions are calculated annually.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution, allocations of Plan sponsor's contribution and Plan earnings (net of certain fund management expenses). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Investment account options available include various funds. Each participant has the option of directing contributions into any of the separate investment accounts and may change allocations daily.

Compensation

Participant compensation is defined by the Plan as wages, tips and other compensation reported on the Federal Form W-2, Wage and Tax Statement, increased by elective deferrals.

Vesting and Forfeitures

Participants are vested immediately in their elective deferrals, rollovers, and actual earnings thereon. The Plan provides that the participant is fully vested in employer-matching contributions at the end of three years or earlier upon attainment of normal retirement age, upon retirement due to disability, upon death or upon termination of the Plan. Upon termination of employment, the nonvested portion of the participant's account is called a forfeiture and remains in the Plan to reduce Plan sponsor contributions or administrative expenses for the year. There were approximately \$21,000 and \$18,000 of forfeitures available to offset contributions or expenses as of December 31, 2024 and 2023, respectively. No forfeitures were used during 2024 to offset contributions or administrative expenses.

Notes Receivable from Participants

Pursuant to Plan provisions, participants are not permitted to borrow from their fund accounts.

Due from Margaret Mary Health Retirement Plan (MMH Retirement Plan)

The amount due from MMH Retirement Plan represented a participant rollover contribution intended for the Plan but inadvertently deposited by the MMH Retirement Plan. The balance as of December 31, 2023 was approximately \$47,000. The participant rollover was remitted to the Plan during 2024.

Payment of Benefits

In general, on termination of service a participant may elect to receive their vested interest in the form of a lump-sum amount, an account rollover, an annuity or leave the account in the Plan, subject to certain limitations and conditions as defined by the Plan. In-service distributions may be made from the Plan for certain participants based on the Plan documents.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Changes in unrealized appreciation of investments are reflected in the statement of changes in net assets available for benefits in the year in which such changes occur.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Each individual investment offered to the participants has varied investment objectives. Participants should refer to the custodian for a more complete description of the investment objectives.

Funds Held in General Accounts of Insurance Companies

Funds held in insurance companies general accounts represent fixed account contracts entered into by the Plan with Talcott Resolution Life Insurance Company (Talcott Resolution), AXA Equitable Life Insurance Company (AXA), and American United Life Insurance Company (AUL). Any contributions are maintained in unallocated funds, whose assets are invested with other assets in the general accounts of Talcott Resolution, AXA, and AUL. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Talcott Resolution, AXA, and AUL. These contracts are included in the financial statements at contract value of approximately \$5,570,000 and \$7,432,000 as of December 31, 2024 and 2023, respectively. These contracts paid a rate of approximately 3.50% for 2024.

Payment of Benefits

The Plan records benefit payments to participants when paid.

Expenses of the Plan

The Plan sponsor provides certain administrative and accounting services to the Plan at no cost. Most administrative expenses are paid directly by the Plan sponsor and generally include audit and other professional fees. The expenses paid by the Plan sponsor are excluded from these financial statements. Administrative expenses incurred by the Plan generally include certain administrative fees charged directly to the participants' accounts. Investment related expenses are included in net change in fair value of investments.

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which was October 13, 2025.

3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES

The plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America (Empower), AXA, and AUL, the trustees of the Plan, have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets as of December 31, 2024 and investment related activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. INCOME TAX STATUS

The Plan has adopted a volume submitter plan document sponsored by American Pension Advisors, LTD, which has received an opinion letter from the Internal Revenue Service dated August 1, 2017, stating that the form of the volume submitter plan document, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the volume submitter plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

Although Plan sponsor has not expressed intent to discontinue the Plan, it may do so at any time, upon resolution by Plan sponsor's Board of Directors. The Plan provides that in the event of termination of the Plan, all amounts credited to the participant accounts will be fully vested and will be paid as directed in the Plan text and regulations.

7. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Plan sponsor, and certain others. The administrative expenses paid to Empower, AXA and AUL, the trustees, are party-in-interest transactions. LJI Wealth Management and Empower Advisory Group, LLC are the investment advisors to the Plan. Empower, American Pension Advisors, CBIZ Benefits and Insurance Services, and ERISA Smart are the third party administrators to the Plan. Blue & Co., LLC is the independent auditor for the Plan. Each receives payment for their services. The Plan sponsor provides certain administrative services at no cost to the Plan including accounting fees.. These expenses qualify as party-in-interest transactions.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as a pandemic or international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
