INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Kindthread 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed an audit of the accompanying financial statements of Kindthread 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Kindthread 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Kindthread 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. DESCRIPTION OF THE PLAN

The following description of the Kindthread 401(k) Plan (the "Plan") (previously known as Performance Apparel Holdings, LLC 401(k) Profit Sharing Plan), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 1979 and restated on January 1, 2023 to amend the name of the Plan from Performance Apparel Holdings, LLC 401(k) Profit Sharing Plan to Kindthread 401(k) Plan. The purpose of the plan is to provide retirement benefits for the employees of Performance Apparel Holdings, LLC d.b.a. Kindthread (the "Company"). Effective January 1, 2024, the Plan sponsor name was amended to Performance Apparel Holdings, LLC d.b.a Kindthread LLC. The Plan is a salary reduction Plan subject to the provision of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

Employees may participate in the Plan after meeting the eligibility requirements as described in the Plan document. Eligible employees include those who have attained the age of 21, excluding union employees. Eligible employees may become participants in the Plan for purposes of making pre-tax or Roth contributions and receiving safe harbor contributions upon one month of service.

Participants are eligible to receive employer discretionary matching and profit-sharing contributions under the Plan upon one year of service, given the eligibility requirements noted above are met.

Contributions

Plan participants may contribute a portion of their pretax annual compensation, not to exceed certain limits and the maximum percentage of annual compensation allowed by the Internal Revenue Code ("IRC"). The Plan allows for pretax or Roth contributions. The Company makes a Safe Harbor matching contribution equal to 100% of an employee's salary deferral contribution up to 4% of the employee's compensation. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified benefit plans. The Company may contribute additional profit sharing amounts at the discretion of the Company's Management. The Company did not make discretionary profit sharing contributions to the Plan for the years ended December 31, 2024 and 2023.

Contributions (continued)

The Plan includes a provision to auto enroll all newly eligible participants. Participants are deemed to have elected to make a salary deferral of 2% of their compensation (as defined in the Plan document), unless they file an election to contribute a different amount (or no amount). The Plan also includes an annual deferral increase program. All participants whose pretax or Roth contribution is less than 4% shall be deemed to have elected to increase his or her salary deferral contribution rate by 1% until the participant reaches a 4% deferral. Participants may opt out of this annual increase program. Participants deferring a dollar rate are excluded from the deferral increase program.

Participant accounts

Each participant's account is credited with the participant's deferral contribution, rollover contributions, and allocations of (a) the Company's matching contributions, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The participant's account is debited with any distributions or withdrawals made to the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching contributions is immediately 100% for Safe Harbor matching contributions. Further, a participant leaving the Company for a reason other than death, disability or attainment of age 65 will be vested in any discretionary Company contributions based on a six-year vesting schedule as defined in the Plan agreement.

Notes receivable from participants

Eligible participants may borrow from their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 4.25% - 10.50%, which is commensurate with National Prime Interest Rate plus 2%. Loan terms range from one to five years, or longer for the purchase of a primary residence. Principal and interest payments are made by participants through payroll deductions. Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

Payment of benefits

The Plan provides that a participant's vested interest in the Plan will be distributed to the participant upon death, total disability, retirement, termination of employment, or upon request after reaching age 59 ½. Participants with account balances less than \$5,000 will receive a lump sum amount equal to their vested account balance as soon as administratively feasible. Participants with account balances equal to or greater than \$5,000 may elect to (a) receive a single lump sum amount equal to their vested account balance, or (b) have all of his or her distributions paid in the form of a direct custodian-to-custodian transfer to another eligible retirement plan designated by the participant.

Participants may also withdraw their pre-tax elective deferrals and Roth contributions in the event of a financial hardship as defined by the Plan and the IRC.

Forfeiture accounts

Any portion of a terminated employee's account that is not vested is forfeited. Forfeitures may be used to pay any Plan administrative expenses or reduce future employer contributions. At December 31, 2024 and 2023, the Plan had \$36,212 and \$19,739, respectively of unallocated forfeiture balances. Forfeitures totaling \$19,918 were used to reduce employer contributions during the year then ended.

Plan administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Trustee and custodial services are provided by Matrix Trust Company (the "Custodian"). Recordkeeping services are provided by OneAmerica Retirement Services, LLC. Certain administrative expenses of the Plan are paid directly by the Company.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements, accompanying notes and the supplemental schedule. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value, (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Expenses

The Plan's administrative expenses including, but not limited to, trustee, custodial, and legal fees are paid from the assets of the Plan. Fees related to participant-directed transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

3. CERTIFICATION OF INVESTMENT INFORMATION

The Plan's Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications as of and for the years ended December 31, 2024 and 2023, from Matrix Trust Company that all of the investment and notes receivable from participants information provided by the Custodian and included in the accompanying financial statements and supplemental schedule is complete and accurate. Information as to the investments in the account of the Custodian, investment income, and all investment related information appearing in the accompanying statements and supplemental schedule are presented in reliance solely upon this certification. The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the valuation methodology used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trusts - The Plan's collective trust investments are valued at the NAV of units of a bank collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchase and sales) may occur daily.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan held traditional investment contracts with American United Life Insurance Company as of December 31, 2024 and 2023, respectively. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The following represents the disaggregation of contract value between types of investment contracts held by the Plan.

The contract value of the traditional investment contracts were \$1,022,034 and \$1,114,951 at December 31, 2024 and 2023, respectively.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (continued)

The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuers are contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the Plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) premature termination of the contracts, (4) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (5) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation or (4) a material amendment to the agreements without the consent of the issuer.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines parties-in-interest similarly to a related party as defined under U.S. GAAP except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Management did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (continued)

The Plan did not enter into any material related party transactions during the Plan year related to compensation arrangements, expense allowances, or similar items. Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan's fully benefit-responsive investment contracts are managed by American United Life Insurance Company ("AUL"), an affiliate of OneAmerica Retirement Services, LLC, who is the Plan's recordkeeper. The Plan's investments are managed by the Plan's investment advisor, MMA Securities, LLC. As service providers these transactions qualify as party-in-interest transactions. Fees paid to parties-in-interest were \$71,383 and \$82,524 for the years ended December 31, 2024 and 2023, respectively. Plan assets also include notes receivable from participants, which qualify as party-in-interest transactions under ERISA.

8. TAX STATUS

The Plan operates under a prototype Plan Agreement. The prototype plan agreement received a determination letter dated November 30, 2020 from the Internal Revenue Service ("IRS") stating the prototype plan and the related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since its adoption, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax exempt.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

9. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.
