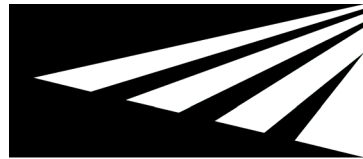

INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the
Bryan Skilled Home Care Retirement Savings Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Bryan Skilled Home Care Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the eight months ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certification from a qualified institution as of December 31, 2024 and for the eight months ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

(1) Plan Description:

The following description of the Bryan Skilled Home Care Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General -

Bryan Skilled Home Care, Inc. (the "Sponsor") established the Plan on May 1, 2024. The Plan is a defined contribution 401(k) plan covering all eligible employees, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions -

Participants may contribute pretax compensation, as defined in the Plan, and Roth elective deferrals subject to the Internal Revenue Service ("IRS") limitations. All newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. The deferral will increase by 1% on an annual basis up to a maximum of 10%. Participants may also contribute amounts representing distributions from other qualified plans and catch-up contributions for participants who attain age 50 by the end of a plan year.

The Sponsor contributes a fixed matching contribution equal to 50% of the participants' deferral up to 6% of eligible compensation on behalf of each participant who is not a care-giver subject to wage parity. The Sponsor may make a discretionary prevailing wage contribution for eligible participants. No prevailing wage contributions were made for the eight months ended December 31, 2024.

Participants direct the investment of the contributions into various investment options offered by the Plan.

Vesting -

Participants are immediately vested in their contributions and the Sponsor's prevailing wage contributions plus actual earnings thereon. Vesting in the Sponsor's matching contributions and earnings is based on vested levels over three years of credited service as defined in the Plan document. The Sponsor's matching contributions are 25% vested at 1 year, 50% vested at 2 years, and 100% vested at 3 years.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

Participant Accounts -

Each participant's account is credited with the participant's contributions, the Sponsor's contributions, Plan gains or losses, and charged with a share of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is that amount that can be provided from the participant's vested accounts.

Notes Receivable from Participants -

Each participant can borrow up to 50% of their vested balance in their account up to a maximum loan of \$50,000. The loan must be a minimum of \$1,000. Participants may only have one loan outstanding at a time. The maximum loan term is 5 years, unless it is for the purchase of a principal residence, in which case the term may be for a up to 30 years. The effective interest rate assumed is the prime rate plus 1%. No loans were taken during the eight month period ended December 31, 2024.

Payment of Benefits -

If a participant terminates employment with the Sponsor, the participant can elect to leave the vested account balance in the Plan until the normal retirement date, if the balance is greater than \$5,000. If the account balance is less than \$1,000, the participant will receive an involuntary cash-out payment in the form of a lump sum distribution. If the account balance is greater than \$1,000, but less than \$5,000, the funds will be automatically rolled over into an IRA established for the participant.

Participants are required to begin distributions when the age of 73 is attained. In the case of death of a participant, the beneficiary designated by the participant shall be paid the deceased employee's vested account balance immediately, or in payments for up to five years from the anniversary of the date of death. If the beneficiary is the participant's spouse, payment of benefits may be deferred until they reach the age of 73.

Upon retirement, the total value of a participant's account can be distributed in in the form of a lump sum payment. Normal retirement age is 65 years old. In-service distributions are permitted upon attainment of age 59 ½. Hardship distributions are not permitted.

Forfeitures -

Participants who separate or withdraw from the Plan will forfeit any amounts not vested with respect to the Sponsor's matching contributions. Forfeitures may be used to pay plan expenses or reduce future matching contributions.

(2) Summary of Significant Accounting Policies:

Basis of Accounting -

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles.

Use of Estimates -

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Sponsor to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition -

Investments are reported at fair value. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Net depreciation in fair value of investments includes realized and unrealized gains and losses on the fair value of investments held by the Plan. Purchases and sales of investments are recorded on a trade date basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits -

Benefits are recorded when paid.

Forfeiture Credits -

As employees leave the Sponsor, their non-vested participant accounts are transferred to a separate cash account. At December 31, 2024, the Plan had no forfeitures.

Plan Expenses -

Certain expenses of maintaining the Plan may be paid directly by the Sponsor and are excluded from these financial statements. Investment related expenses are included in net investment income.

(3) Fair Value Measurements and Investments:

U.S. generally accepted accounting principles establish a fair value hierarchy, which require an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the reported entity has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (“SEC”). These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trusts: Valued at the NAV of units of a collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

There have been no changes in the methodologies used at December 31, 2024.

(5) Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant accounts and the amounts reported in the Statement of Net Assets Available For Benefits.

(6) Income Tax Status:

The Plan Sponsor has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated October 6, 2020, stating that the form and content of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan Sponsor believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

U.S. generally accepted accounting principles require the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor believes there are no such positions, and therefore, no provision for income tax has been included in the Plan’s financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(7) Plan Termination:

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right. Accordingly, in the event of Plan termination, participants would become 100% vested in their employer contributions.

(8) Related Party Transactions and Party-in-Interest Transactions:

All Plan investments are shares of mutual funds and a collective trust managed by ADP. ADP provides investment management and recordkeeping services. ADP is the third party plan administrator and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to ADP totaled \$11,287 for the eight months ended December 31, 2024.
