To the Participants and Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Dixie Landscape 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Dixie Landscape 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement and amendment for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan adopted by the Board of Directors of Dixie Landscape, LLC (the plan sponsor) and is subject to the provisions of the Internal Revenue Code and the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a qualified safe harbor 401(k) plan designed to make safe harbor matching contributions that enable the employer to simplify plan administration by ensuring that non-discrimination regulations are met.

Eligibility

All non-excluded employees of the plan sponsor are eligible to participate in the Plan after completing 6 months of service and having reached the age of 21.

Entry Date

For the purpose of salary deferrals, matching contributions, and profit-sharing contributions, entry date will be the first day of the Plan year quarter coinciding with or next following the date the eligibility requirements are satisfied.

Contributions

Participants may elect to contribute a percentage and or portion of their annual pretax or post-tax Roth compensation, subject to statutory maximums. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other plans and certain individual retirement accounts (IRA). Under Internal Revenue Service (IRS) Code Section 402(g)(1), the maximum deferral of earnings was \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have reached age 50 could have contributed an additional \$7,500 for the years ended December 31, 2024 and 2023, respectively. The plan sponsor will make safe harbor matching contributions equal to 100% of the first 5% of the participant's compensation that is contributed to the plan, not to exceed more than 5% of the participant's total compensation.

Additional profit-sharing amounts may be contributed at the discretion of the plan sponsor. No additional profit-sharing amounts were contributed during 2024.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to any of the various Empower Retirement, LLC (Empower) investment options (see Note 3). Participants may change their investment options at any time.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contribution as well as an allocation of the plan sponsor's contribution and Plan earnings or losses. Participant accounts are charged with an allocation of certain other administrative expenses, such as loan fees, specific to each participant. Allocations of the Plan's earnings or losses in each investment option and plan sponsor contributions are made to the participant's accounts based on the ratio of each participant's current account balance in each investment option to total participant's account balances in the investment option. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Forfeitures of the non-vested account balances of participants are used to reduce employer contributions and pay Plan expenses. For the year ended December 31, 2024, there were no amounts in the forfeiture account to be used to offset future employer contributions.

Vesting

Participants are immediately vested in salary reduction contributions, voluntary contributions, transfer contributions and any safe harbor contributions. Participants are vested in the employer's profit sharing and matching contribution based on years of service as follows:

Payment of Benefits

Participant contributions and the vested portion of the plan sponsor's matching contributions are available for distribution upon attainment of age 59½, death, disability, termination of employment or normal retirement age. If the participant's vested account balance is less than \$5,000 at the date of the distribution, then that balance shall be distributed in a single lump-sum payment. If the participant's vested account balance exceeds \$5,000 at the date of distribution, then that balance shall be distributed in a single lump-sum payment or partial withdrawals of at least \$1,000 equal to the required minimum distribution rules as defined by the IRS. If the participant's vested account balance is more than \$5,000 at the date of the distribution, then the participant must consent to the distribution before it may be made.

Contributions are also available for distribution in the form of a hardship withdrawal.

Payment of Benefits (Continued)

In the event of death while employed by the plan sponsor, the participant becomes 100% vested and the amount of the account will be used to provide the participant's beneficiary with a death benefit.

A participant becomes 100% vested in their accounts if they become permanently disabled as defined by the Plan document.

Termination of the Plan

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan to make estimates and assumptions that affect the reported amounts of net assets available for benefit and disclosure of contingent net assets available for benefit as of the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. Management determines the Plan's valuation policies, which are in accordance with GAAP. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative and accounting functions are performed by the plan sponsor's employees, who receive no compensation from the Plan. Administrative expenses, such as professional fees and other, are paid directly by the plan sponsor.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide and Empower have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and has certified to the completeness and accuracy of the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the information reflected on the supplementary schedule Form 5500 – Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments (principally mutual funds) and charged for Plan withdrawals and administrative expenses.

During the year ended December 31, 2024, the Plan's underlying investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by approximately \$958,000. This was reported as net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

NOTE 4. NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants consists entirely of loans to participants. A loan cannot exceed the lesser of one-half of the vested interest of a participant's account balance or \$50,000 and must be at least \$1,000. The loans are secured by the participant's vested account balance and bear interest at the prime rate of interest, as published in the Wall Street Journal, on the day the loan is requested, plus 1% (the prime rate of interest being 7.50% and 8.50% as of December 31, 2024 and 2023, respectively). During the years ended December 31, 2024 and 2023, the interest rate on notes receivable from participants ranged from 4.25% to 9.50%. The notes receivable from participants had various maturity dates through December 2029. Notes receivable from participants were approximately \$236,000 and \$195,000 as of December 31, 2024 and 2023, respectively.

All loans must be repaid within a five-year period unless it is for the purchase of a principal residence, which allows for longer repayment terms.

NOTE 5. FAIR VALUE MEASUREMENTS

GAAP provides a framework for measuring fair value, expands disclosures about fair value measurements, and establishes a fair value hierarchy which prioritizes the inputs used in measuring fair value summarized as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual term), the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of the unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value.

Mutual funds: - Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value fund: Valued at the net asset value (NAV). The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the fund, the investment advisor reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Nationwide, custodian of the Plan; therefore, these transactions qualify as party-in-interest.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in these risks and uncertainties in the near term would materially affect participant account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 8. TAX STATUS

The Plan obtained its latest determination letter dated June 30, 2020, in which the IRS stated that the prototype plan document of the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Plan management is required to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken by the Plan. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
