Note (1) Description of Plan

The following description of the Global Crossing Airlines 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan sponsored by Global Crossing Airlines, Inc. (the “Company” or the “Plan Sponsor”), for the benefit of all employees since the date of entry and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Each month new participants are automatically enrolled to contribute 6% which is automatically increased each January 1st by 1% up to a maximum percentage of 10%. Participant may choose a different amount or may choose not to defer. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

Discretionary Contributions – The Company may make a discretionary match contribution and/or discretionary contribution to be determined by the Company, which is immediately vested 100%. For the years ended December 31, 2024 and 2023, the Company made \$428,462 and \$0, respectively, of Employer Discretionary Contributions.

Participant Accounts – Individual accounts are maintained for each participant. Each participant’s account is adjusted to reflect the Company’s discretionary contributions, participant’s contributions and withdrawals, income, expenses and investment gains and losses attributable to the participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investing - Contributions made to the employee account are invested to provide benefits under the plan. Contributions are self-directed by Participants and can buy and sell stocks, bonds, exchange-traded funds (ETFs), and mutual funds in the normal manner, albeit with no tax consequences.

Notes Receivable from Participants – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loan repayments must be within five years, other than principal residence loans. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid by deductions from the participant’s pay each payroll period and loan rate is determined at the time of the loan, which is based of 1% plus the prime rate. Participants may only have one outstanding loan at a time.

Payment of benefits – On termination of service due to death, disability or retirement, a participant shall be entitled to receive the value in his or her account in a lump-sum amount unless the participant previously elected to receive such amount in the form of a lifetime annuity. For termination of service due to other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution, if the account balance is below \$1,000. Minimum distributions from the participant account are required by the age of 73, unless participant is not yet separated from employer and can delay minimum distributions until the year that retires.

Hardship Withdrawal – Early withdrawal from participant retirement account for an immediate and heavy financial need, such as medical expenses, costs to prevent eviction or foreclosure, or funeral expenses. These withdrawals are subject to income tax, and a 10% early withdrawal penalty may apply if you are under 59½, unless an exception is met.

Change in Administrator – In April 2024, the Plan Sponsor transitioned from Principal to ADP as their third-party administrator.

Note (2) Summary of significant accounting policies.

Basis of accounting - The financial statements of the Plan are prepared on the accrual method of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants - Notes receivable from participants is reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits – Benefits are recorded when paid.

Administrative expenses - Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Note (3) Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024 were obtained or derived from information supplied to the plan administrators and certified as complete and accurate by ADP RETIREMENT TRUST SERVICES and Principal Life Insurance Company, respectively.

Note (4) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

- **Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.
- **Level 2:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund.

Pooled Separate Accounts: Investments in pooled separate accounts represent a unit of account whose per unit value is the result of the accumulated values of the underlying investments. The underlying investments are investments vehicles valued using NAV per share, as determined by the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is used as a practical expedient to estimate fair value.

Common Collective Trusts: Investments in common collective trusts represent interests in pooled investment vehicles maintained by a bank or trust company and available exclusively to qualified retirement plans. The fair value of the Plan's investment is based on the net asset value ("NAV") of units of the trust, as determined by the fair value of the underlying assets held by the trust, less its liabilities, divided by the number of units outstanding. The NAV is used as a practical expedient to estimate fair value.

The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024, and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The availability of observable market data is monitored to access the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers in or out of levels 1, 2, or 3.

Note (5) Guaranteed Investment Contract

The Principal Fixed Income Guaranteed Option was a fully benefit-responsive guaranteed general-account backed group annuity contract, issued by Principal Life Insurance Company (Principal Life) to Principal Trust Company as custodian. Principal Life guaranteed interest accounts are reported at contract value which is the aggregation of contributions, plus interest, less withdrawals and administrative expenses. The rate of interest contractually guaranteed by Principal Life is credited to participant account balances and the rate may not be less than 1% (1.55% at December 31, 2023).

Certain events limited the Plan's ability to transact at contract value with Principal Life. Such events included the following: amendments to the Plan documents (including complete or partial plan termination or merger with another plan), termination of any record-keeping arrangement, service agreement or other agreement between Principal and the Plan, or termination of the investment contract. No redemption fees, early withdrawal charges, or market value adjustments are charged on participant transfers of assets into or out of the contract. A surrender of the Plan's interest or initiated transfer in this contract is subject to either a 12-month advance notice or a 5% surrender charge. Notification of the Plan's intent to terminate its interest may be revoked within 90 days of Principal's receipt of such notice, after which time, the notice becomes irrevocable. The Plan Administrator did not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring. The balance in the Principal Fixed Income Guaranteed Option contract was \$4,070 on December 31, 2023.

Note (6) Tax Status

The Internal Revenue Service ("IRS") has determined that the prototype non-standardized profit-sharing plan is designed in accordance with applicable sections of the IRC and informed the recordkeeper of such in an opinion letter dated October 6, 2020. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note (7) Risks, Uncertainties and Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note (8) Related party and party-in-interest Transactions

ADP RETIREMENT TRUST SERVICES and Principal Financial Group, the custodians of the Plan as of December 31, 2024 and December 31, 2023, respectively, and for the period of April 1 to December 31, 2024 and for the period of January 1 to March 31, 2024 and for the year ended December 31, 2023, respectively, thus parties-in-interest, held the Plan's investments.

Certain officers and employees of the Company (who may also be participants in the Plan) perform administrative services related to the operation, record-keeping and financial reporting of the Plan. The Company pays the salaries of these individuals and pays other administrative expenses on behalf of the Plan. Certain fees, to the extent not paid by the Company, are paid by the Plan.

Note (9) Prohibited Transactions

During years – ended December 31, 2021 through December 31, 2023, the Plan Sponsor failed to remit certain participant contributions to the Plan in a timely manner. Management has corrected this error during the year ended December 31, 2024.

During the year – ended December 31, 2024, the Plan Sponsor failed to withhold deferrals from certain participants related to earnings from post-termination pay periods. Management is in the process of contacting the affected participants and making the correction with lost earnings.

Note (11) Subsequent Events

Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

In accordance with the SECURE 2.0 Act of 2022, effective January 1, 2025, the Plan was amended to include the optional increased “super catch-up” contributions for participants attaining ages 60–63. Regular catch-up contributions will continue to be available to eligible participants age 50 and over.

Effective June 1, 2025, the Plan was amended to modify eligibility requirements. Under the revised terms, employees become eligible to participate in the Plan upon attaining age 18 and completing 2 months of service (elapsed time). The amended eligibility and entry date provisions apply only to individuals hired on or after June 1, 2025. No additional service waivers or special conditions apply to existing participants.
