### 1. DESCRIPTION OF THE PLAN

The following description of the Professional Translating Services Inc. 401k Plan (the "Plan") provides only general information. Participants should refer to the Plan's agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a 401(k) defined contribution plan covering all employees of BIG Language Solutions LLC (the "Company") who complete one year of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Participant Accounts**

Each participant's account is credited with the Company's contributions, participant contributions and allocation of Plan earnings. Allocation of earnings is based on account balances as defined by the Plan. All amounts in participant accounts are participant directed. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately 100% vested in their contributions, including rollovers, plus actual earnings thereon, and the Company's matching and discretionary contributions.

#### **Participant Loans**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of participant's vested accrued benefits. Participants may have up to two outstanding loans. The loans are secured by the balance in the participant's account. The loan interest rate is set at 2% above prime rate, as defined. Principal and interest is paid ratably through payroll deductions. As of December 31, 2024, there were \$106,171 in participant loans outstanding.

#### **Payment of Benefits**

On termination of service, death, disability, or retirement, a participant may elect to receive a distribution equal to the vested portion of their account balance.

#### **Letter of Certification**

The Plan received a letter of certification from the Plan's trustee for the year ending December 31, 2024 that certified the information furnished to the Plan's administrator pursuant to 29 CFR 2520.103.-8.

### 2. SUMMARY OF ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Plan Administration**

The Plan Sponsor serves as the plan administrator. The plan administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan and making determinations regarding questions which may affect eligibility for benefits. The plan administrator has engaged Merrill Lynch Pierce Fenner & Smith as investment advisors, ADP, LLC ("ADP") (see Note 7) to assist in the administration of the Plan and Reliance Trust as trustee and custodian.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a further discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the plan year.

#### **Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **Tax Status**

The Plan is a 401(k) pre-approved prototype plan provided by ADP applied for and received approval from the IRS as a volume submitter.

#### **Administrative Expenses**

Administrative expenses incurred by the custodians and asset management and advisory fees are paid from the assets of the Plan. Administrative expenses of the Plan are also paid by the Plan Sponsor. Administration expenses for the plan totaled \$63,629 for the year ended December 31, 2024.

#### **3. CONTRIBUTIONS**

Participants may contribute 1% to 90% of annual compensation. Participants who attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans (rollover). Participants direct the investment of their contributes into various investment options offered by the plan. The Company may contribute a discretionary match. There were no discretionary contributions for the year ended December 31, 2024.

#### **4. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### **5. INVESTMENTS AND FAIR VALUE MEASUREMENTS**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520-103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the custodians as complete and accurate to the best of their knowledge, except for comparing such information certified by the custodians to the information included in the Plan's financial statements and supplemental schedules. Investments held and certified by the custodians in the accompanying statements of net assets available for benefits totaled \$9,256,098 in December 31, 2024. Investment gain reported and certified by the custodians in the accompanying statement of changes in net assets available for benefits totaled \$785,367 for the year ending December 31, 2024.

U.S. generally accepted accounting principles establish a framework for measuring fair value. Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provided the framework for measuring fair value. That framework provides a fair value hierarchy that give the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 Measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Registered investment companies – Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end registered investment companies that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The registered investment companies held by the Plan are deemed to be actively traded.
