Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of the H.J. Russell & Company Employees' Retirement & Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (the 2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the 2024 financial statements is complete and accurate.

Opinion

In our opinion, based on our audit and the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of the report,

- the amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying 2024 financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the 2024 financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the 2024 financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the 2024 financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the 2024 financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audit did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – 2024 Supplemental Schedule Required by ERISA

The 2024 supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the 2024 financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the 2024 financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the 2024 financial statements or to the 2024 financial statements themselves, and other additional procedures in accordance with GAAS. Their report dated October 10, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan

The following description of the H.J. Russell & Company Employees’ Retirement & Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of H. J. Russell & Company, LLC (HJR) and all affiliates within the H. J. Russell Enterprise (HJRE) and Concessions International Holdings, Inc. (Concessions) (collectively the Company). Employees of the Company who are age eighteen or older and who have completed one month of service (as defined in the Plan) are eligible to participate in the Plan. Nonresident aliens, leased employees, and union employees (unless participating pursuant to the terms of a collective bargaining agreement) are ineligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees are eligible to receive matching contributions after completing one month of service. One credited year of service is completed if at the end of the first consecutive twelve months of employment an employee has completed 1,000 hours of service. Employees participating in the Plan pursuant to a separate collective bargaining agreement are entitled to receive profit sharing contributions in accordance with the terms of the applicable agreement. An administrative committee as designated by the Company is responsible for the oversight of the Plan. The administrative committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Participants may make pre-tax contributions of up to 100% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024. Additionally, participants who have attained age 50 before the end of the Plan year are eligible to make “catch-up” contributions, not to exceed \$7,500 in 2024. The Plan also provides for participant rollover contributions from other qualified retirement plans, including after-tax Roth contributions and in-plan Roth rollover contributions. In 2024, a participant may have total contributions to the Plan in the amount of \$69,000, or \$76,500 including catch-up contributions. No automatic enrollment is applicable to the Plan.

The Company may make discretionary matching contributions for participants of the Plan equal to a discretionary percentage of a participant’s elective deferrals, of each tier, to be determined by the Company. The tiers may be based on the rate of a participant’s elective deferrals or years of service. The Company will determine the calculation methodology at the time of the matching

contribution. During the 2024 Plan year, HJR matched 50% of participant contributions that do not exceed 8% of compensation and Concessions matched 50% of participant contributions that do not exceed 6% of compensation. The Company may make a discretionary nonelective profit-sharing contribution to eligible employees who have completed one year of service. No discretionary nonelective profit-sharing contribution was made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company contributions, and earnings and losses on the investments in their account, and is charged with an allocation of certain administrative expenses. Participants direct the investment in their account into various investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, including elective deferrals, catch-up contributions, and rollovers, as well as the actual earnings thereon. Participants vest 25% after one year of service, 50% after two years of service, and are fully vested after three years of service for Company matching contributions and nonelective profit-sharing contributions. Participants become 100% vested in all contributions plus actual earnings thereon if the participant terminates employment due to death, total and permanent disability, or upon reaching normal retirement age (age 65).

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$42,766 and \$31,997, respectively. These accounts may be used to pay Plan administrative expenses or to reduce Company contributions. During 2024, no forfeitures were used to reduce the Company contributions or pay Plan administrative expenses.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. Participants may have more than one outstanding loan at a time, as long as the total outstanding loan balance does not exceed the lesser of \$50,000 or 50% of the vested account balance. The notes are secured by the balance in the participant's account and bear a fixed rate of interest. During 2024, outstanding notes receivable from participants had fixed rates ranging from 4.25% to 9.50% for the term of the loan, not to exceed 5 years. Principal and interest are paid through payroll deductions.

Payment of Benefits

At the time of death, disability, termination of service or retirement, the participant or their beneficiary may receive payment of the vested interest in their respective account in a partial or lump-sum distribution. At age 59.5, participants may elect a partial or lump-sum distribution of the employee portion of their account. The participant's contributions may also be withdrawn for certain hardship situations. If a participant terminates employment and has an account balance less than \$7,000, the participant will automatically receive a lump-sum payment equal to the value of their account.

Administrative Expenses

Certain administrative expenses are permitted to be paid by the Plan in accordance with the Plan's provisions. Expenses that are specifically attributable to an individual participant—such as loan origination fees and certain transaction fees for withdrawals are charged directly to the respective participant's account. These expenses are paid to service providers of the Plan and therefore qualify as party-in-interest transactions. General administrative and recordkeeping expenses may be paid from Plan assets and are generally allocated among all participants' accounts, either proportionately based on account balances or as an equal dollar amount per participant, depending on the nature of the expense. Certain expenses incidental to the administration of the Plan may be paid by the Company, and the Company does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions

Employee contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company's discretionary matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan, generally bi-weekly as soon as practicable. Company discretionary nonelective profit-sharing

contributions are considered payable to the Plan once approved by the Company. However, some or all employer contributions may not actually be contributed until after the Plan year end. Any unfunded participant or Company contributions are included in the employee or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification 326, *Financial Instruments—Credit Losses*, the Company estimates the current credit risk associated with the employer contribution receivables. After giving consideration to the risk characteristics, including historical payment experience, the Company determined that no allowance for credit loss was necessary and there was no current year activity in the allowance for credit losses as of and for the years ended December 31, 2024 and 2023.

Valuation of Investments and Revenue Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, realized and unrealized gains and losses on those investments, and fees charged for investment management and administrative services on those investments.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received by the Plan, primarily monthly. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced, and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Standard Insurance Company, the Plan's qualified institution.

4. Investments

Certain Plan investments are managed by Minnesota Life Insurance Company, a service provider to the Plan, therefore transactions in these investments qualify as party-in-interest transactions.

Investments are exposed to various risks such as interest rate, currency, market, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, or similar events. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan invests in Pooled Separate Accounts (PSAs). The net asset value (NAV) of the PSAs is not publicly quoted, but is available to current investors and Plan participants. The NAV is the basis for current transactions and the PSAs can be redeemed at NAV as of the measurement date. Therefore, this investment is considered to have a “Readily Determinable Fair Value”. The NAV is calculated in a manner consistent with GAAP for investment companies. While PSAs are covered by federal securities laws, they are exempted from registering with the Securities and Exchange Commission. Most of the security prices were obtained from a pricing service.

5. Income Tax Status

The Company adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan document (pre-approved plan) sponsored by Minnesota Life Insurance Company. The Internal Revenue Service has determined and informed Minnesota Life Insurance Company by a letter dated June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter, and has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan’s income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in all Company contributions.
