INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the Kibo Software 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. Description of Plan

The following description of the Kibo Software 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution Plan covering substantially all employees of Kibo Software, Inc. and its participating subsidiaries, affiliates and locations (collectively, the “Company”, “Plan Sponsor” or “Employer”), as described in the Plan document, who are age 18 or older. Employees who are covered by a collective bargaining agreement, unless the agreement requires the employees to be included in the Plan, and residents of Puerto Rico, are ineligible to participate in the Plan. Eligible participants may enter the Plan on the first day of the month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Effective June 1, 2024, the Plan changed the trustee and recordkeeper from Fidelity Management Trust Company to ADP Retirement Trust Services, LLC, trustee of the Plan and to ADP, Inc. recordkeeper of the Plan. This change in service providers initiated a “Black Out” period beginning July 30, 2024 and continued through September 1, 2024. During this period, participants’ plan accounts were not available for investment fund exchanges, loan requests, and distribution requests. During the Black Out period, funds were transferred to the new service provider at which point participants had the option to make their own investment elections or otherwise have their account balance mapped to a target date fund based on the age of the respective participant.

Contributions

Each year, participants may contribute up to 90 percent of their pre-tax eligible annual compensation, as defined in the Plan document. Contributions may also be designated as Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4 percent of eligible compensation and their contributions invested in a designated age-appropriate target date fund until changed by the participant.

The Company may elect to make discretionary matching employer contributions to the Plan based on a discretionary percentage of base compensation that a participant contributes to the Plan. For the year ended December 31, 2024, discretionary matching employer contributions were 50 percent of the first 4 percent of the base compensation that participants contribute to the Plan. The Company may, at its discretion, make additional profit-sharing contributions to the Plan on an annual basis. There were no profit-sharing contributions for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Code (“IRC”) limits.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and discretionary matching employer contributions, if any, as well as allocations of discretionary profit-sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Participants direct the investment of their contributions into various mutual funds and a collective investment trust option offered by the Plan and maintained by the trustee of the Plan. Participants may change their investment options at any time.

Forfeited Amounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$117,894 and \$113,551, respectively. Forfeitures may be used to pay administrative expenses of the Plan and/or to reduce employer contributions. During the year ended December 31, 2024, forfeitures of \$48,154 were used to reduce employer contributions and \$0 of forfeitures were used to pay administrative expenses of the Plan.

Vesting

Participants are vested immediately in their contributions, including their elective pre-tax deferral contributions, Roth 401(k) deferrals, and rollover contributions, plus actual earnings thereon.

Each participant is vested in the discretionary matching employer contributions and profit-sharing contributions according to the following schedule based upon years of service:

Participants that merged into the Plan from the Certona Corporation 401(k) Plan on January 1, 2020, are 100% vested in their legacy safe harbor matching contributions.

A participant is 100 percent vested upon death, disability, normal retirement age (65) or early retirement (age 55).

Payment of Benefits

On termination of service due to death, disability, retirement or otherwise, a participant may elect to receive a lump sum equal to the value of the participant's vested interest in his or her account, installments or partial withdrawals. In circumstances when a terminated participant has a vested account balance less than \$7,000 (\$5,000 prior to modification allowed by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 ("SECURE Act 2.0")), the participant's vested account balance shall be distributed in a lump sum. In the event of a mandatory distribution greater than \$1,000, if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan administrator. Hardship and in-service distributions are also permitted from participant accounts, based on the terms of the Plan document.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balances. A participant may only have two loans outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at a rate equal to 1% over the prime interest rate. Principal and interest are paid ratably through payroll deductions.

Loan terms shall not extend beyond five years from the date of the loan, unless the loan is for the purchase of a participant's primary residence.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The Plan's Administrative Committee determines the Plan's investment policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from Plan participants and the related discretionary matching employer contributions are recorded in the year in which the employee contributions are withheld from compensation. Discretionary employer profit-sharing contributions, if any, are recorded in the year in which the related participant compensation is earned.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants during 2025.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

All reasonable administrative expenses, including trustee, custodial and third party administration fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

3. Information Certified by Qualified Institutions

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ADP Retirement Trust Services, LLC, the trustee of the Plan, held the Plan's investment assets and executed investment transactions as of

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (“FASB”) Accounting Standards Codification are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The shares of mutual funds held by the Plan are deemed to be actively traded.

Collective investment trusts: Valued at the net asset value or equivalent based on units of the collective investment trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the collective investment trust less its liabilities. This practical expedient is not used when it is determined to be probable that the collective investment trust will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan is applying the practical expedient as of December 31, 2024 and 2023 to its collective investment trusts.

As of December 31, 2024, the Plan’s investment options include the Invesco Stable Asset Fund (the “Fund”), a collective investment trust. The Fund’s investment objective is to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity.

As of December 31, 2023, the Plan’s investment options include collective investment trusts which are designed to mirror the investment strategies of similar mutual funds, including target date funds of Fidelity Institutional Asset Management (“FIAM”), and a fixed income fund.

These collective investment trusts are redeemable at net asset value under agreements with the underlying collective investment trusts. However, it is possible that these redemption rights may be restricted by the collective investment trusts in the future in accordance with underlying fund agreements. Due to the nature of the investments held by the collective investment trusts, changes in market conditions and the economic environment may significantly impact the net asset value of the collective investment trusts, and consequently, the fair value of the Plan’s interest in the collective investment trusts. Furthermore, changes in the liquidity provisions of the funds may significantly impact the fair value of the Plan’s interest in the collective investment trusts.

5. Related Party and Party-in-Interest Transactions

ADP Retirement Trust Services, LLC is the current trustee and an affiliate of ADP, Inc. recordkeeper of the Plan, Certain Plan investments are units of mutual funds and/or were collective investment trusts managed by Fidelity Management Trust Company, or affiliates, the former trustee and recordkeeper of the Plan. Therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. Fees paid directly from participant accounts, including those for the administration of participant loans, are included in administrative expenses. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant’s account balance.

During 2024 and 2023, the Company failed to remit to the Plan’s trustee certain employee contributions and loan repayments totaling \$183,718 and \$15,580, respectively, within the period prescribed by the Department of Labor regulations. During 2025, the Company plans to make contributions to the affected participants’ accounts to make the participants whole and compensate those participants for potential lost income due to the 2024 and 2023 processing delays. The Company believes that these transactions do not affect the tax status of the Plan and is taking action prescribed by the regulations to remedy such errors.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in any employer contributions for which they were not already vested and the trustee would distribute account balances as permitted by the Plan document.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Tax Status

Effective June 1, 2024 and August 1, 2024, through the adoption of an Automatic Data Processing non-standardized defined contribution pre-approved plan, the Plan was amended and restated (see Note 9). The Internal Revenue Service ("IRS") issued an opinion letter dated October 6, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with applicable IRC requirements as of that date. Prior to the June 1, 2024 amendment and restatement of the Plan, the Plan had adopted a Fidelity Pre-Approved Defined Contribution Plan. The IRS issued an opinion letter dated June 30, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with applicable IRC requirements as of that date. Although the Plan has been amended since receiving the opinion letters, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

9. Plan Amendments

Effective June 1, 2024, through the adoption of an Automatic Data Processing Non-Standardized Defined Contribution Pre-Approved Plan, the Plan was amended and restated in order to change the trustee and recordkeeper from Fidelity Management Trust Company to ADP Retirement Trust Services, LLC, trustee of the Plan and ADP, Inc. recordkeeper of the Plan and to make other general administrative changes to the Plan.

Effective August 1, 2024, the Plan was amended and restated to make general administrative changes to the Plan.

10. Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.
