Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of PopSockets LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Plan Description

The following description of PopSockets LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established during 2017 and subsequently amended and restated. The Plan is available to all employees of PopSockets LLC (the "Company") age 18 or older except for union employees, nonresident aliens, leased employees, and interns. The entry date for eligible participants is the first day of the month after obtaining eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the sponsor of the Plan. The Plan's investment manager and custodian is Ascensus Trust Company (the "Custodian").

Contributions

The Plan provides for employee salary deferral contributions, including before-tax and after-tax Roth contributions, up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the Internal Revenue Service (IRS). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Employees are automatically enrolled to contribute into the Plan upon reaching eligibility at 6 percent of compensation, unless the employee elects a different amount. Employee contributions to the Plan are made through regular payroll deductions.

The Plan is operating pursuant to the safe harbor provisions of the Internal Revenue Code. The Company's safe harbor contributions are on an annual basis and will equal 3 percent of the participant's eligible compensation, regardless of the participant's salary deferral. Highly compensated employees are not eligible for the safe harbor contribution. Safe harbor contributions totaled approximately \$329,000 for the year ended December 31, 2024.

The Company may make, at its sole discretion, a discretionary nonelective profit-sharing contribution. Profit-sharing contributions totaled approximately \$334,000 for the year ended December 31, 2024.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates at loan origination determined periodically by the plan administrator. Principal and interest are paid ratably through biweekly payroll deductions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses and plan losses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants' contributions, any safe harbor nonelective employer contributions, nonelective profit-sharing contributions, and related earnings or losses thereon are fully vested at all times and are not subject to forfeiture for any reason.

Note 1 - Plan Description (Continued)

Benefit Payments

On termination of service, death, disability, or retirement, a participant or beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. Participants may request that all or a portion of their accounts from a pretax deferral contribution source be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals. Furthermore, the Plan allows for terminated participant vested account balances of \$1,000 or less to be automatically distributed and balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan into a qualified IRA. The IRS has required minimum distributions (RMD) once a participant reaches RMD age during the previous plan year and is no longer employed by the Company.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Vanguard Group, Inc. or its affiliates. Vanguard Group, Inc. is a service provider of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. The Plan provides for loans to participants, which are also party-in-interest transactions. The aforementioned transactions are exempt from the prohibited transaction rules.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Note 2 - Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee appoints the investment manager, determines the Plan's valuation policy utilizing information provided by the investment advisors, and monitors the performance of the Plan's investment funds based on quoted market values. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative expenses of the Plan are paid by the Company.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 14, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Ascensus Trust Company holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Ascensus, LLC, on behalf of Ascensus Trust Company.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Mutual funds and money market funds are valued at quoted prices reported in active markets.
