**INDEPENDENT AUDITORS' REPORT**

To the Plan Trustees and Members of the  
Resource Acquisition & Management 401(k) Profit Sharing Plan & Trust

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Resource Acquisition & Management 401(k) Profit Sharing Plan & Trust (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **2023 Financial Statement**

Plan management is responsible for the accompanying financial statement of Resource Acquisition & Management 401(k) Profit Sharing Plan & Trust, which comprise the statement of net assets available for benefits as of December 31, 2023. We have performed a compilation engagement in accordance with the Statement on Standards for accounting and Review Services promulgated by the Accounting and Review Services Committee of the AICPA. We did not audit or review the financial statement nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by plan management. Accordingly, we do not express an opinion, a conclusion, nor provide any form of assurance on the financial statement as of December 31, 2023.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Resource Acquisition & Management 401(k) Profit Sharing Plan & Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024

NOTE A - DESCRIPTION OF PLAN

The following description of Resource Acquisition & Management 401(k) Profit Sharing Plan & Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering the employees of Resource Acquisition & Management Services, Inc. and Resource Partnering Group, Inc. (collectively referred to as the "Company") that have completed one year of service and are 21 years of age or older. The Company manages the operation and administration of the Plan. Officers and employees of the Company perform certain administrative functions. No such officer or employee receives compensation from the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan was created January 1, 2017.

2. Contributions

Participants are permitted to make elective deferral contributions of their compensation, subject to the limits of the Internal Revenue Code. Participants are also permitted to make Roth deferrals.

Employer matching and profit-sharing contributions are discretionary. Profit sharing contributions shall be allocated to each employee in proportion to their compensation as a percentage of the compensation of all eligible employees. To be eligible for employer matching contributions a participant must be 21 years of age and have completed one year of service.

3. Participant Accounts

The participant accounts are participant directed investment options. The participants are allowed to change the percentage contributed to the Plan through payroll deductions at any time. Participants can also move individual accounts from one mutual fund to another or change how the funds are allocated among investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Each participant in the Plan has a separate account which is credited with the annual allocation of (a) the Company's contributions, (b) the employee's elective deferrals and (c) the Plan's earnings or losses. Allocations are based on the prorated earnings of the participant compared to the total earnings of all participants in the same investment.

4. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts, plus actual earnings or losses thereon is based on years of service.

A participant is vested in employer contributions as follows:

One hundred percent vesting occurs, regardless of the number of years of service, when a participant reaches normal retirement age (65), dies, becomes totally and permanently disabled, or upon termination of the Plan.

5. Payment of Benefits

A participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or annual installments computed in various manners, upon termination of service due to death, disability, or retirement. A participant may receive the value of the vested interest in his or her account as a lump sum distribution for termination of service due to other reasons. A participant may receive a lump sum or partial distribution from his or her vested interest, with certain limitations and/or conditions, while still in service. Generally, these distributions are limited to hardship cases or participants who have reached a certain age. There were no participants who requested benefit payments who were not yet paid at December 31, 2024.

6. Forfeitures

Forfeited non-vested account balances are used to reduce employer contributions and to reduce plan expenses paid by the Sponsor. The forfeiture balance totaled \$339 as of December 31, 2024.

7. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 95% of one-half of their total vested account balance (not including Roth deferral accounts). Loan transactions are treated as a transfer from the investment fund to the participant loan account. Loan terms may range from one to five years, unless the purpose of the loan is for the purchase of a primary residence.

NOTE A - DESCRIPTION OF PLAN - Continued

The loans are collateralized by the balance in the participants' accounts and bear interest at the prime rate (8.5% at December 31, 2024) plus 1%, as defined by the Plan. Principal and interest is paid ratably through payroll deductions. Upon separation of service, the vested account payable to an individual who has an outstanding participant loan will be determined by reducing the vested account balance by the amount of the loan. The Plan had notes receivable from participants of \$68,510 at December 31, 2024.

8. Plan Termination

Although it has expressed no intention to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants shall become 100% vested in their employer contributions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies applied in the preparation of the accompanying financial statements follows:

1. Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting and accordingly reflect all significant receivables, payables, and other liabilities.

2. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein as well as the related disclosures. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Concentration of Credit Risk

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

5. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

6. Benefit Payments

Benefits are recorded when paid.

7. Expenses

Certain administrative expenses of the Plan are paid by the Plan and are reflected in the Plan's financial statements. However, certain legal and other operating expenses of the Plan are paid by the Company and, therefore, are not included in the accompanying financial statements.

NOTE C - FINANCIAL DATA CERTIFIED BY THE TRUSTEE (UNAUDITED)

The investments of the Plan were held and administered by Mid Atlantic Trust Company (the "Trustee") as of December 31, 2023 and 2024, and for Plan year ended December 31, 2024. The Trustee has supplied the Plan administrator with certain information utilized in preparing the financial statements and supplemental schedule. The Plan administrator has obtained certifications from the Trustee certifying that the information provided by the Trustee is complete and accurate as of and for the year ended December 31, 2024. In accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator has elected not to have this information audited by the Plan's independent certified public accountants.

NOTE D - FAIR VALUE MEASUREMENT

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement), unadjusted quoted prices in active markets for similar assets or liabilities (level 2 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

*Mutual funds:* Valued at the daily closing price as reported by the fund. These funds publish their daily net asset value (NAV) and transact at that price. These funds held by the Plan are deemed to be actively traded.

NOTE E - TAX STATUS

Effective January 1, 2017, the Plan adopted the use of the Paychex Prototype Non-Standardized Profit Sharing Plan ("Prototype Plan"). The Prototype Plan has been amended since receiving the Internal Revenue Service determination letter. The Plan sponsor believes that the Prototype Plan continues to qualify and operate as designated. The Company believes that the Plan, as amended, qualifies under Section 401(a) of the Internal Revenue Code and is, therefore, not subject to tax under present income tax laws.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Tax years since 2022 are subject to examination.

NOTE F - EXCESS CONTRIBUTIONS

In order to remain a qualified plan under Internal Revenue Service Regulations, the Plan must satisfy the 401(k) nondiscrimination requirements each year, which limit the percentage of compensation that can be contributed by highly compensated employees, as defined in the Internal Revenue Code, relative to the percentage of compensation contributed by non-highly compensated employees. The Plan has satisfied the requirements for 2024.

NOTE G - PARTY-IN-INTEREST TRANSACTIONS

The Plan paid the trustee \$17,878 for recordkeeping services during the year ended December 31, 2024.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities, will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in Statement of Net Assets Available for Benefits.

NOTE I - SUBSEQUENT EVENTS

The Plan has evaluated events and transactions occurring subsequent to December 31, 2024 as of October 14, 2025 which is the date the financial statements were available to be issued.
