## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Aquarion Company Insurance Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### **1. Description of Plan**

The following description of the Medical and Dental Plan for Employees of Aquarion Company and its Designated Subsidiaries (plan number 501), referred to as the Aquarion Company Insurance Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined benefit plan which provides health and other benefits to eligible employees and their dependents and certain retiree medical benefits for retired employees of Aquarion Company and certain of its subsidiaries (the Company). A Voluntary Employees' Beneficiary Association (VEBA) trust (the Trust) was established under Section 501(c)(9) of the Internal Revenue Code (the Code). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective April 25, 2002, Aquarion Company (the Company) completed the acquisition of three American Water Works subsidiaries (AWW) in Massachusetts, New York and New Hampshire, and Aquarion Water Company of Connecticut and completed the acquisition of Connecticut-American Water Company (CAWC) (collectively, the Participating Companies). Former nonunion employees of the Participating Companies are provided benefits under the Plan. A new plan was established to provide benefits for union employees and retirees similar to those benefits received under the American Water Works Company Post-Retirement Medical Plan. Nonunion employees hired after April 25, 2002 receive benefits under the Plan. Union employees receive benefits under the new plan.

Effective March 7, 2022, the Company completed a merger transaction with Torrington Water Company. The definition of an 'Aquarion Employee' was amended to include any Employee of Torrington Water Company who is employed on or after October 3, 2022. The definition of an 'Aquarion Retiree' was amended to include any Employee or former Employee of Torrington Water Company who was hired prior to July 1, 2013 and who, as of October 3, 2022, has a combination of age and service totaling at least 75 or was deemed totally and permanently and disabled with 10 years of service.

## Notes to Financial Statements (continued)

### 1. Description of Plan (continued)

#### Benefits

The Plan provides health benefits and certain other benefits including dental, vision and prescription drug insurance coverage to active participants and their covered dependents. Effective January 1, 2020, the Company became fully insured for all medical, vision and prescription drug claims. As such, obligation for payments to medical, vision, and prescription drug providers is retained by the insurance companies, and the Plan pays for premiums only. The dental claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only arrangements. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants was retained by the Plan.

For the years ended December 31, 2024 and 2023, eligible retirees over 65 years of age were entitled to \$4,706 and \$4,482 per year, respectively, in lieu of the Plan directly paying claims, for a prescription drug benefit with any excess available for a Medicare supplement. Retirees under 65 years of age are entitled to benefits similar to active employees.

The Plan, under Connecticut General Life Insurance Company, is an Open Access Plan, which provides in-network and out-of-network benefits at varying levels. There are two options offered within the Open Access Plan to all eligible employees, a Plus Option and a Health Savings Account (HSA) Plan Option.

The Plus Option provides in-network benefits at a cost of \$30 per primary care office visit and \$40 per specialist office visit. In-network costs to the employee include a \$750 individual and \$1,500 family maximum deductible with a 10% co-insurance and a \$1,100 individual and \$2,200 family per person out-of-pocket annual maximum. Out-of-network costs to the employee include a \$1,500 individual and \$2,500 family maximum deductible with a 30% co-insurance and a \$1,900 individual and \$3,800 family per person out-of-pocket annual maximum.

The HSA provides in-network benefits at a cost of 20% co-insurance with a \$1,600 individual and \$3,200 family maximum deductible and an out-of-pocket annual maximum expense of \$2,000 per individual and \$4,000 per family. Out-of-network costs to the employee include 40% co-insurance with a \$2,500 individual and \$5,000 family maximum deductible and an out-of-pocket maximum expense of \$4,000 per individual and \$8,000 per family.

The Plan's excess of benefit obligations over net assets at December 31, 2024 and 2023 relates primarily to the postretirement benefit obligation, the funding of which is not covered by the contribution rate provided by the current funding vehicle. It is expected that the deficiency will be funded through future contributions from the plan sponsor.

### 1. Description of Plan (continued)

#### Contributions

The Company's policy is to contribute the maximum allowed as a tax deduction under the Code. Under present law, the Company is not permitted to deduct amounts for future benefits to current employees and retirees. The employees of the Company are required to make contributions to the Plan as determined by the benefits selected.

### 2. Summary of Significant Accounting Policies

#### Income Taxes

The Plan is tax exempt under the provisions of Section 510(c)(9) of the Code (see Note 7). However, the Plan is subject to income tax on its unrelated business income under Sections 512-514 of the Code, which is included in the statement of changes in net assets available for benefits.

#### Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **2. Summary of Significant Accounting Policies (continued)**

#### **Claims Payable**

The Plan is self-funded for dental claims. All medical claims are covered under the fully-insured portion of the Plan. Claims payable includes claims incurred under the self-funded option for dental claims and unpaid prior to the Plan's year-end.

#### **Plan Expenses**

Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Investment management, custodial fees, and claim processing fees are paid by the Plan. Certain expenses of maintaining the Plan are paid directly by the Company.

#### **Risks and Uncertainties**

Contributions to the Plan and the actuarial present value of benefit obligations are determined based upon certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.

### **3. Certification by the Investment Trustee**

Information presented in the accompanying financial statements for the period from January 1, 2023 to April 1, 2023 for investments and investment income including net appreciation (depreciation) was derived, without audit, from information certified to be complete and accurate by SEI Private Trust Company, the trustee, as permitted by the election made by the Plan Administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Information presented in the accompanying financial statements as of December 31, 2024 and 2023 and for the period from April 1, 2023 to December 31, 2023 and year ended December 31, 2024 for investments and investment income including net appreciation (depreciation) was derived, without audit, from information certified to be complete and accurate by The Bank of New York Mellon Corporation, the trustee, as permitted by the election made by the Plan Administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 4. Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

#### *Money Market and Mutual Funds*

Money market and mutual funds are valued using Level 1 inputs, which consist of the quoted price of shares held by the Plan at year end.

#### *Collective Trust Funds*

The collective trust funds are valued at the net asset value of the units held of the collective trust. The net asset value is used as a practical expedient to estimate fair value.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### 4. Fair Value Measurements (continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Post Retirement Benefit Obligations

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31. Postretirement benefits include future benefits expected to be paid to or for 1) eligible currently retired employees and their beneficiaries and dependents, and 2) eligible active employees and their beneficiaries and dependents after retirement from service with the Company. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment, and to reflect the portion of those costs expected to be borne by Medicare, the retired participants and other providers.

For health costs covered by insurance contracts, it is the present intention of the Company and the Plan to continue obtaining insurance coverage for benefits. The Plan's excess of benefit obligations over net assets available for plan benefits at December 31, 2024 and 2023 relates primarily to postretirement benefit obligations. Effective January 1, 1994, the Company established a VEBA for the purpose of funding a reserve for future benefit obligations for retiree health benefit coverage. The Company has been annually contributing the actuarially determined maximum tax-deductible contribution, and participants are required to make contributions, as determined by the Plan's administrator. Over time, continuing this practice should eliminate the existing excess of benefit obligations over net assets available for benefits.

For measurement purposes, the annual rate of increase in the per capita cost of covered health care benefits for 2024 was assumed to be 7.50% for pre-65 individuals and 3.5% for post-65 individuals. These rates are assumed to decrease to 5.0% for pre-65 individuals in 2035 and remain at those rates thereafter. The annual rate increase in the per capita cost for dental benefits for 2024 and thereafter was assumed to be 5.0%.

For measurement purposes, the annual rate of increase in the per capita cost of covered health care benefits for 2023 was assumed to be 6.75% for pre-65 individuals and 3.5% for post-65 individuals. These rates are assumed to decrease to 5.0% for pre-65 individuals in 2031 and remain at those rates thereafter. The annual rate increase in the per capita cost for dental benefits for 2023 and thereafter was assumed to be 5.0%.

### 5. Post Retirement Benefit Obligations (continued)

The Plan's postretirement benefit obligation does not reflect an amount associated with the Medicare subsidy allowed under the Medicare Prescription Drug Improvement and Modernization Act of 2003 because the Plan is not directly entitled to the Medicare subsidy. The Company has included the effects of the Medicare subsidy in measuring its postretirement benefit obligations; therefore, the Plan's postretirement benefit obligation differs from that of the Company.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

### 6. Party-in-Interest Transactions

Certain Plan investments are managed by the trustees (See Note 3), therefore these transactions qualify as party-in-interest transactions. Investment management and custodial expenses paid by the Plan to the trustees totaled \$1,665 and \$29,850 for the years ended December 31, 2024 and 2023, respectively. Certain employees of the Company who participate in the Plan perform administrative services to the Plan at no cost to the Plan.

### **7. Income Tax Status**

The Trust funding the Plan has received an exemption letter from the Internal Revenue Service (IRS) dated April 17, 1997 stating that the Trust is tax exempt under the provisions of Section 501(c)(9) of the Code as a VEBA. The Plan and Trust are required to operate in conformity with the Code to maintain the tax-exempt status of the Trust. The Plan has been amended since receiving the determination letter. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related Trust is tax exempt, except for taxes on unrelated business taxable income.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. There were no uncertain tax positions taken by plan management. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **8. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. If the Company terminates or partially terminates the Plan, the Trust will pay benefits that participants are entitled to receive under the terms of the Plan.

### **9. Subsequent Events**

Subsequent events were evaluated through October 15, 2025, the date the financial statements were available to be issued.
