INDEPENDENT AUDITORS' REPORT

To the Plan Administration of
Gulf Coast Social Services 403(b)

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Gulf Coast Social Services 403(b) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the 2024 audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution, Nationwide, as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above, related to assets held by and certified to by a qualified institution, agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the 2024 financial statements.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about ABC Company Employee Benefit Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance, but it is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - PLAN DESCRIPTION

The following description of the Gulf Coast Social Services 403(b) (the "Plan") provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

a) General

The Plan is a defined contribution plan covering all Gulf Coast Teaching Family Services, Inc. d.b.a. Gulf Coast Social Services, Inc. (the "Employer") employees. The Plan is administered by the Employer. The trustees (custodians) of the Plan's assets are American Funds and Nationwide. All employees can participate by making elective deferrals to the Plan commencing on their hire date. Employees whose compensation exceeds compensation limits which define a highly compensated employee are excluded from the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Directors of the Employer instituted employer contributions into the Plan effective January 1, 2021, thereby placing the plan under the requirements of ERISA. The Plan was amended and restated effective January 1, 2024 to conform to new tax laws.

The following description of the Plan provides only general information. Participants should refer to the legal plan document and trust agreement for a more complete description of the Plan's provisions.

b) Contributions

Each year, participants may contribute by salary reduction pursuant to Section 403(b) of the Internal Revenue Code (the "Code") a portion of their compensation. The salary reduction limit for 2024 and 2023 was \$23,000 and \$22,500, respectively. Participants aged 50 or over at the end of the calendar year can also make catch-up employee elective contributions of \$7,500 beyond the basic limit on elective deferrals. Participants may also contribute amounts representing eligible rollover distributions from other qualified retirement Plans.

Employees are eligible for employer matching and discretionary contributions after completing a year of service, defined as at least 1,000 hours of service in 12 months. The initial computation period runs from date of hire to the first anniversary; if not met, eligibility is measured on the Plan Year thereafter. Eligible employees may receive an employer discretionary match on the first day of each Plan quarter upon meeting eligibility.

b) Contributions (continued)

The Employer may make contributions equal to a discretionary amount and/or a percentage of the participant's deferral. For the year ended December 31, 2024, the Employer made quarterly matching contributions equal to 50% of the lesser of (i) 6% of a participant's eligible compensation or (ii) the participant's elective deferral. For the year ended December 31, 2023, the Employer made a matching quarterly contribution equal to 25% of the lesser of (i) 6% of a participant's eligible compensation or (ii) the participant's elective deferral. The Employer's total matching contributions for the years ended December 31, 2024 and 2023 were \$55,166 and \$27,479, respectively.

c) Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the Employer's contributions, (b) Plan earnings and losses, and (c) is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of their account to any of the investment options available under the Plan.

d) Vesting

Participants are immediately 100% vested in their 403(b) contributions, employer contributions, rollover contributions, and actual earnings thereon.

e) Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's account or installments as mutually agreed upon by the participant or beneficiary and the Plan's Administration. Upon retirement, withdrawals of any amount can be distributed at any time. Participant account balances that do not exceed \$5,000 must be distributed as a lump sum. Distributions must begin no later than April 1 following the end of the year when the participant reaches age 70 ½.

f) Forfeited Accounts

Participants are 100% vested in their accounts; there are no forfeitures.

g) Administrative Expenses

The Employer pays certain expenses of maintaining the Plan and is therefore excluded from these financial statements. Investment related expenses are included in the net appreciation (depreciation) in the fair value of investments.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions about the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

c) Investment Valuation and Income Recognition

The Plan's investments are reported at fair value in the statements of net assets available for benefits. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administration determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee, and insurance company. All the investment vehicles are mutual funds. Interest, dividends, realized gains (losses) on sales of investments, and unrealized appreciation (depreciation) in the fair value of investments are shown as net appreciation (depreciation) in the fair value of investments in the statements of changes in net assets available for benefits.

d) Payment of Benefits

Benefits are recorded when paid.

e) Subsequent Events

Plan administration has evaluated subsequent events for recognition or disclosure through October 14, 2025, the date the financial statements were available to be issued. No events have occurred subsequent to the balance sheet date that would require recognition or additional disclosure in the financial statements.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the entire term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input significant to the fair value measurement. Valuation techniques must maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value of mutual funds is based on quoted net asset values of the shares reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. There have been no changes in the methods used since December 31, 2024.

The preceding method described may produce a fair value calculation that may not indicate the net realizable value or reflect future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with those of other market participants, using different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments were held by two custodians, American Funds and Nationwide, and managed by the Plan administrator for the years ended December 31, 2024 and 2023. The Plan provides for participant-directed investments.

NOTE 4 - RISKS AND UNCERTAINTIES

The Plan's assets are invested in mutual funds. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and risks resulting from global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 5 - INVESTMENT INFORMATION CERTIFIED AND UNCERTIFIED

The Plan's investments were held in trust and administered by two trustees (custodians) for the year ended December 31, 2024. A portion of the Plan's investments, specifically those held by Nationwide, was certified as complete and accurate by the Trustee. All investment information presented in the accompanying financial statements and supplemental schedule related to these Nationwide assets, including investments held and net appreciation in fair value of investments and interest and dividends, was obtained or derived from information supplied by Nationwide, one of the Plan's trustees, and has been certified as complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the certified Nationwide assets as of December 31, 2024. The following was unaudited by the Plan's auditors as of December 31, 2024:

All remaining Plan assets, held by custodians other than Nationwide, were not certified by a trustee. Accordingly, the Plan's independent auditors performed auditing procedures on the investment information related to these uncertified assets in accordance with auditing standards generally accepted in the United States of America.

NOTE 6 – QUALIFIED NON-ELECTIVE CONTRIBUTIONS (QNECS)

During the year ended December 31, 2024 and 2023, the Plan sponsor made qualified non-elective contributions (QNECs) to the Plan for \$2,647 and \$0, respectively. QNECs are employer contributions that are fully vested when made and are allocated to eligible participants' accounts. QNECs are used to satisfy certain nondiscrimination requirements under the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code, including the Actual Deferral Percentage (ADP) and Actual Contribution Percentage (ACP) tests. The contributions are included in "Employer Contributions" in the accompanying statements of changes in net assets available for benefits.

Although QNECs are 100% vested at the time of contribution, the plan's records may reflect amounts coded as 'forfeitures' related to QNECs. These entries generally arise from administrative corrections, such as allocation errors, eligibility adjustments, or testing reversals, and are not true forfeitures of vested participant benefits.

NOTE 7 - PLAN TERMINATION

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their accounts.

NOTE 8 - TAX STATUS

The Plan utilizes a prototype Plan document and relies on the opinion letter issued to the prototype document sponsor. The prototype document sponsor received an opinion letter dated March 31, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service or other taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no governmental audits for tax periods.

Note 9 - PLAN TRANSFER OF ASSETS

Effective January 1, 2024, the Plan transitioned from using American Funds to Nationwide as the designated investment custodian for future contributions. Under this change:

- Participants were given the option to either maintain their existing balances at American Funds or elect to roll their balances into the new Nationwide platform.
- All contributions made on or after January 1, 2024, are directed exclusively to Nationwide.
- Balances that remain at American Funds continue to be held and invested under the same terms and conditions applicable prior to the transition.

During the year ended December 31, 2024, participants elected to transfer a total of \$1,148,064 from American Funds to Nationwide. This transfer did not impact participants' rights to their existing account balances, and all assets remain fully participant-directed. The Plan administrator determined that this change was in the best interest of the participants, providing access to enhanced investment and recordkeeping services through Nationwide.

NOTE 10 - DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2024 and 2023, participant contributions of \$463 and \$0 were not timely remitted to the plan in accordance with the requirements of the Department of Labor, respectively. The Organization remitted the contributions as soon as administratively feasible.

NOTE 11 - RELATED PARTY TRANSACTIONS

During the years ended December 31, 2024 and 2023, the Plan held investments in mutual funds issued by American Funds with fair values of \$1,352,740 and \$3,366,280, respectively. In addition, the Plan held investments in mutual funds issued by Nationwide with fair values of \$1,567,556 and \$0 as of December 31, 2024 and 2023, respectively. These investments are considered party-in-interest transactions under ERISA due to the custodial relationship.

Administrative expenses of \$17,642 and \$8,581 were paid to parties-in-interest during the years ended December 31, 2024 and 2023, respectively.
