INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of

Opinion

We have audited the accompanying financial statements of Studio Mechanics Local 476 Health and Welfare Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits, including the statements of plan benefit obligations, as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Studio Mechanics Local 476 Health and Welfare Plan (the “Plan”) provides only general information about the Plan’s provisions. Participants should refer to the summary plan description for a more complete description of its provisions, copies of which may be obtained from the Plan sponsor.

General. The Plan was established during 1963 as a result of collective bargaining agreements to provide health care, death, and disability benefits for participants and their covered dependents. Any employee employed in any of the job classifications covered by a collective bargaining agreement with Motion Picture Studio Mechanics Local 476 and for whom the employers are obligated to make contributions may apply for coverage as of the first day of the calendar quarter following the calendar quarter in which the employee worked a minimum of 300 hours in covered employment. Effective November 5, 2023, the employee may apply for coverage as of the first day of the calendar quarter following two consecutive calendar quarters in which the employee worked a minimum of 600 hours in covered employment.

Benefits. The Plan provides health benefits (medical and prescription drugs), life insurance, short-term disability benefits, and accidental death and dismemberment benefits. Retired employees are entitled to medical benefits if they have attained at least age 62, are members of the Union, and have worked at least 300 hours.

Stop Loss Coverage. The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Self-insured Benefits. All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims processors under administrative services only (“ASO”) arrangements. The claims processors pay claims directly to or on behalf of participants directly from the assets of the Plan. Despite the Plan’s utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (“PBM”) which periodically makes refunds (pharmaceutical manufacturers’ rebates) to the Plan based on the Plan’s actual utilization pattern of specific brand name drugs.

Contributions. In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections, as defined by the Plan. Coverage continues at no cost to participants who work at least 450 hours in covered employment per quarter.

Alternatively, the participant may pay an amount determined by the Trustees; \$4.80 per hour for single coverage or \$9.78 per hour for family coverage. Lower rates of \$2.50 per hour for single coverage and \$5.00 per hour for family coverage apply to all Studio Mechanics Retirement Trust retirees as of December 31, 2000 and any participant retiring on or after January 1, 2001 who has at least 25 years of service with Studio Mechanics Retirement Trust, 20,000 hours of contributions to the Studio Mechanics Retirement Trust, and is eligible under the Studio Mechanics Health and Welfare Plan on the date of retirement. At the time of retirement, Medicare becomes the retiree’s primary insurance and the Plan becomes secondary. If coverage is terminated, the participant must re-qualify as described above. Effective January 1, 2024, all retirees which qualify for Medicare Part A or Part B must enroll in a Medicare Part C plan sponsored by the Plan.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates and Assumptions. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from those estimates. Future events and their effects cannot be predicted with certainty; accordingly, accounting estimates require the exercise of judgment. Accounting estimates used in the preparation of these financial statements change as new events occur, as more experience is acquired, as additional information is obtained, and as the operating environment changes.

Cash and Cash Equivalents. All highly liquid investments that are readily convertible to cash, generally money market and certificate of deposit investments, are considered to be cash equivalents. The Plan regularly maintains cash balances that exceed Federal Deposit Insurance Corporation limits.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement dated. If available, quoted market prices are used to value investments. The amounts shown for securities that have no quoted market price represent estimated fair value. See Note 7 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Benefits are recorded when paid.

Receivable from Pharmacy Benefit Manager ("PBM"). In Spring 2024, the Plan's management conducted a pharmacy audit to review the contractual discounts provided by the Plan's PBM, resulting a pharmacy benefits overpayment of approximately \$3.48 Million. The amount was presented as other income and receivable, net of \$300,000 of PBM credit, in the Statement of Changes in Net Assets Available for Benefits and the Statement of Net Assets Available for Benefits as of December 31, 2023, respectively. In addition, approximately \$1 Million due to PBM was included in Accounts Payable as of December 31, 2023. During the year ended December 31, 2024, the \$1 Million due as of December 31, 2023 and an additional \$1.96 Million were settled against the PBM receivable. The remaining balance of approximately \$230,000 is presented as a receivable in the Statement of Net Assets Available for Benefits as of December 31, 2024 and will be settled in 2025.

Payments of Benefits. Claim payments are recorded when paid by the third-party claims processor. Amounts due to the claims processor that have yet to be reimbursed by the Plan are recorded as accounts payable in the accompanying statements of net assets available for benefits.

Stop Loss. Premiums for stop loss insurance are included in group insurance premiums in the accompanying statements of changes in net assets available for benefits. Stop loss refunds totaling \$1,314,649 and \$2,959,207 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Administrative Expenses. The Plan's expenses are paid either by the Plan or the Local, as provided by the plan document. Expenses that are paid directly by the Local, if any, are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 3 – ACTUARIAL INFORMATION

The actuarial review of the Plan does not include a postretirement benefit obligation for retiree medical benefits for eligible participants and their dependents upon retirement. The actuary has determined that the potential liability is negligible because few participants elect to continue coverage unless the cost is offset by their hours bank, as described in Note 1 above. The hours bank can be used to offset the cost of health coverage upon retirement for up to 18 months under COBRA. There were no retirees on the Plan who had elected to pay for coverage as of December 31, 2024 and 2023.

There is a liability due to hours accumulated in the hours bank calculated by the actuary. The liability is estimated based on census data collected as of the end of each year. The actuary projects covered members with an hours bank balance as of December 31, 2024 and 2023 out to the years when the participants are expected to utilize the hours bank. The hours bank is then converted into the cost of future coverage to project a stream of expected health costs for each year in the future. Health care costs used in the projection are based on the current COBRA rates.

See below for other significant assumptions used to determine the postretirement and postemployment benefit obligations as of December 31, 2024 and 2023.

The Plan was amended to increase the deductible under major medical coverage for the year ended December 31, 2024. The Plan was not amended to increase the deductible under major medical coverage for the year ended December 31, 2023. The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining actuarial present value of the benefit obligations.

NOTE 4 – INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan by a letter dated May 10, 1979 that the Plan was designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been restated and amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

NOTE 5 – PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect. However, in order to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Discontinuance or termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

NOTE 6 – CLAIMS INCURRED BUT NOT REPORTED

Plan obligations for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrator. These amounts are paid by the Plan only if the claims are submitted and approved for payment.

NOTE 7 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") *Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money Market Funds and Mutual Funds . Valued at quoted market price at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 8 – SIGNIFICANT EMPLOYERS

The Plan received Employer contributions of approximately \$12,032,000 (68%) and \$5,216,000 (67%) from four Employers during the years ended December 31, 2024 and 2023, respectively.

NOTE 9 – FUNDING POLICY

Participating employers contribute such amounts as are specified in their collective bargaining agreements. The hourly contribution rate in effect ranged from \$7.85 to \$10.25 during the years ended December 31, 2024 and 2023.

NOTE 10 – RELATED PARTIES

The Plan has six related tax-exempt entities that include the Motion Picture Studio Mechanics Local 476 ("Local"), MPSM #476 Realty Corp., Inc. ("Realty Corp."), the Studio Mechanics Local 476, I.A.T.S.E. Retirement Plan ("Retirement Plan"), the Studio Mechanics Local 476 Annuity Plan ("Annuity Plan"), Studio Mechanics Local 476 Training Fund ("Training Fund") and Studio Mechanics Local 476 Legal and Education Assistance Fund ("Legal and Education Fund"). The financial activities of these entities are not included in these financial statements.

The Plan has common officers and trustees and shares office facilities and staff with the Local, the Realty Corp., the Retirement Plan, the Annuity Plan, the Training Fund, and the Legal and Education Fund. The Local initially pays the operating expenses of the combined facility. These expenses are allocated on a basis approved by the Trustees and the officers of the Local.

The Plan incurred \$138,329 and \$119,490 in shared administrative expenses during the years ended December 31, 2024 and 2023, respectively. In addition, the Plan also incurred \$5,541 and \$63,592 for the years ended December 31, 2024 and 2023, respectively, for direct operating expenses which were initially paid by the Local. As of December 31, 2024 and 2023, the Plan owed to the Local \$58,541 and \$207,294, respectively.

The Plan owed the Annuity Plan \$-0- and \$1,725 as of December 31, 2024 and 2023, respectively.

The Plan owed the Training Fund \$-0- and \$69 as of December 31, 2024 and 2023, respectively.

The Legal and Education Fund owed the Plan \$-0- and \$212 as of December 31, 2024 and 2023, respectively.

NOTE 12 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertain inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
