## REPORT OF INDEPENDENT AUDITORS

To the Retirement Plan Committee and Plan Administrator of the  
Argos USA Union 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Argos USA Union 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan’s transactions that are presented and disclosed in the financial statements are in conformity with the plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor’s Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### A. Description of the Plan

##### General

The following description of the Argos USA Union 401(k) Plan (the “Plan” and formerly Argos USA Roberta Plant 401(k) and Profit Sharing Plan until August 1, 2022) provides only general information. The Plan is sponsored by Argos USA, LLC, (the “Company” or “Plan Sponsor”). Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Company’s corporate offices are currently located in Alpharetta, Georgia.

The Plan, which was effective August 1, 2011, and most recently restated on August 1, 2022, is a defined contribution plan covering substantially all employees at the Roberta Plant who are members of the United Steel Workers, International Union, Local #9-537; employees at the Frederick location who are members of the United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied Industrial and Service Workers International Union (USW), American Federation of Labor – Congress (CLC), on behalf of Local 8-0031/Unit 1; employees at the Martinsburg location who are members of the subordinate lodge of International Brotherhood of Boilermakers, Iron Ship Builders, Black Smith, Forgers, and Helpers AFL-CIO Martinsburg, West Virginia, Local Lodge D-208; and excluding non-resident aliens. Eligible employees may enter the Plan immediately upon completing the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The purpose of the Plan is to encourage the Company’s union employees to save and invest, systematically, a portion of their current compensation so that they and their families may have a source of additional income upon their retirement or in the event of death.

Plan to plan transfers occur between the Plan and other Plans sponsored by the Company as a result of changes in employment status in the normal course of business. For the years ending December 31, 2024 and 2023, \$35,054 and \$435,206 in assets, respectively, were transferred from the Plan to the Argos USA Retirement Savings Plan.

Effective December 31, 2024, the Plan merged into the Summit Materials 401(k) Retirement Plan and the related assets and participant accounts of \$12,109,520 were transferred from the Plan into the Summit Materials 401(k) Retirement Plan.

##### Eligibility

Effective January 1, 2016, union employees of the Company are eligible to participate in the Plan upon the completion of 720 hours of service and reaching age 21. Prior to this date, union employees had to have completed one year of service and 1,000 hours and reached age 21 in order to participate in the Plan. Effective August 1, 2022, the hours of service increased to 750 hours.

## ARGOS USA UNION 401(k) PLAN

### NOTES TO FINANCIAL STATEMENTS *(continued)*

#### A. Description of the Plan – continued

##### Eligibility

Effective January 1, 2017, all Frederick and Martinsburg union employees must have six months of service, with no other conditions, for elective deferrals and non-elective contributions.

Eligible employees may enter the Plan on the first day of the following month after becoming eligible.

##### Contributions

Participants may contribute up to an annual limit of 50% of eligible compensation, as defined by the Plan. Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code (the “Code”) as defined in the Plan document.

Participants who are eligible to make salary deferral contributions under the Plan and have attained age 50 before the close of the Plan year are eligible for catch-up contributions in accordance with and subject to the limitations imposed by the Code.

The Company makes a non-discretionary matching contribution in an amount equal to 25% of the participant’s eligible contributions up to 4% of the participant’s eligible compensation. Effective January 1, 2017, in lieu of the 25% match rate up to 4% of eligible compensation, the Martinsburg union employees will receive a 50% match rate up to 6% of eligible compensation allocated on a per payroll basis. Frederick union employees are excluded from matching contributions.

Effective January 1, 2016, the Company established a non-elective feature to the Plan allowing all eligible employees to have an account with the Plan. In order for an employee to participate in the non-elective portion, the employee must have completed one year of service as of January 1st of any year. The Company will contribute 3% of the employee’s previous year’s W-2 earnings and the contribution will be made as of March 15<sup>th</sup>. Employees will have a five year vesting period, however, should they leave the Company prior to being vested, such amounts in the non-elective account will be forfeited. If the employee should leave after being fully vested, the participant will be entitled to the Company’s contribution. Effective August 1, 2022, the contribution rate increased to 3.25%. The Company intends to contribute an additional .25% each year beginning January 1, 2023 through 2025.

Effective January 1, 2017, in lieu of the 3% non-elective contribution allocated on a plan year basis, the fixed rate is 5% and will be allocated on a per payroll basis for the Frederick and Martinsburg union employees. There are no allocation conditions for the non-elective contributions for Frederick and Martinsburg union employees.

##### Participant Accounts

Each participant’s account reflects the participant’s elected salary deferral contributions, the Company’s non-discretionary matching contributions, and the Company’s non-elective contributions made on behalf of the participant and earnings, expenses, gains, losses attributed thereto, and investments made with amounts in the participant’s account.

### NOTES TO FINANCIAL STATEMENTS *(continued)*

#### A. Description of the Plan – continued

##### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contributions portion of accounts plus actual earnings thereon is as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
1 year but less than 2 years	20%
2 years but less than 3 years	40%
3 years but less than 4 years	60%
4 years but less than 5 years	80%
5 years or more	100%

Frederick and Martinsburg union employees are 100% vested in all contribution types.

##### Notes Receivable from Participants

Notes receivable from participants represent amounts borrowed from a participant's account, which creates notes receivable from participants to the Plan. Notes must be at least \$1,000 but cannot exceed the lesser of one half of the participant's vested account balance or \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior 12-month period. Participants may have one loan outstanding at any given time. Notes must be repaid in payments through payroll deductions on at least a quarterly basis over a five-year period unless it is for the purchase of a principal residence, in which case the loan repayment period may not extend beyond 15 years. Interest rates on outstanding notes receivable from participant loans are commensurate with market rates for similar loans. The interest rate on outstanding notes receivable from participant loans ranged from 3.25% to 8.50% at December 31, 2023. No loans were held by the Plan at December 31, 2024.

##### Benefit Payments

Participants withdrawing during the year for reasons of service or disability, retirement, death, or termination are entitled to their vested account balance. Benefits are distributed in the form of lump sum, rollovers, or installment payments.

#### A. Description of the Plan – continued

##### **Benefit Payments – continued**

Certain in-service withdrawals are allowed. A participant may also elect to withdraw all or a portion of their vested account balance while employed after reaching age 59 ½. A participant may receive a hardship distribution from salary reduction contributions if the distribution is: (1) on account of uninsured medical expenses incurred by the participant, their spouse or dependents; (2) to purchase (excluding mortgage payments) a principal residence of the participant; (3) for the payment of post-secondary tuition expenses; (4) needed to prevent eviction of the participant from their principal residence or foreclosure upon the mortgage of the participant's principal residence; (5) to make payments for burial or funeral expenses for your deceased parent, child, dependent or a primary beneficiary designated by you under the Plan; (6) to pay expenses for the repair of damage to your principal residence; or any other immediate and heavy financial need as determined by the Internal Revenue Service (the "IRS").

##### **Investment Options**

Upon enrollment in the Plan, a participant may direct their salary deferrals in 1% increments into any of the Plan's investment options.

##### **Forfeitures**

Forfeited balances of non-vested participant accounts are first used to offset Plan expenses, any remaining forfeitures shall be used to reduce the Company's contributions. Unallocated forfeiture account balances at December 31, 2024 and 2023, were \$0 and \$7,414, respectively. During the years ended December 31, 2024 and 2023, there was \$1,197 and \$180, respectively, used to offset Plan expenses. During the years ended December 31, 2024 and 2023, there were \$8,437 and \$0 forfeitures used to offset employer contributions, respectively.

##### **Administrative Expenses**

Both the Plan and the Company pay administrative expenses related to the Plan. Employees of the Company perform certain administrative functions with no compensation from the Plan. During the years ended December 31, 2024 and 2023, the Plan Sponsor paid substantially all of the administrative expenses on behalf of the Plan, with the exception of amounts paid by participants for various recordkeeping fees.

#### B. Summary of Significant Accounting Policies

##### **Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **B. Summary of Significant Accounting Policies – continued**

##### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenue and expense during the reporting period. Actual results could differ from those estimates.

##### **Contributions**

Contributions from the Company and the participants are accrued as they become obligations of the Company, as determined by the Plan's administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

##### **Investment Valuation and Income**

The investments of the Plan are stated at fair value as of the end of the year and are subject to market or credit risks customarily associated with equity investments. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Note C for information related to the Plan's valuation methodologies.

Investment gains and losses are accounted for using the average cost basis of the securities sold. The net realized and unrealized gains and losses on investments include realized gains and losses on sales of investments during the year and unrealized increases or decreases in the market value of investments held at year end. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

##### **Notes Receivable from Participants**

Notes receivable from participants are valued at remaining outstanding principal balances plus accrued but unpaid interest.

##### **Payment of Benefits**

Benefits are recorded when paid.

### NOTES TO FINANCIAL STATEMENTS *(continued)*

#### C. Fair Value Measurements

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value and requires that the lowest level input be used. The three levels defined are as follows:

- Level 1 — observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.
- Level 2 — observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.
- Level 3 — inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

GAAP requires that management describe the methodologies used to measure the fair value of assets and liabilities. The methodologies used to measure the fair value of the Plan's investments are as follows:

- Mutual funds are measured using the estimated net asset values ("NAV") of the shares held by the Plan at year end and are classified within Level 1 of the valuation hierarchy.
- The common collective trust funds are valued based upon the redemption price of the units held by the Plan, which is based on the current fair value of the common collective trust funds' underlying assets. Unit values are determined by the financial institution sponsoring such funds by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

#### D. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, the trustee of the Plan.

#### E. Tax Status

Effective August 1, 2022, the Plan was amended and restated through the adoption of the Principal Life Insurance Company's Non-Standardized Pre-Approved Profit Sharing Plan, which has a favorable opinion letter from the IRS dated June 30, 2020. This letter states that the form of the plan is acceptable under Section 401 of the Code. The Company may rely on this letter with respect to the qualification of the Plan under Code Section 401(a) with certain limitations. Therefore, the related trust is exempt from federal income taxation.

#### **E. Tax Status – continued**

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **F. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, all amounts credited to participant's accounts will become 100% vested. However, as discussed in Note A, the Plan merged into another plan effective December 31, 2024.

#### **G. Parties-in-Interest Transactions**

Parties-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

Transactions in such investments, as well as loans made to participants, qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA which are exempt from the prohibited transaction rules.

#### **H. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
